**STATEWIDE CURRENT SITUATION:** On April 9, Governor Abbott directed the Texas Division of Emergency Management (TDEM) to deploy additional state emergency response resources ahead of severe storms and flash flooding, including large hail and possible tornadoes, expected to move across Texas through Wednesday night.

According to the National Weather Service, severe thunderstorms and flash flooding are expected to impact the state through tomorrow night. The severe thunderstorm threat across Texas includes large hail, heavy rainfall, damaging wind, and possible tornadoes. Additionally, significant rainfall could cause serious flash flooding and river flooding in portions of the state through the end of the week.

Earlier this week, the Governor directed TDEM to mobilize state emergency response resources and increase the readiness level of the State Emergency Operations Center to Level II (Escalated Response) in preparation for this week's severe weather.

At the Governor's direction, TDEM has mobilized the following additional resources across the state to support local emergency response operations:

- **Texas A&M Engineering Extension Service (Texas A&M Task Force 1 and Texas Task Force 2):** Urban Search & Rescue Teams and Boat Squads
- **Texas A&M Forest Service:** All-Hazard Incident Management Teams and Saw Crews
- **Texas Parks and Wildlife Department:** Game Wardens, Park Police Officers, and Swiftwater Rescue Boat Squads

- **Texas Department of Public Safety:** Tactical Marine Unit and Helicopters with Hoist Capabilities
- **Texas Military Department:** Ground Transportation Platoons

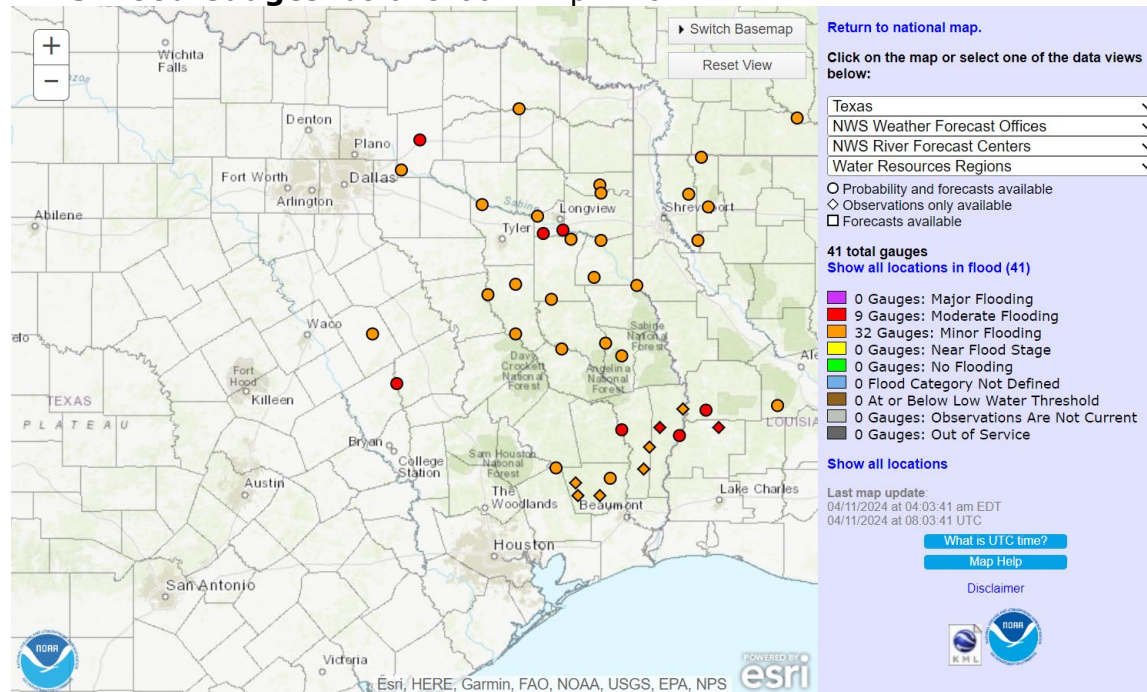
Over the weekend, TDEM mobilized the following emergency response resources across the state at Governor Abbott's direction to support local emergency response operations:

- **Texas A&M Forest Service:** Firefighters and fire engines; heavy equipment such as bulldozers and motor graders; Texas Intrastate Fire Mutual Aid System (TIFMAS) Strike Teams comprised of personnel and fire engines; Firefighting aircraft including large airtankers, multi-engine air tankers, single engine airtankers, aerial supervision modules and air attack platforms
- **Texas Division of Emergency Management:** Emergency response personnel to support requests for state assistance from local officials; Communications Coordination Group is engaging with telecommunications partners
- **Texas National Guard:** UH-60 Blackhawk helicopters
- **Texas Department of State Health Service (Texas Emergency Medical Task Force):** Wildland Fire Support Packages and Severe Weather Support Packages including paramedics and ambulances
- **Texas Department of Transportation:** Personnel and equipment to assist with road closures; motor graders to support emergency response operations
- **Texas Department of Public Safety:** Texas Highway Patrol Troopers to assist with road closures and traffic control
- **Texas Parks and Wildlife Department:** Game Wardens and Park Police Officers to provide law enforcement support
- **Texas A&M AgriLife Extension:** Disaster Assessment and Recovery Agents as well as AgriLife Extension Agents to support agricultural and livestock needs
- **Texas Animal Health Commission:** Personnel to provide livestock support
- **Texas Commission on Environmental Quality:** Air/water/wastewater monitoring
- **Public Utility Commission of Texas:** Personnel to coordinate with utility providers across the threat area

Texans are urged to monitor local forecast information and make an emergency plan. Additionally, people across the state are encouraged to follow instructions of local officials and keep an emergency supply kit nearby.

### River Flooding:

Moderate river flooding is being reported at the Sabine River near Greenville, Longview, and Bon Weir.

Moderate river flooding is being reported at Navasota River near Easterly.

Moderate river flooding is being reported at Neches River near Town Bluff.

Minor river flooding is being reported at the Sabine River near Quinlan, Mineola, Gladewater, and Beckville.

Minor river flooding is being reported on the Sulphur River near Talco.

Minor river flooding is being reported on the Angelina River near Cushing and Lufkin.

Minor river flooding is being reported on the Neches River near Neches and Alto.

Minor river flooding is being reported on the Navasota River near Groesbeck.

### OPERATIONAL PRIORITIES:

1. Protect life and property.
2. Support rapid & effective response.
3. Collect and disseminate accurate incident information to improve decision-making.

4. Accurately track incident costs associated with assigned resources for cost recovery.

### **Region 1 (Includes DDs 1, 2, and 7)**

DD 7 – Abilene (Includes Brown, Callahan, Coleman, Comanche, Eastland, Fisher, Haskell, Jones, Kent, Knox, Mitchell, Nolan, Runnels, Scurry, Shackelford, Stephens, Stonewall, Throckmorton, and Taylor Counties): Level III (Increased Readiness Conditions)

### **Region 2 (Includes DDs 3, 4, and 22)**

DD 4 – Dallas/Ft. Worth (Includes Collin, Dallas, Denton, Ellis, Erath, Hood, Hunt, Johnson, Kaufman, Navarro, Palo Pinto, Parker, Rockwall, Somervell, Tarrant, and Wise Counties): [Level IV \(Normal Conditions\)](#)

### **Region 3 (Includes DDs 5, 6, 14, and 15)**

DD 5 – Mt. Pleasant (Includes Bowie, Cass, Delta, Franklin, Hopkins, Lamar, Morris, Red River, and Titus Counties): Level III (Increased Readiness Conditions)

DD 6 – Tyler (Includes Anderson, Camp, Cherokee, Gregg, Harrison, Henderson, Marion, Panola, Rains, Rusk, Smith, Upshur, Van Zandt, and Wood Counties): Level III (Increased Readiness Conditions)

DD 14 – Lufkin (Includes Angelina, Houston, Jasper, Nacogdoches, Newton, Polk, Sabine, San Augustine, San Jacinto, Shelby, Trinity, and Tyler Counties): Level III (Increased Readiness Conditions)

**Shelby County:** On April 10, Shelby County submitted a Disaster Declaration. Voluntary evacuations occurred in the Sand Isle area.

**Tyler County:** On April 10, Tyler County submitted a Disaster Declaration. Voluntary evacuations occurred in the areas of Fox Landing, Mount Neches, and Barlow Lake Estates.

**Newton County:** On April 10, Newton County and the City of Newton both submitted Disaster Declarations.

DD 15 – Beaumont (Includes Hardin, Jasper, Jefferson, and Orange Counties)

**Jasper County:** On April 10, Jasper County submitted a Disaster Declaration.

### **Region 4 (Includes DDs 16)**

DD 16 – Houston (Includes Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton Counties): [Level IV \(Normal Conditions\)](#)

**Galveston County:** Numerous power outages were reported because of fallen poles, and mobile homes suffered damage throughout the county. The Voluntary Agency Liaison (VAL) is coordinating with Texas Gulf Coast Regional Voluntary Organizations in Disaster (TGCRVOAD) for debris cleanup. R.D. McAdams Junior High School sustained a gas leak that has been repaired and repairs to the damage to the roof began on April 10.

**Harris County:** Assessments are underway for damaged and collapsed commercial structures near Katy. Damages were confirmed by the National Weather Service (NWS) from an F-1 Tornado.

### **Region 7 (Includes DDs 8, 9, and 10)**

DD 10 – San Angelo (Includes Coke, Concho, Crockett, Irion, Kimble, Mason, McCulloch, Menard, Reagan, Schleicher, Sterling, Sutton, and Tom Green Counties): [Level IV \(Normal Conditions\)](#)

### **Region 8 (Includes DDs 11, 12, 13, and 23)**

DD 12 – Austin (Includes Bastrop, Blanco, Burnet, Caldwell, Fayette, Hays, Lee, Llano, Travis, and Williamson Counties): [Level III \(Increased Readiness Conditions\)](#)

## **RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS**

**Texas Division of Emergency Management, Texas A&M University System (TDEM):** Incident Support Task Force (ISTF) has assigned three personnel to the SOC and are monitoring the current weather conditions.

**Texas A&M Engineering Extension Service (TEEX) / Texas A&M Public Works Response Team (TX-PWRT):** TX-PWRT has one Liaison Officer (LNO) assigned to the SOC to coordinate and support operations. [Resource availability has been disseminated and the TX-PWRT LNO continues to monitor requests.](#)

**Texas Military Department (TMD):** TMD has assigned six personnel to the SOC and activated Two Ground Transportation Platoons (GTP), with a total of [26](#) personnel, for severe weather response.

**Texas Parks and Wildlife Department (TPWD):** Texas Game Warden Officers are prepared to respond and support rescue operations with statewide resources and has assigned two LNOs to the SOC. TWPD officers, boat rescue teams with swift water and shallow running boats, search and rescue (SAR) teams with 4x4 vehicles, [a helicopter crew with one rescue swimmer, and one drone operator](#) are available on standby. One resident was evacuated from her house by TPWD due to flood waters on April 9. [TPWD Aviation assisted with a search and rescue operation in Newton County on April 10.](#)

**Texas Department of Transportation (TxDOT):** TxDOT is closely monitoring both fire and severe weather threats across the state, and the TxDOT LNO will be at SOC during the day and will operate virtually at night. Overnight TxDOT crews responded to multiple reports overnight to include flooding, accidents on major highways, assistance to law enforcement, diverting traffic from flooded roadways, and clearing debris from roadways. TxDOT will begin preliminary damage assessments as soon as floodwaters recede and as of April 10, 61 state-maintained roads were impacted by flooding, to include 30 road closures.

**Texas Department of State Health Services (DSHS) / Texas Emergency Medical Task Force (EMTF):** EMTF has activated three Severe Weather Packages (SXW PKGS), three Task Force Leaders (TFL), and three Medical Incident Support Teams (MIST). Two Heavy Ambulance Strike Teams (AST) are on standby. The State Medical Operations Center (SMOC) is on limited activation to manage EMTF resources in response to the severe weather.

**American Red Cross (ARC):** The ARC has identified Disaster Relief Operations (DRO) team leadership and Mass Care Teams have prepositioned supplies with shelters on standby. [ARC has conducted disaster assessments for an RV park on the outskirts of Waco that was under water. Twenty cases were reported, and all were assessed as major damage. All residents declined to go to a shelter.](#)

**The Salvation Army (TSA):** The Salvation Army has deployed the Canteen to Kirbyville to support first responders and those affected by the severe weather with food and hydration.

**Southern Baptist Texas Convention (SBTC):** Six shower units were delivered to the Tyler Emergency Operations Center (EOC) to support first responders in the area.

**Texas Baptist Men (TBM):** The TBM, Texans on Mission, quick response feeding unit is on standby.



**Mercy Chefs:** Mercy Chefs are on standby to support feeding operations.
