# Summary of the Upcoming Week

- **Flash flood threat continues near burn scar areas across mainly across N NM into early next week.**
- **Excessive heat lingers in LA over the weekend then expands across much of the Region by mid week.**
- **Tropical Depression Four is moving WNW and will emerge from Cuba today. It is forecast to turn north and then northeast into Florida by the end of the weekend. No impacts expected to FEMA Region 6.**

Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall


