# FEMA Region 6 Weather Threat Briefing

Friday, September 06, 2024

# Summary of the Upcoming Week

- **Daily threat for heavy rainfall along the TX/LA coasts into the middle of next week. Today and Tuesday have highest risks for flash flooding over next 5 days.**
- **Isolated heavy rainfall over S NM burn scars could produce flash flooding today.**
- **Tropical Weather Outlook:**
  - **Low (10%) chance of tropical development in the northwestern Gulf over the next 7 days. Primary impact to FEMA 6 is heavy rain along the TX/LA coasts.**
  - **Low (10 - 20%) chance of tropical development in the Caribbean and the remainder of the Atlantic Basin. The Caribbean system may produce heavy rainfall along the TX coast next week.**





Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall




### Excessive Rainfall Outlook




