Summary of the Upcoming Week

- **Marginal risk for heavy rain Monday for NM burn scars.**
- **TS Gordon is in the eastern Atlantic. No impacts to FEMA 6.**
- **Medium (50%) chance of tropical development off the coast of the Carolinas over the next 7 days. No impacts to FEMA 6.**





5-Day Precipitation Forecast & River Flood Status





Tomorrow's Tornado & Severe Wind / Hail Probabilities








Forecast Rainfall




Excessive Rainfall Outlook









Excessive Rainfall Outlook




The risk of excessive rainfall within 25 miles of a point is < 5%








Excessive Rainfall Outlook
