FEMA Region 6 Weather Threat Briefing

Tuesday, October 01, 2024

Summary

- **No significant weather impacts to FEMA 6 over the next 5 days.**
- **Tropical Weather Outlook:**
 - **Disorganized showers and thunderstorms located over the southwestern Caribbean Sea are associated with a low pressure system. Environmental conditions could support some gradual development of this system. There is a medium chance (40%) that a tropical depression could form towards the end of the week or this weekend as the system enters the Gulf of Mexico. Monitor possible impacts by late weekend or early next week.**
 - **No impacts to FEMA 6 from Tropical Storm Kirk and one disturbance in the eastern Tropical Atlantic.**





Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall




Isolated minor river flooding will continue the rest of the week for the Cache River at Patterson in AR. No significant impacts expected.










Excessive Rainfall Outlook






Today's Tornado & Severe Wind / Hail Probabilities









Tomorrow's Tornado & Severe Wind / Hail Probabilities





Excessive Rainfall Outlook




