Summary

- **No significant weather impacts over the next 5 days.**
- **Tropical Weather Outlook:**
 - **Hurricane Milton has strengthened to a major hurricane Monday morning with maximum sustained winds near 125 mph. Milton will continue to move eastward across the Gulf today. Rip currents will affect coastal areas early this week.**
 - **No impacts to FEMA 6 from Kirk or Leslie.**
 - **Area in far eastern Atlantic has a low, 30%, chance of development. No impacts.**



Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall




Isolated minor river flooding will continue until the end of the week near Cache River at Patterson in AR. No significant impacts expected.






Forecast Rainfall








Excessive Rainfall Outlook






Today's Tornado & Severe Wind / Hail Probabilities










Excessive Rainfall Outlook






Tomorrow's Tornado & Severe Wind / Hail Probabilities









U.S. Drought Monitor Class Change - CONUS 1 Week








