FEMA Region 6 Weather Threat Briefing

Tuesday, October 15, 2024

Summary

- **Elevated fire weather conditions over OK, TX, AR, N LA this week. Near critical conditions could develop on Wednesday and/or Thursday across TX Panhandle/OK as wind gusts increase.**
- **Frost/Freeze conditions expected Wednesday morning in N OK, TX Panhandle, N AR in the morning.**
- **Risk for heavy rainfall leading to flash flooding Friday night into Saturday over NM burn scars.**

- **Tropical Weather Outlook:**
 - **A disturbance in the eastern tropical Atlantic has a medium chance (60%) of development. No impacts are expected in the next 7 days.**
 - **A disturbance in the western Caribbean has a low chance (30%) of development. No impacts are expected in the next 7 days.**

Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall







Tomorrow's Tornado & Severe Wind / Hail Probabilities





Excessive Rainfall Outlook




