**STATEWIDE CURRENT SITUATION:** On March 13, Governor Abbott [announced](#) that he directed TDEM to activate additional state emergency response resources in anticipation of extremely critical wildfire danger expected across West Texas and ongoing elevated-to-critical fire weather conditions across most of the state into the weekend.

On March 7, Governor Abbott [announced](#) that he directed TDEM to request officials from the U.S. Small Business Administration (SBA) join state and local partners to conduct joint preliminary damage assessments in South Texas communities impacted by recent wildfires. These assessments will aid in determining whether Texas meets the threshold for additional federal disaster assistance.

On March 5, Governor Abbott [announced](#) that the Federal Emergency Management Agency (FEMA) approved the state's request for Fire Management Assistance Grants for the Welder Fire in San Patricio County and the Duke Fire in Bexar County.

On March 4, Governor Abbott [directed](#) the Texas Division of Emergency Management (TDEM) to elevate the readiness level of the Texas State Emergency Operations Center (SOC) to Level II (Escalated Response Conditions) as the state braced for extremely critical wildfire conditions and severe weather threats. The Governor also added 33 counties to the state's wildfire disaster declaration, which now totals 236 counties impacted by increased fire weather conditions.

### OPERATIONAL PRIORITIES:

---

1. Protect life and property.
2. Support rapid & effective response.
3. Collect and disseminate accurate incident information to improve decision-making.
4. Accurately track incident costs associated with assigned resources for cost recovery.

### **Region 1 (Includes DDs 1, 2, and 7)**

DD 1 – Amarillo (Includes Armstrong, Briscoe, Carson, Castro, Childress, Collingsworth, Dallam, Deaf Smith, Donley, Gray, Hall, Hansford, Hartley, Hemphill, Hutchinson, Lipscomb, Moore, Ochiltree, Oldham, Parmer, Potter, Randall, Roberts, Sherman, Swisher, and Wheeler Counties)

**Gray County:** [The Rest Area has burned 7,931 acres and is 60% contained.](#)

**Roberts County:** [The Windmill fire has burned 23,000 acres and is 65% contained.](#)

**Disaster District Emergency Operations Center (DDEOC) 1:** activated to Level III (Increased Readiness Conditions) on March 13.

**Haskell County:** [The Cow Pasture Fire burned 600 acres and is contained.](#)

**DDEOC 7:** [Returned Level IV \(Normal Conditions\) on March 15.](#)

### **Region 2 (Includes DDs 3, 4, and 22)**

DD 3 – Wichita Falls (Includes Archer, Baylor, Clay, Cottle, Foard, Hardeman, Jack, Wichita, Wilbarger, and Young Counties)

**Wichita County:** [The Midway Fire burned 20 acres and is contained.](#)

**DDEOC 3:** [Returned to Level IV \(Normal Conditions\) on March 15.](#)

DD 4 – Dallas/Ft. Worth (Includes Collin, Dallas, Denton, Ellis, Erath, Hood, Hunt, Johnson, Kaufman, Navarro, Palo Pinto, Parker, Rockwall, Somervell, Tarrant, and Wise Counties)

**DDEOC 4:** Returned to Level IV (Normal Conditions) on March 15.

DD 22 – Sherman (Includes Cooke, Fannin, and Grayson Counties)

**DDEOC 22:** Returned to Level IV (Normal Conditions) on March 15.

**Region 3 (Includes DDs 5, 6, 14, and 15)**

DD 5 – Mt. Pleasant (Includes Bowie, Cass, Delta, Franklin, Hopkins, Lamar, Morris, Red River, and Titus Counties):

**Cass County:** The Cass 1230 fire has burned two acres and is contained.

**Cass County:** The Conco Hil fire has burned 57 acres and is contained.

DD 6 – Tyler (Includes Anderson, Camp, Cherokee, Gregg, Harrison, Henderson, Marion, Panola, Rains, Rusk, Smith, Upshur, Van Zandt, and Wood Counties):

**Upshur County:** The Upshur 1259 Fire burned 50 acres and is contained.

DD 14 – Lufkin (Includes Angelina, Houston, Jasper, Nacogdoches, Newton, Polk, Sabine, San Augustine, San Jacinto, Shelby, Trinity, and Tyler Counties):

**Angelina County:** The Angelina 1258 Fire burned seven acres and is contained.

**Region 4 (Includes DDs 16)**

DD 16 – Houston (Includes Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton Counties)

**Brazoria County:** The Brazoria 1279 Fire burned 15 acres and is 30% contained.

**Colorado County:** A Wildfire burned 5 acres and is contained.

**Walker County:** The Walker 1281 Fire burned 8 acres and is 50% contained.

**Region 5 (Includes DDs 19-21)**

DD 20 – Corpus Christi (Includes Aransas, Bee, Brooks, Duval, Jim Wells, Kenedy, Kleberg, Live Oak, Nueces, Refugio, and San Patricio Counties)

**DDEOC 20:** Activated to Level III (Increased Readiness Conditions) on March 14.

**Duval County:** The Duval 1256 Fire burned 100 acres and is 50% contained.

**Refugio County:** The Lake Pasture Fire burned 300 acres and is 90% contained.

DD 21 – Weslaco (Includes Cameron, Hidalgo, and Willacy Counties)

**DDEOC 21:** Activated to Level III (Increased Readiness Conditions) on March 14.

**Hidalgo County:** The Hargill Reservoir Fire has burned 13 acres and is 95% contained.

**Hidalgo County:** A Brush fire has burned 26 acres and is 90% contained.

### **Region 6 (Includes DDs 17, 18, and 24)**

DD 17 – Victoria (Includes Calhoun, DeWitt, Goliad, Gonzales, Lavaca, Jackson, and Victoria Counties):

**Calhoun County:** The Bayside fire burned 20 acres and is contained. The Ocean Front fire burned 508 acres and is contained.

**Jackson County:** The Lolita Grass Fire burned 10 acres and is contained

**Victoria County:** The 1686 Mulch Fire burned 11 acres and is contained.

**Victoria County:** The Josephine Fire burned 4 acres and is contained.

DD 18 – San Antonio (Includes Atascosa, Bandera, Bexar, Comal, Frio, Gillespie, Guadalupe, Karnes, Kendall, Kerr, McMullen, Medina, and Wilson Counties)

**Bandera County:** The Saddle fire has burned 17 acres and is 95% contained.

**Gillespie County:** The Crabapple Fire has burned 8,640 acres and is uncontained. The fire is threatening 50 structures, and the County Judge has signed a disaster declaration with a mandatory evacuation.

**Kendall County:** A Wildfire has burned 50 acres and is 50% contained.

**Wilson County:** A Wildfire has burned 3 acres and is not contained.

DD 24 – Del Rio (Includes Dimmit, Edwards, La Salle, Kinney, Maverick, Real, Uvalde, Val Verde, and Zavala Counties)

**Real County:** The Chicken Strip Fire has burned 40 acres and is 30% contained.

### **Region 8 (Includes DDs 11, 12, 13, and 23)**

DD 12 – Austin (Includes Bastrop, Blanco, Burnet, Caldwell, Fayette, Hays, Lee, Llano, Travis, and Williamson Counties)

**Fayette County:** [The Yellowjacket \(Fayette 1248\) Fire burned four acres and is contained.](#)

**Llano County:** The Red Rock Creek Fire has burned 48 acres and is 85% contained.

DD 23 – Killeen (Includes Bell, Coryell, Hamilton, Lampasas, Milam, Mills, and San Saba Counties):

**San Saba County:** The Cottonwood Creek Fire has burned 635 acres and is contained.

## RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS

**Mass Care:** TDEM partners are adapting to the evolving conditions and are ensuring community needs are met while prioritizing safety. Local agencies continue to support feeding and assess recovery efforts as it transitions to community resources to meet the needs of residents.

**Texas A&M AgriLife Extension Service (AgriLife):** SOC Liaisons maintain daily communication with ESF 11 partners for situational awareness and needs assessment. Disaster Assessment and Recovery (DAR) specialists and County Extension Deployment Team members are on standby to support any ESF 11 efforts associated with animal response or other fire weather response efforts as requested.

**Texas A&M Forest Service (TAMFS):** TAMFS has firefighting resources positioned in all TDEM Regions. Air Tankers, Attack helicopter aircraft, Single Engine Airtankers (SEAT), heavy equipment and engines are positioned throughout the state. TAMFS has activated the Emergency Operations Center (EOC) in College Station. Texas Intrastate Fire Mutual Aid System (TIFMAS) strike teams are in Amarillo, Lubbock, Merkel, San Angelo, Ozona, Brownwood, Kerrville, Silverton, Burkburnett, Childress, Waco, McGregor, Uvalde, Alice, and Beeville.

**Texas Military Department (TMD):** TMD is providing direct support to TAMFS with aerial fire suppression capability in response to critical fire weather. TMD has staged two Medium MRP with four UH-60 helicopters in San Antonio, and one Heavy MRP with two CH-47 Chinook helicopters in Grand Prairie, both with crews. A SOC Support Team has been assigned to Austin. As of March 11, TMD Rotary Wing aircraft have flown a

total of 42 hours and dropped a total of 122 buckets for a total of 68,630 gallons of water. TMD has activated 34 personnel and six aircraft in support of this incident.

**Texas Parks and Wildlife Department (TPWD):** TPWD has the following Statewide resources available to support, one LNO to the SOC, one helicopter in Austin, State Game Wardens, and State Park Police Officers, and All-Terrain Vehicles. TPWD Aviation responded to the Onion Creek Wildfire in Hays County and successfully made 18 water bucket drops (2,070 gallons of water).

**Texas Department of Information Resources (DIR):** DIR is continuing to monitor the situation using cybersecurity tooling and threat intelligence feeds. No cyber threats related to this weather event have been identified. No requests for network or technology have been made.

**Texas Department of Transportation (TxDOT):**

As of March 15, no roads/highways were closed due to fire weather conditions and evacuations in two separate counties. TxDOT started sharing Extreme Wildfire messaging on DMS road signage and on social media. The wildfires, high winds, and brown-out conditions in the Panhandle, Caprock, and Plains yesterday contributed to several multi-vehicle crashes and overturned high-profile vehicles that resulted in the shutdown of several roads and highways. TxDOT crews assisted LE with road closures, evacuations, traffic control, and debris cleanup. Crews will begin conducting road inspections looking for signs of structural or roadway damage. As witnessed March 14, wildfires and weather conditions can quickly limit visibility on roadways. TxDOT urges motorists to slow down and drive w/caution. Check DriveTexas.org for the most current road conditions.

TxDOT continues to staff the State Ops Ctr and are closely monitoring fire and storm threats across the state. Crews statewide stand ready to respond and assist.

**Texas Department of State Health Services (DSHS):** DSHS is currently monitoring the situation and ready to deploy resources and respond as the incident requires. DSHS has two LNOs assigned to the SOC.

**Texas Emergency Medical Task Force (EMTF):** EMTF has recorded 1,987 encounters, with six treated, and none transported.

**American Red Cross (ARC):** Volunteers have completed damage assessments in Sinton and have identified over 100 affected homes. North Texas teams assessed damage to over 119 homes and have provided disaster emergency supplies.

**The Salvation Army (TSA):** On March 5, TSA of San Antonio Rapid Response unit supported first responders for the Calaveras fire with 176 meals, 75 snacks, and 103 drinks. TSA of Beeville supported first responders and those affected by the Welder

Complex fires by providing food, snacks, and water. The Beeville Service Unit is supporting those affected by the Welder Fires in Sinton by providing meals in coordination with the local Baptist Church.
