There will be an increased potential of severe thunderstorms across much of the area Thursday afternoon and evening. There is a Slight (Level 2 of 5) risk of severe storms mainly east of an Artesia to Presidio line. The main concern will be very large hail (potentially greater than 2" in diameter) and damaging winds in excess of 70 mph, though a tornado will also be possible. Locally heavy rainfall could result in a localized flash flood threat with some of the storms.

Hazardous Weather



Severe thunderstorms are forecast to develop across portions of the Caprock and Rolling Plains this afternoon and evening. Storms will be capable of producing extremely large hail in excess of baseball size, damaging wind gusts up to 80 mph, and tornadoes. Torrential rainfall will also accompany storms, resulting in the potential for localized flash flooding.







Keetch-Byram Drought Index


