FEMA Region 6 Weather Threat Briefing

Wednesday, June 25, 2025

Disclaimer: The purpose of this briefing is to provide a **Regional** weather threat assessment and is meant as a general overview. Summary

- **Flash Flooding:** Slight risk (level 2 of 4) for NM today and Marginal risk (level 1 of 4) in NM Thursday through Sunday. Major to Extreme risk (levels 3-4 of 4) for burn scar/debris flow flash flooding today with Major risk for S NM through Saturday.
- **Heat:** Excessive heat across portions of AR, E LA through Friday.
- **River Flooding:** Moderate/Minor river flooding in AR, TX, and LA. Trinity River at Liberty, TX is forecast to enter major flood stage by this evening. Homes in several subdivisions will be flooded.
- **Tropical:** Post-tropical cyclone Andrea is expected to dissipate today. No impacts to FEMA 6.

Today's Tornado & Severe Wind / Hail Probabilities








Tomorrow's Tornado & Severe Wind / Hail Probabilities








Marginal risk (level 1 of 4) for flash flooding in S-C NM outside of burn scar areas.




Marginal risk (level 1 of 4) for flash flooding in E NM, W TX outside of burn scar areas.
