STATEWIDE CURRENT SITUATION: On July 8, Governor Abbott held a press conference at the Hunt Store following an aerial tour of flood damage to <u>provide an update</u> on the state's continued response to severe flooding that impacted Texas.

Governor Abbott urged Texans to continue reporting suspected missing loved ones by calling 830-258-1111 or emailing kerrvillemissing@dps.texas.gov.

The State of Texas has deployed over 2,100 personnel and more than 1,100 vehicles and equipment assets to help local officials and communities respond to and recover from the devastating flooding. More than 20 state agencies are currently responding to flooding threats across the state.

On July 6, Governor Abbott announced that President Donald J. Trump approved federal disaster assistance as part of a Major Disaster Declaration, following deadly and destructive flooding that impacted Texas this past week

The Governor directed the Texas Division of Emergency Management (TDEM) to formally request that FEMA officials join state and local partners in conducting joint preliminary damage assessments in Kerr County.

Officials continue to review disaster damage information self-reported by Texans through TDEM's Individual State of Texas Assessment Tool (iSTAT) damage survey. When it is safe to do so, impacted Texans are encouraged to submit information about damage to homes or businesses by visiting damage.tdem.texas.gov.

On July 5, Governor Greg Abbott held a press conference with the U.S. Department of Homeland Security (DHS) Secretary Kristi Noem to provide an update on the ongoing response to severe flooding impacting the Texas Hill Country. The Governor also expanded the number of counties included in his disaster declaration and requested a federal disaster declaration. Governor Abbott <u>expanded</u> the number of counties included in his disaster declaration and requested a federal disaster declaration.

On July 4, Governor Abbott <u>provided</u> an update during a press conference at the Hill Country Youth Event Center on Texas' response to severe flooding impacting Kerr County and surrounding communities.

On July 3, TDEM <u>increased</u> the readiness level of the Texas State Emergency Operations Center (SOC) to Level II (Escalated Response) and activated additional state emergency response resources as portions of West and Central Texas prepared for continued heavy rainfall and flash flooding threats heading into the holiday weekend.

On July 2, TDEM <u>activated</u> state emergency response resources in anticipation of increased threats of flooding in parts of West and Central Texas heading into the holiday weekend.

OPERATIONAL PRIORITIES:

- Protect life and property.
- Support rapid & effective response.
- Collect and disseminate accurate incident information to improve decision-making.
- Accurately track incident costs associated with assigned resources for cost recovery.

Region 6 (Includes DDs 17, 18, and 24)

DD 18 – New Braunfels (Includes Atascosa, Bandera, Bexar, Comal, Frio, Gillespie, Guadalupe, Karnes, Kendall, Kerr, McMullen, Medina, and Wilson Counties):

On July 6, Disaster District Emergency Operation Center (DDEOC) 18 moved to Level II. As of July 7, TEEX PWRT teams are working on lift station issues from Kerrville to Comfort. Damage assessments are ongoing and multiple state agency Critical Incident Stress Management (CISM) Teams are on site. Discussions are on-going regarding Debris Management and establishing temporary debris sites.

Comal County:

In Comal County evacuations were conducted along river road, below the Canyon Lake Dam. Heavy rains forced evacuations of lower-lying homes along the Guadalupe River, but residents have been allowed to return home.

Guadalupe County:

In Guadalupe County, eight inches of rain fell early in the morning on July 5th. The rain caused flooding along the roadways and eight vehicles were flooded requiring water rescues.

Kendall County:

Individual State of Texas Assessment Tool (iSTAT) surveys have been completed in Kendall County.

Kerr County:

A family reunification center is located at Trinity Baptist Church on 800 Jackson Road in Kerr Co. The American Red Cross has a shelter located at Calvary Baptist Church on 113 Methodist Encampment Road in Kerr Co. and a medical is located at Kerr Co. First United Methodist Church on 321 Thompson Drive in Kerr Co.

40 Incident Support Task Force (ISTF) personnel are conducting damage assessments in Kerr County. The Volunteer Reception Center has been established and is located at Salvation Army Shelter on 855 Hays Street in Kerr Co.

A Unified Command has been established, and the Incident Command Post (ICP) is located at the Hill Country Youth Event Center in Kerr Co. The Maroon Incident Management Team (IMT) is coordinating to track personnel and working requests in support of the Kerr County Complex Incident. A Texas A&M Forest Service (TAMFS) CISM Team is on site for responders. Kerr County bridges are scheduled for infrastructure assessments tomorrow morning.

Donations management is being bolstered with TDEM Incident Support Task Force (ISTF) personnel, and a warehouse has been identified. ISTF has met with Kerr Co. and Kerr County officials regarding debris management, potential locations of temporary debris sites, and search and rescue volunteer operations. ISTF is tracking shelters and reunification centers.

Region 8 (Includes DDs 11, 12, 13, and 23)

DD 11 – Waco (Includes Bosque, Falls, Freestone, Hill, Limestone, and McLennan Counties):

On July 6, DDEOC 11 activated to Level III.

DD 12 – Austin (Includes Bastrop, Blanco, Burnet, Caldwell, Fayette, Hays, Lee, Llano, Travis, and Williamson Counties):

On July 5, DDEOC 12 activated to Level III.

Near historic rainfall impacted Travis, Burnet, and Williamson Counties during the night and first responders conducted dozens of water rescues.

Burnet County:

Crews from Travis County extended their response into Burnet County, where they coordinated with local responders, Texas Parks and Wildlife Department, Texas Task Force, and Texas Department of Public Safety boats to rescue dozens of people in Burnet, Marble Falls, and other areas of the county.

Texas Task Force 2 (TX-TF2) assisted with an area wide search in Burnet County on July 7.

San Saba County:

The shelter at the San Saba Civic Center has been closed.

Travis County:

Rainfall started in Travis County with water rescues reported early in the morning hours. Emergency Services Districts (ESDs) and Austin units managed the rescues. The city of Austin requested boat squads at approximately 3:00 AM due to neighborhoods being impacted by fast moving water. Travis County aviation assets worked directly with the SOC to dispatch local and state aircraft to assist TX-TF throughout the day.

Travis County requested a wide area search team to assist with recovery in a neighborhood where fatalities were reported. A Texas Task Force 2 (TX-TF 2) Type 3 team located in Llano was moved to Travis County to meet this need.

Williamson County:

Flooding in Williamson County started in the Leander area, moved to Liberty Hill and to surrounding cities and communities. An apartment complex was evacuated along the San Gabriel River near downtown Georgetown due to rising waters. Numerous roads are closed in Williamson County due to damage from flooding and water on the roadways, with one railroad bridge destroyed. Several RV parks have been evacuated ahead of rising waters, and some evacuations were conducted with boats.

Texas Intrastate Fire Mutual Aid System (TIFMAS), Emergency Medical Task Force (EMTF), and Texas Division of Emergency Management will begin conducting Individual State of Texas Assessment Tool/ Public State of Texas Assessment Tool (iSTAT/pSTAT) surveys in Williamson County.

DD 13 – Bryan (Includes Brazos, Burleson, Grimes, Leon, Madison, Robertson, and Washington Counties):

On July 6, DDEOC 13 returned to Level IV.

DD 23 – Killeen (Includes Bell, Coryell, Hamilton, Lampasas, Milam, Mills, and San Saba Counties):

On July 4, DDEOC 23 activated to Level III.

Hamilton County:

Hamilton County Sheriff requested assistance from the Oklahoma Task Force Boat Squad for a missing female on the Leon River.

San Saba County:

San Saba County continues to experience flooding due to the previous heavy rainfall. The San Saba Civic Center shelter has been closed.

RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS

Texas Division of Emergency Management (TDEM):

Communications Coordination Group (CCG):

The Communications Coordination Group (CCG) and its partners are actively monitoring the situation and preparing resources for potential response. Public, private, and volunteer sectors are assessing and adjusting their resources as needed. The Commission on State Emergency Communications (CSEC) has contacted 9-1-1 centers in affected areas, confirming no current issues with 9-1-1 systems and coordinating requests for dispatch personnel.

Cellular providers are taking proactive measures: AT&T FirstNet has deployed a Cell on Wheels (COW) to San Saba and Kerr Co., while Sprint-T-Mobile has two COWs on standby, and Verizon has SATCOLTs staged in Plano. Cellular providers have also offered cellphones, charging stations, and accessories for reunification centers and have implemented refueling/backup power operations. While some cell tower repairs are underway, overlapping coverage prevents major outage issues.

The Texas Department of Public Safety's Office of the Statewide Interoperable Communications (SWIC) is identifying available COMLs (Communications Unit Leaders) for potential support. Amateur Radio services have activated local nets, providing backup emergency communication and localized reports. Federal partners are monitoring and ready to assist upon request. Finally, the Texas Telecommunicator Emergency Response Taskforce (TXTERT) is monitoring the situation and rostering personnel to support dispatch centers if required.

As of July 7, there were seven mobile cellular platforms requested, and they are assigned to Kerr, Llano, and San Saba counties. Cellular service is stable. SWIC has supplied a COML to provide communications support.

Incident Support Task Force (ISTF):

ISTF members have been deployed to TDEM Region 5. ISTF Regional Volunteer Agency Liaison (VAL) team is supporting community response and identifying key recovery needs, such as food access, debris removal, and muck-outs. There have been 1,300 requests for Volunteer Organizations Active in Disasters (VOAD) cleanup assistance have been submitted through iSTAT.

On July 5, five ISTF members deployed to the Kerr Co. area. ISTF has members rostered and pending a second wave deployment.

ESF- 6 Mass Care:

Sheltering:

As of July 8, four shelter sites have a cumulative population of 233 people.

Reunification:

Two reunification centers are open:

- Schreiner University
- First United Methodist Church Kerr Co.

Feeding:

9 fixed sites and mobile areas have served 6,402 total meals.

Partners coordinating resources:

- The Salvation Army

- Southern Baptist Men
- World Central Kitchen

VOAD

Team Rubicon, Global Empowerment Mission, Convoy of Hope, and ITDRC are supporting efforts with equipment at the reunification centers. Regional VALs are connecting with community and local jurisdiction to coordinate VAL/VOAD Activities.

Texas A&M AgriLife Extension Service (AgriLife):

One Disaster Assessment and Recovery (DAR) Area Chief is reporting to the IMT. Two DAR agents are assisting the Type 3 VET Team in Kerr County. Thirteen DAR agents will be conducting damage assessments in Kerr County. The AgriLife DAR PIO has been sharing weather safety information via social media channels and is working with other state agency partners on message delivery.

AgriLife Disaster Assessment and Recovery (DAR) Unit is monitoring the flooding in Tom Green, Kerr, Bandera, Coke, Comal, Concho, Gillespie, Kendall, Kimble, Llano, Mason, McCulloch, Menard, Reeves, and San Saba Counties. AgriLife DAR Agents have disseminated weather information and have been in contact with officials in the affected counties. AgriLife has a SOC Liaison at the SOC. A DAR Area Chief has reported to the Incident Management Team (IMT) for assistance and another DAR Area Chief is assisting Red Cross in the city of San Saba. DAR PIO has been sharing weather safety information via social media channels and is working with other state agency partners with message delivery.

The Gillespie County AgriLife office is being used by Texas Parks and Wildlife Department (TPWD) for staging. AgriLife currently has two DAR agents assisting a Type 3 Vet Team in Kerr County. Evacuees from the Tom Green County flood that were at the AgriLife Extension & Research facility have been relocated to a nearby church. Texas A&M AgriLife Extension has sent 20 DAR Agents and County Extension Agents to support damage assessment efforts in Kerr County.

Texas A&M Engineering Extension Service Public Works Response Team (PWRT):

On July 8, PWRT team leaders met with Kerrville public works staff at 8:00 AM. The plan for the day was to visit and assess additional distribution and collection sites.

On July 7, PWRT members from Team 2 met with the City of Kerr Co. Public Works to identify tasks. The team members then split into 3 groups. Group 1 traveled to Comfort to assist the Kendall County WCID with a generator repair. Group 2 visited the Surface Water Treatment Plant in Kerr Co. to perform further assessments. Group 3 stayed in the area to assist at Distribution/Collection sites. 1 member remains as the LNO at the IMT. PWRT continues to staff the SOC for 24 hours.

On July 5, PWRT was requested to send a team to Kerr Co. The PWRT team arrived at the Kerr Co. IMT with plans to assist at the Surface Water Treatment Plant tomorrow.

PWRT members have arrived in Kerr Co.. This assessment of the Surface Water Treatment Plant found the raw water intake is out, chemical storage and equipment is destroyed, the disinfection process is out of service, and the security fence is destroyed. An additional PWRT team deployed to Kerr Co. on July 6 to begin lift assist operations.

Texas A&M Engineering Extension Service Texas Task Force 1 (TEEX/TX-TF1):

As of July 8, Search and Rescue (SAR) resources continue to arrive in the area of operations. Swift Water Rescue Boat Squads from Virgina arrived in Austin for check-in and inspection before being assigned in Kerr County. Swift Water Rescue Boat Squads from Florida arrived in Austin for check-in and inspection before being assigned in Kerr County. Additional requests via Emergency Management Assistance Compact (EMAC) are still being processed. A request to FEMA for three additional Type III Task Forces, Water Capable with Human Remain Detection (HRD) capability has been made. TX-TF1, TX-TF2, and TX-TF3 continue to conduct mission assignments throughout the area of operations.

TEEX activated seven Texas A&M Task Force 1 Type 3 Swiftwater/Flood Rescue Teams consisting of six personnel and two inflatable rescue boats each. A Water Group

Supervisor (WGS) Package with two personnel coordinates the TX-TF1 SAR response to assist with any search and rescue incidents related to the forecasted potential severe weather and flooding forecasted within the State. Five of the teams and the WGS were prepositioned on July 3.

On July 5, TX-TF1 began operations in Burnet and Western Travis Counties. TX-TF1 and TX-TF2 have continued operations in Regions 6 and 8, conducting search and rescue operations and evacuations. TX-TF1 Water Squads and Water Group Supervisors have also pivoted resources to Comal and Guadalupe Counties due to heavy rainfall in the area. TX-TF1 & TX-TF2 have conducted a total of 312 evacuations, 43 rescues, and 40 calls of assistance from other first responders.

On July 6, Urban Search and Rescue (USAR), Oklahoma Task Force 1 & 2 (OK-TF1 & OK-TF2) and Louisiana Task Force 1 (LA-TF1) arrived at the SOC. Swift Water Rescue Boat Squads from Florida and Virgina, and a Canine Mission Ready Package from Tennessee are enroute. TX-TF1, TX-TF2, and TX-TF3 have continued to be engaged in mission assignments throughout Texas. Water Squad Dallas, Washington County, OK-TF1, and OK-TF2 repositioned to TDEM Region 2. As of July 6, there were 132 evacuations, 54 rescues, and 40 calls for assistance from first responder agencies.

Texas A&M Forest Service (TAMFS):

TAMFS has activated six All-Hazard Strike Teams, 14 Saw Teams, three skid steers, and two mobile command posts. There are three Liaison Officers (LNO's) at the SOC, one LNO and one Staging Area Manager (STAM) with the Incident Management Team (IMT). One PIO was assigned to San Angelo. TAMFS has sent six personnel to assist with logistics and coordination in Disaster District Emergency Operations (DDEOC) 10. The TAMFS Taskforce from Alice transported a Bearcat from Laredo to Kerr County. Five TIFMAS Strike Teams are assisting with search and rescue, and 911 Backfill in Kerrville. One TIFMAS Strike Team is assigned to Leander. TAMFS has activated 239 personnel.

Department of Information Resources (DIR):

DIR is monitoring the situation using cybersecurity tooling and threat intelligence feeds. No cyber threats related to this weather event have been identified. The Texas.gov homepage banner has been updated to include flood recovery resources and a link to the Kerr County Flood Relief Fund.

Public Utility Commission of Texas (PUC):

As of July 7, No significant statewide outages to report. One Liaison Officer remains assigned to the SOC. PUC has one Liaison Officer (LNO) assigned to the SOC and will support 24-hour operations if needed.

Power outages statewide peaked to 8,600 and are just under 5,000 on July 6. The power outages are concentrated in the Oncor, CenterPoint, and Kerr Co. service areas. Oncor's estimated time of restoration is July 6, at 7:00PM. Restoration may be delayed due to terrain conditions and the potential for extensive repairs.

Texas Alcoholic Beverage Commission (TABC):

Twenty-three members of TABC's Special Response Team (SRT) will assist DPS and TPWD in checkpoint, search, and recovery operations.

Fifteen SRT members and a victim services coordinator remain on standby and are ready to respond if needed. TABC is actively supporting the state's response to the severe weather event by supporting public safety and disaster recovery efforts.

TABC Special Response Team (SRT) responded to the Kerr Co. EOC to assist with public safety and disaster recovery operations. An Additional SRT remains on standby, and additional law enforcement personnel are available if more are needed.

Texas Commission on Environmental Quality (TCEQ):

As of July 8, TCEQ is tracking 17 drinking water systems that are on a Boil Water Notice (BWN) serving a population of 50,584.

TCEQ has staff available to respond to any air/water/waste related issues including drinking water/wastewater issues and/or emergency response activities, as needed. TCEQ is providing local governments with technical assistance and guidance on debris management and are available to process Temporary Debris Management Site applications. TCEQ has authorized two temporary debris management sites.

Texas Department of Agriculture (TDA)

TDA is staffing 12-hour shifts at the State Operations Center (SOC) to monitor unmet needs in the agricultural community. The free, confidential Agri-Stress Helpline offers 24/7 support via call or text for those experiencing stress or loss. Staffed by trained professionals, it serves the agriculture, forestry, and fishing sectors, providing support and referrals to local mental health resources. So far, it has helped over 285 Texans in 114 counties. Call or text 1-833-897-2474 for assistance.

TDA's Hay Hotline is open for those wishing to donate hay. Donors can register at https://texasagriculture.gov/Home/Production-Agriculture/Hay-Hotline and will be contacted if requests are received.

TDA's STAR (State of Texas Agriculture Relief) Fund is accepting applications from those who suffered agricultural losses due to the recent weather event. Funds may be used for rebuilding fences, restoring operations, and other disaster-related costs. Applicants in counties included in the Texas Governor's disaster declaration have 90 days from the proclamation date to apply. The deadline is November 4, 2025, at 11:59

p.m. Apply at https://texasagriculture.gov/Home/Production-Agriculture/Disaster-Assistance/STAR-Fund/Severe-Weather.

Through the Emergency Food Assistance Program (TEFAP), TDA food bank contractors distribute USDA-donated food to emergency feeding organizations. Texans can access this food via on-site meals or take-home packages.

Texas Department of Public Safety (DPS):

Texas Highway Patrol (THP) continues to assist with search and recovery efforts. They are conducting traffic control, assisting local law enforcement with emergency calls, and serving as escort teams.

Unmanned Aircraft continue to support partnering agencies in search and recovery efforts. They are conducting mapping overflights for debris piles as they move east (downriver) toward Canyon Lake.

Criminal Investigation Division (CID) are teamed with SOG conducting recovery efforts. CID personnel are at the morgue assisting Rangers in identification efforts. CID Special Agents are also providing security for local and county officials, and at public meetings.

Texas Rangers Division is assisting with the collection of DNA samples for transport by AOD to the University of North Texas - Denton for victim identification. Rangers are providing death notifications for identified victims.

Aircraft Operations Division (AOD) are conducting aerial reconnaissance missions for damage assessments in the area as well as providing flights for officials. Fixed wing aircraft are transporting DNA samples to the University of North Texas - Denton for victim identification.

The Infrastructure Operations Division (IOD) deployed the Sam Houston Command Trailer to the Kerr County EOC. They are supporting local Kerr Co. PD and Kerr County SO with Communication personnel. A 106' radio tower was deployed to Center Point as a repeater to be used amongst search personnel and to communicate with the command trailer.

Information Technology (IT) is providing on-site tech support and integrations for critical Frontline systems: TXMAP, TAK, and aircraft video systems.

Intelligence and Counterterrorism (ICT) Division Analysts are collecting, analyzing, and sanitizing information on missing and deceased individuals. They are also assisting with mapping operational routes for DPS assets to enter the impacted area. ICT Communication operators are augmenting emergency call intake from Kerr Co. PD and Kerr County SO.

Victim Employee Support Services (VESS) assisted with death notifications and continue working with the affected families by providing psychological support. They have conducted several debriefings with emergency personnel in the operational area and more are planned in the coming days.

Three boat teams from the Tactical Marine Unit (TMU) continue to assist recovery efforts in Burnet County.

Texas Department of State Health Services (DSHS)

On July 8, Southwest Texas Regional Advisory Council (STRAC) regionally deployed two Mortuary Enhanced Remains Cooling Systems to Kerrville. The Coastal Bend Regional Advisory Council (CBRAC) has deployed two morgue trailers to Kerrville; one is in use at Ingram, and one is staged and ready to receive decedents. Texas Mass Fatality Response Team members remain activated, with two members supporting fatality operations at Grimes Funeral Home.

On July 7, SETRAC deployed two additional morgue trailers to support fatality management operations in Boerne and Kerrville. CBRAC is actively moving two morgue trailers to Kerrville.

A SOC Coordination Officer (SCO) and (LNO) have been sent to the SOC and the State Medical Operations Center (SMOC) has activated for 24-hour operations. DSHS initiated mortality surveillance operations and Public Health Region 8 is deploying one Mortuary Enhanced Remains Cooling System and Morgue trailer to support with fatality management. EMTF has activated multiple assets for this incident. The Texas Mass Fatality Operations Response Team (TMORT) has been activated and is supporting the jurisdiction with six personnel. An additional DSHS morgue trailer deployed to Kerr Co. on July 5.

Southwest Texas Regional Advisory Council (STRAC) deployed one Mortuary Enhanced Remains Cooling System to support fatality management operations, and the San Antonio Regional Medical Operations Center has been activated to support operations.

Public Health Region 8 has assigned personnel to support DDEOC 18 and have activated one Mortuary Enhanced Remains Cooling System and one Morgue Trailer in support of fatality management operations. Public Health Region 7 has assigned personnel to support DDEOC 12 in Williamson County.

The Capital Area of Texas Regional Advisory Council (CATRAC), Regional Medical Operations Center (RMOC), has been activated for operations. RMOC has communicated with hospitals, nursing homes, and ALS facilities within the impact area. The South East Texas Regional Advisory Council (SETRAC) will deploy two morgue trailers to Kerr Co.

Texas Department of Transportation (TxDOT):

As of July 7, TxDOT has 34 locations on state-maintained roads impacted by floodwaters, with 9 closed due to highwater and 25 are closed due to damages.

As of July 6, TxDOT has 36 locations on state-maintained roads impacted by floodwater, nine are closed due to highwater, and 21 are closed due to damage. TxDOT crews have been monitoring roads, clearing debris, cleaning drainage areas, and providing traffic control. State Highway (SH) 29 in Burnet County has reopened, and temporary main-lane closures were in place the last several days to provide egress to firefighting equipment. TxDOT crews and emergency staff are rostered and are on standby to respond. TxDOT has 24/7 staffing in the SOC.

Texas Emergency Medical Task Force

The following EMTF Resources are activated across the state:

- EMTF 7 one SWX PKG in Kerr Co.
- EMTFs 2 and 9 have one SWX PKG in Llano
- EMTF 11 has one SWX PKG in Leander
- EMTF 6 has one SWX PKG in Leander
- EMTF 4 has one SWX PKG in San Antonio staged at the Lancer Warehouse in San Antonio
- Two MISTs at the SOC with SCO
- One MIST at the Rellis IMT
- One MIST at the Kerr Co. IMT
- Six TMORT personnel in Kerr Co.

Three SWX PKGs are on standby (EMTFs 1, 2, 6)

SWX Activation Totals: 1,188 encounters, 57 treated, 49 transported

Texas Health and Human Services Commission (HHSC):

On July 7, HHSC deployed four personnel to Kerr Co. Unified Command to coordinate disaster behavioral health services. They are working to support the Family Assistance Center and First Responder Assistance Center.

Texas HHSC sent staff to the SOC and personnel will remain for the duration of the incident. The Longterm Care Regulation section reports no impacted facilities. The Kerr Co. State Hospital reports no major impacts. Ice, water, and freight vendors are on standby to respond as needed. Disaster Behavior Health units at the local level were deployed on July 6.

A long-term care (LTC) facility in Burnet County was evacuated. Other LTC facilities have reported impacts from the severe weather but are able to shelter in place. A residential childcare facility in Liberty Hill was evacuated, and the children were moved into a stable environment. Two intermediate care facilities in Seguin have been relocated to hotels.

Texas Military Department (TMD):

As of July 8, TMD received four UH-60 aircraft and crews from Arkansas National Guard via EMAC to assist in transporting stranded persons in the impacted Hill Country. TMD activated North Dakota Air National Guard MQ-9 operators supporting Texas Remote Piloted aircraft through an EMAC.

TMD has activated eight Ground Transportation Platoons (GTP), 3.5 Rotary Wing Medium MRPs, a SOC Support Team, Air Operations Center Representatives, a Rotary Wing Heavy MRP, a Tactical Air Control Party (TACP), two Shelter Teams, Remote Piloted Aircraft, two Ground Transportation Company Headquarters, one Battalion Mission Command, an Air Operations Center MRP, and two Electronic Tracking Network (ETN) Teams are assigned. TMD has activated 243 personnel, 43 vehicles, and nine aircraft. EMAC has activated 30 personnel and four aircraft in support of 25-0025 02JUL Severe Weather. TMD personnel will be assisting with iSTAT and pSTAT damage assessments. Additionally, TMD has activated Chaplains and Behavioral Specialist to support Service Members working the rescue and recovery operations. TMD has made 520 rescues as of July 6. On July 7, TMD activated a Public Affairs Team to provide public information and media relations during disaster response operations.

Texas Parks and Wildlife Department (TPWD):

Texas Game Wardens continue to support statewide response operations related to the severe weather that has affected the State of Texas. Game Wardens remain actively engaged and positioned throughout the impacted regions with Texas Game Wardens staffing the State Operations Center and all activated EOCs. One helicopter is deployed to Kerrville and specialized units including SAR boat teams, UAS pilots, and ATV teams are actively engaged in SAR missions and other assigned duties. Texas Game Wardens in Kerrville are conducting day/night search and recovery missions in collaboration with other ESF 9 partners. As of July 9, TPWD has a combined total of 444 rescues and evacuations. Texas Game Wardens continues to be in communication and working alongside TDEM and other state, federal & local partners through this event.

Texas Department of Housing and Community Affairs

TDHCA is actively supporting the state's response to the severe weather event by supporting its community action agency partners at the local level and coordinating resources with HUD at the federal level.

The following partners are working with local officials to identify and assist impacted households with immediate food/gas/hotel needs.

The Calvary Temple Church, Burnet Community Center, Cross Tracks Church, and Mill Pond Park shelters have been closed.

The ARC has distributed 480 bottles of water, 200 Comfort Kits, 226 cots, and 270 blankets.

The Salvation Army (TSA):

The TSA is supporting feeding operations in Kerr Co. (Calvary Temple - now moved to Hunt), Ingram (City West Church), and Hunt (Crider's). In San Angelo, Hargraves Auto provided meals to first responders and survivors. TSA has provided 3,640 meals and 22,530 drinks.

Southern Baptists of Texas Disaster Relief (SBTC):

SBTC has a Quick Response Feeding Unit (QRU) operational at the First Baptist Church in Kerr Co. On July 6, an IMT, QRU, Chaplains, showers, laundry units, and mud out units arrived in San Saba. SBTC has provided 350 volunteer hours, 269 ministry contacts, and 639 meals.
