FEMA Region 6 Weather Threat Briefing

Thursday, July 10, 2025

Disclaimer: The purpose of this briefing is to provide a **Regional** weather threat assessment and is meant as a general overview. Summary

- **Flash Flooding:**
 - Marginal risk (level 1 of 4) over NE NM, W TX, OK/TX Panhandles, OK, SE LA Friday; N TX, NM, OK and AR on Sunday; and over S NM, E OK and AR on Monday.
 - Slight risk (level 2 of 4) over E NM, TX and OK on Saturday
- **Severe Storms:** Marginal risk (level 1 of 5) over NE NM, TX/OK Panhandles today; E NM, TX/OK Panhandles tomorrow; E NM, OK TX Panhandles, W/NW TX on Saturday
- **River Flooding:** Rivers over TX and NM have receded below minor flood stage, but any localized heavy rainfall will result in quick responses where the ground is saturated.
- **Tropical:** No tropical impacts expected over the next 7 days.

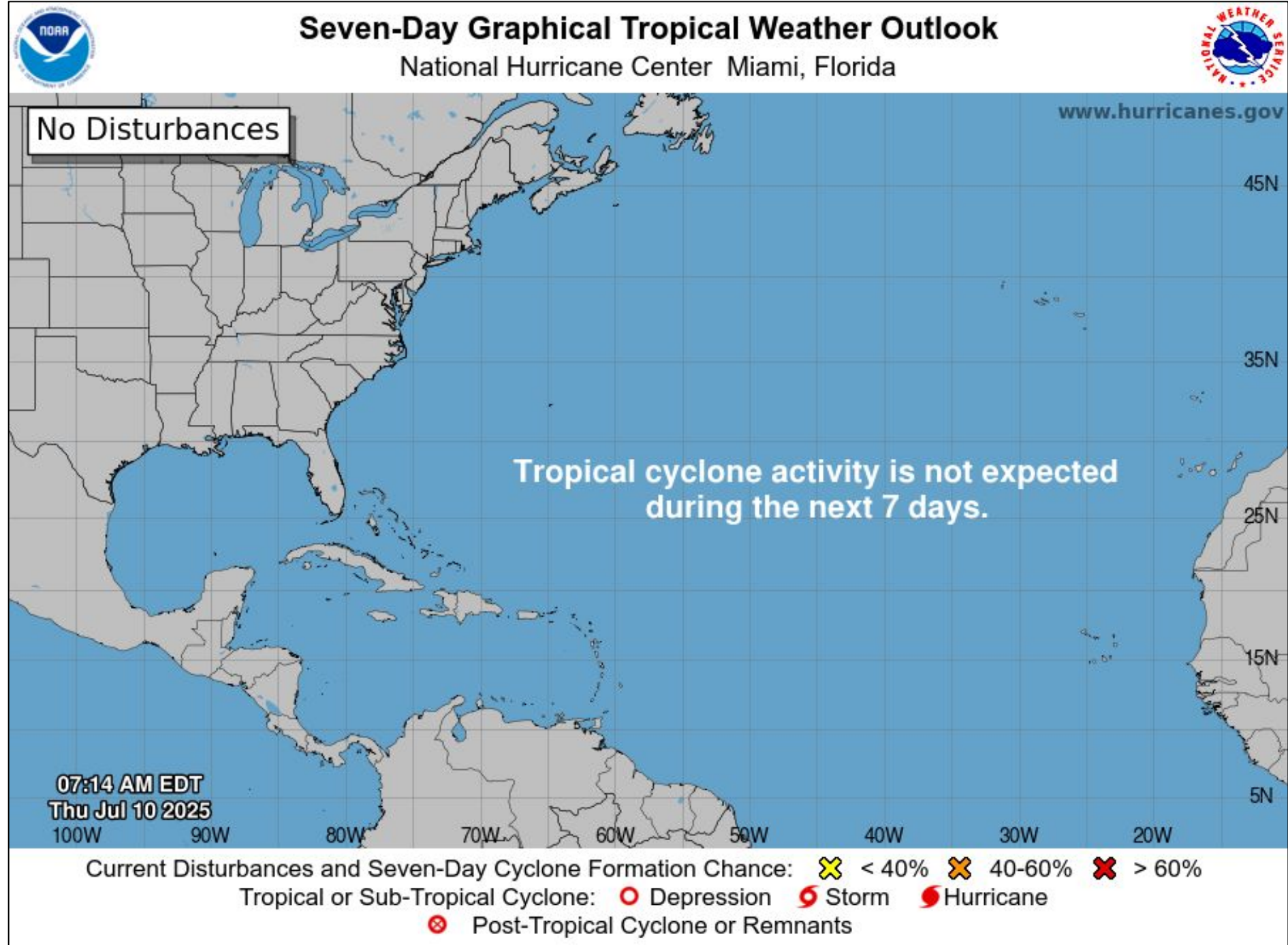

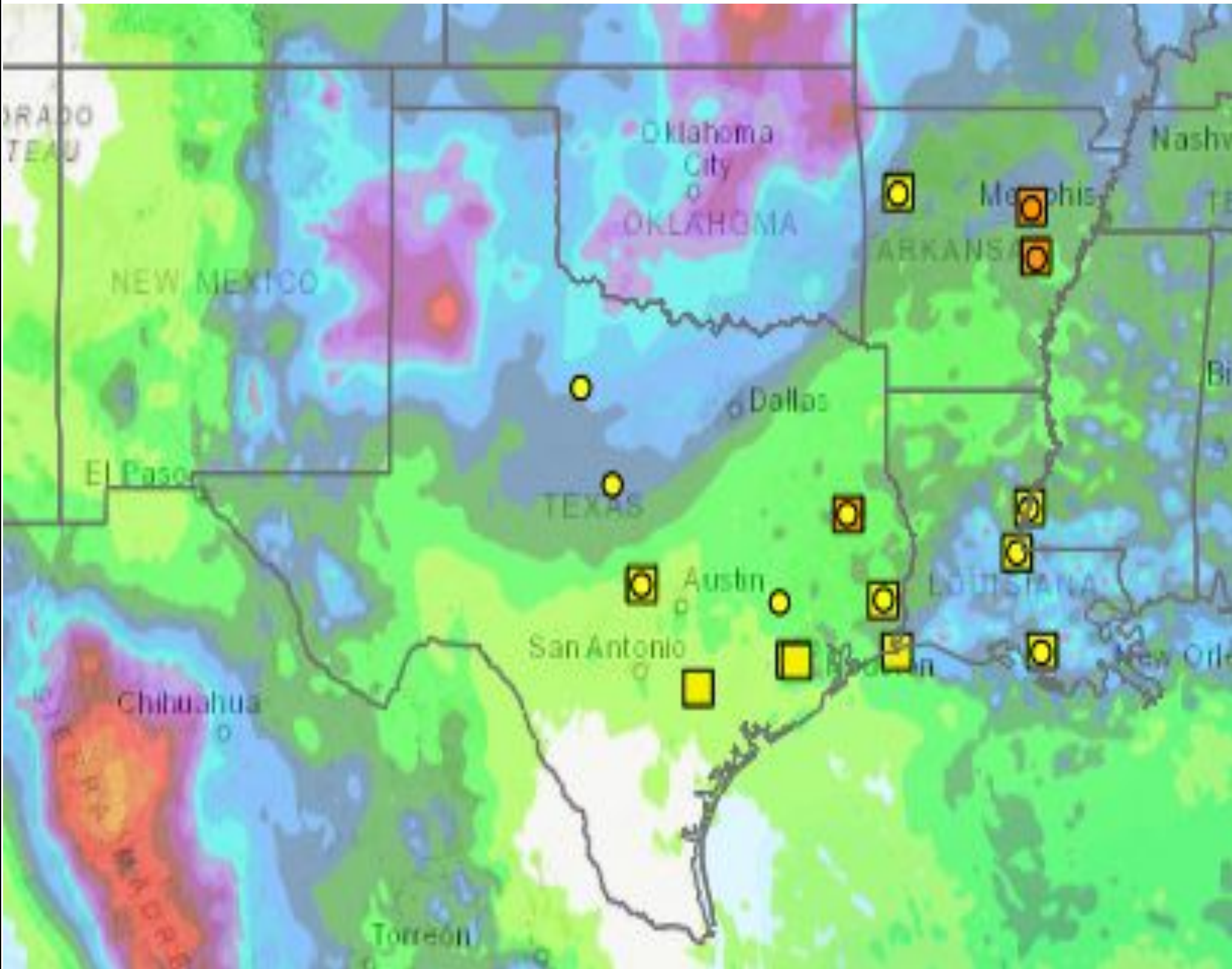

Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall

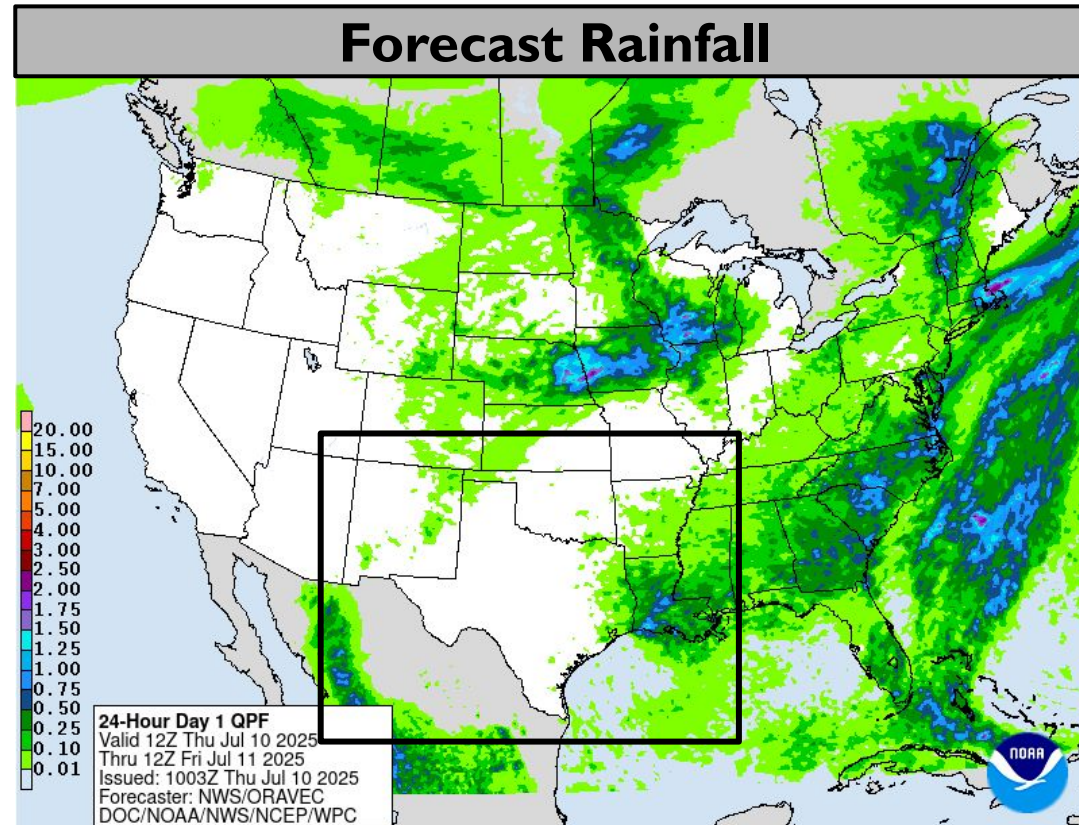
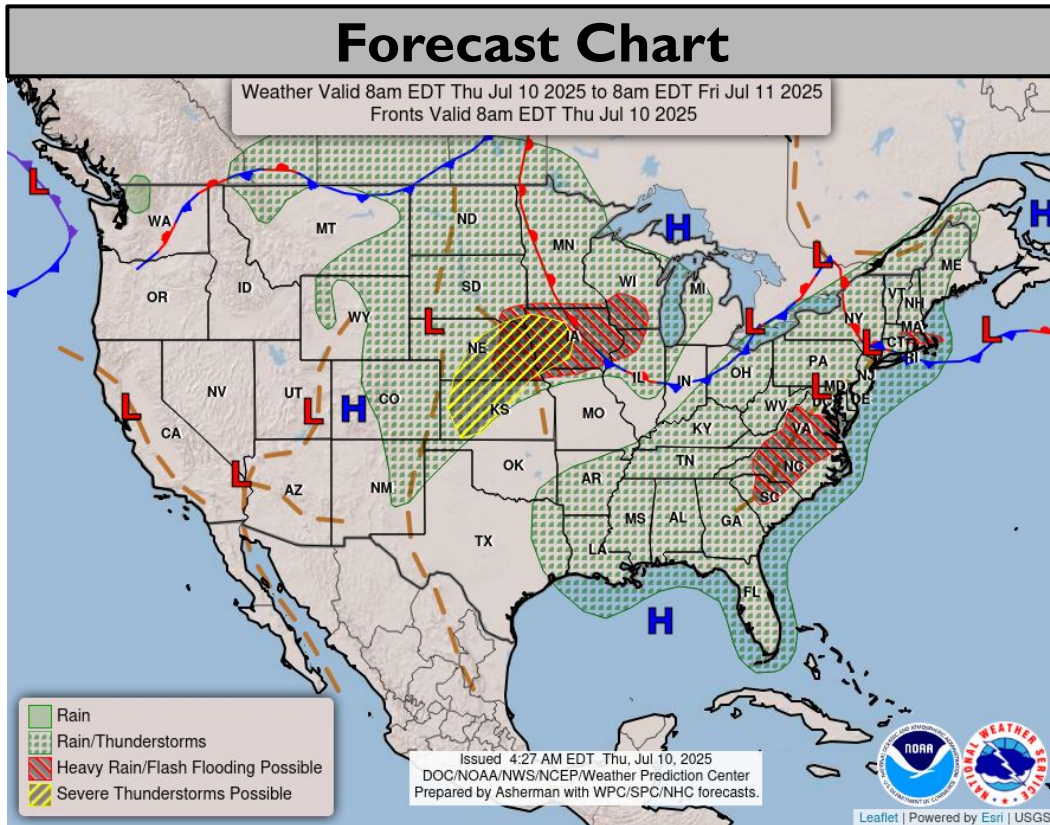


River levels in TX/NM have receded, but localized heavy rainfall could produce quick rises where ground is saturated.

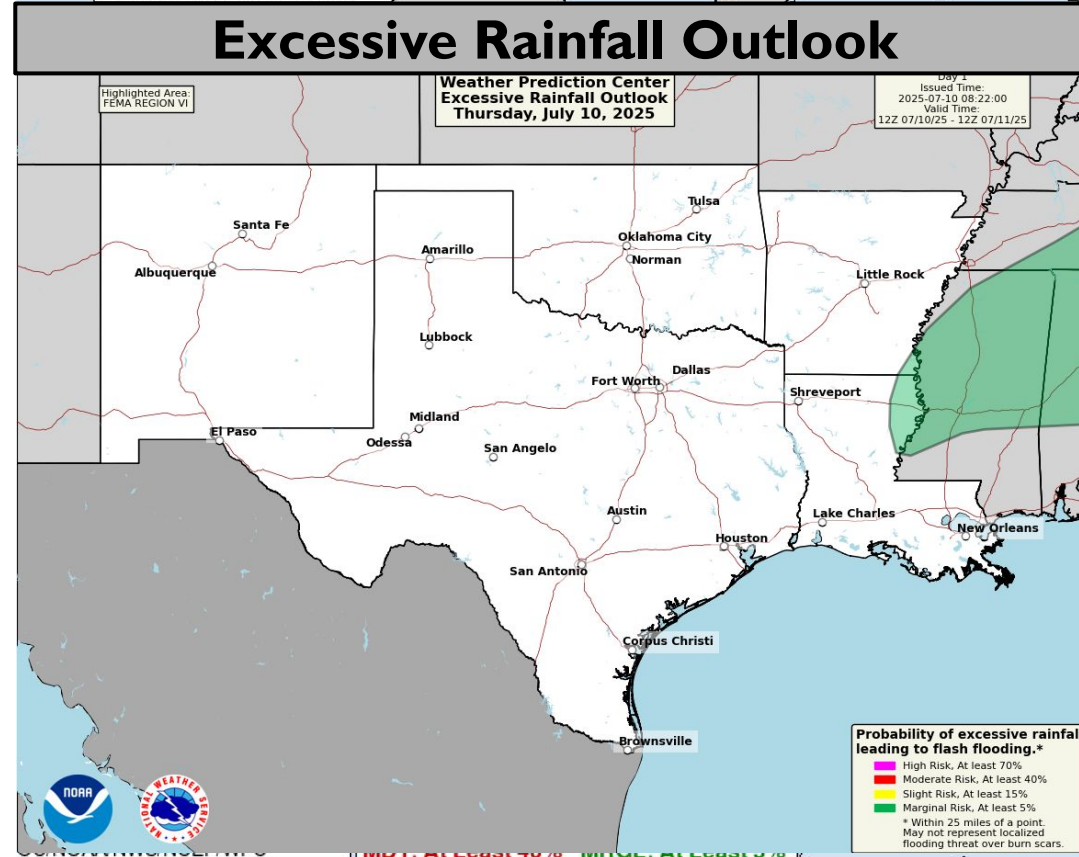
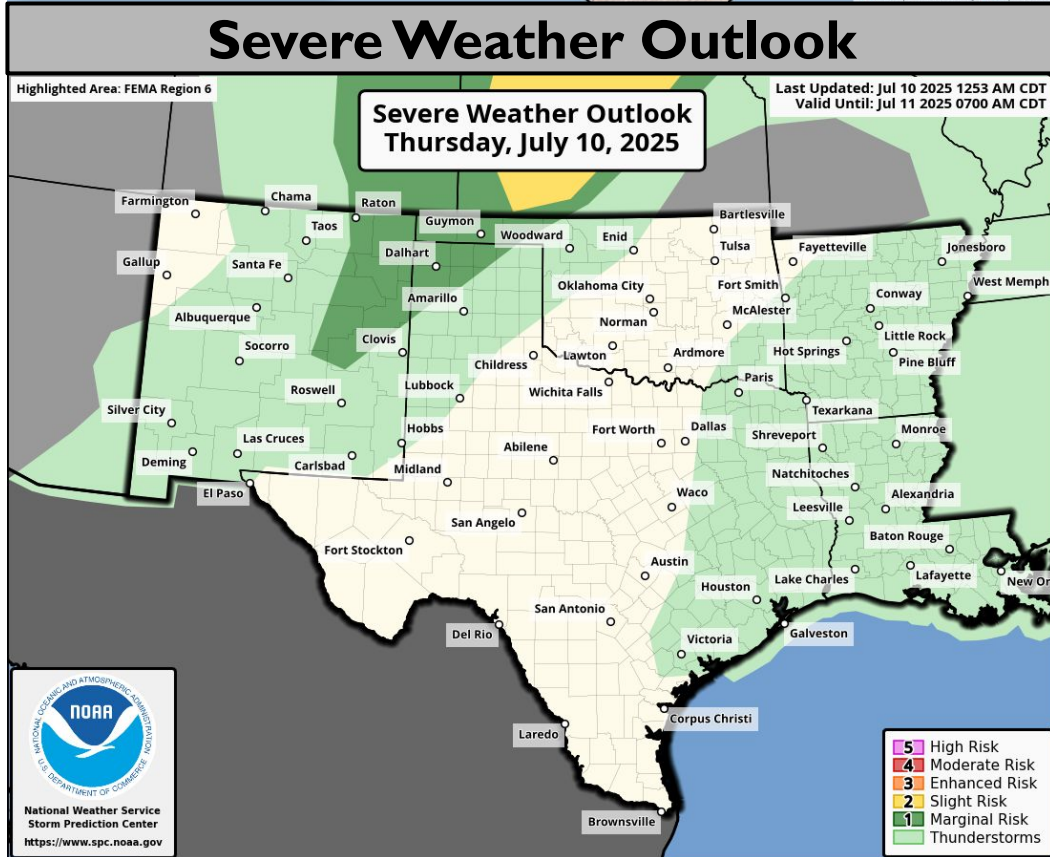

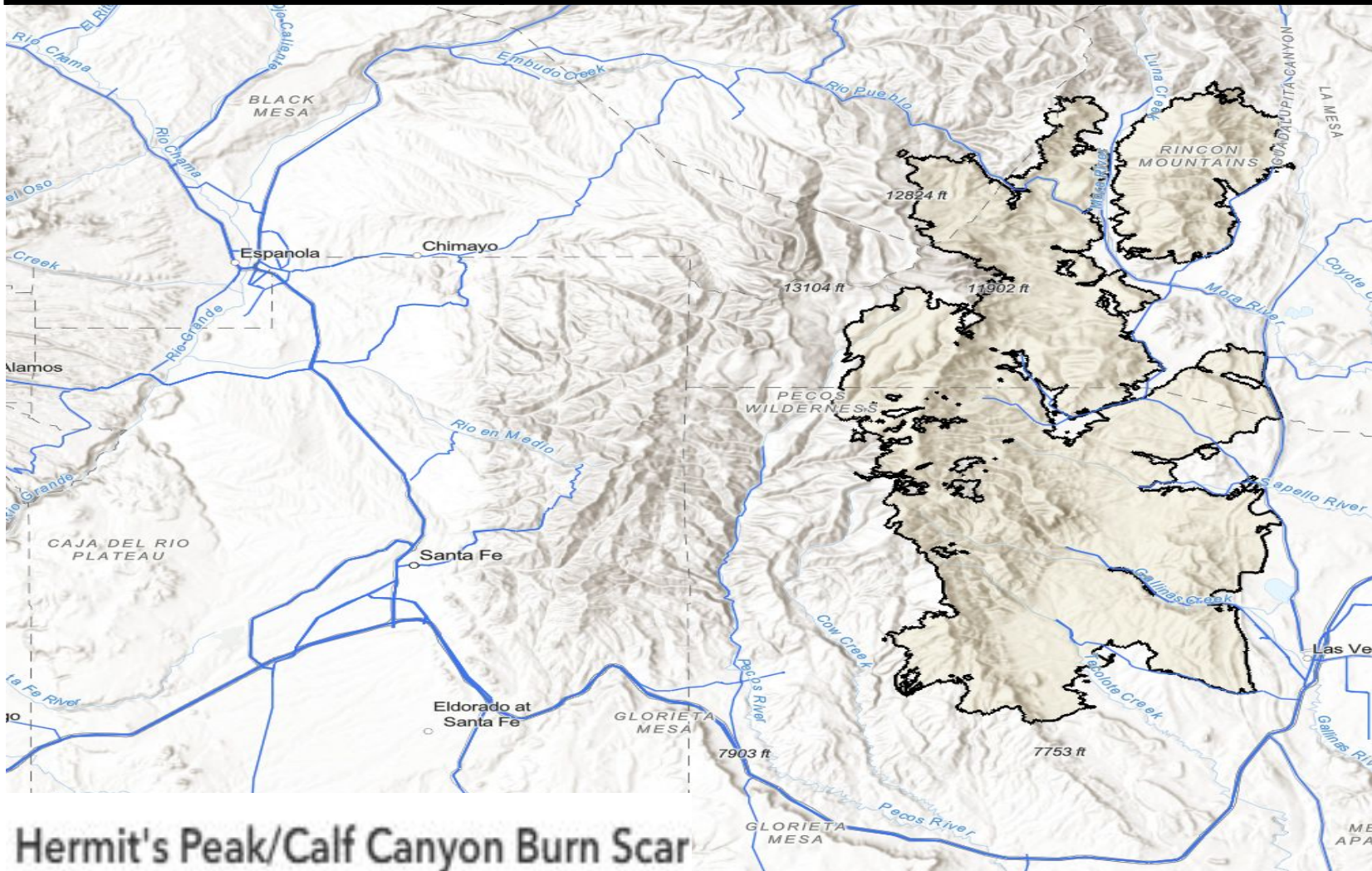




Burn Scar Debris Flow Risk - HPCC Scars New Mexico

Major (level 3 of 4)	Flood Watch Issued OR Debris Flow Probability > 50%
Extreme (level 4 of 4)	Life Threatening Flash Flooding Likely - Historic Type Day

- WPC's Excessive Rainfall Outlook is *Not Applicable* to burn scars.
- *Note* 2nd year burn scars can be more dangerous than year 1.

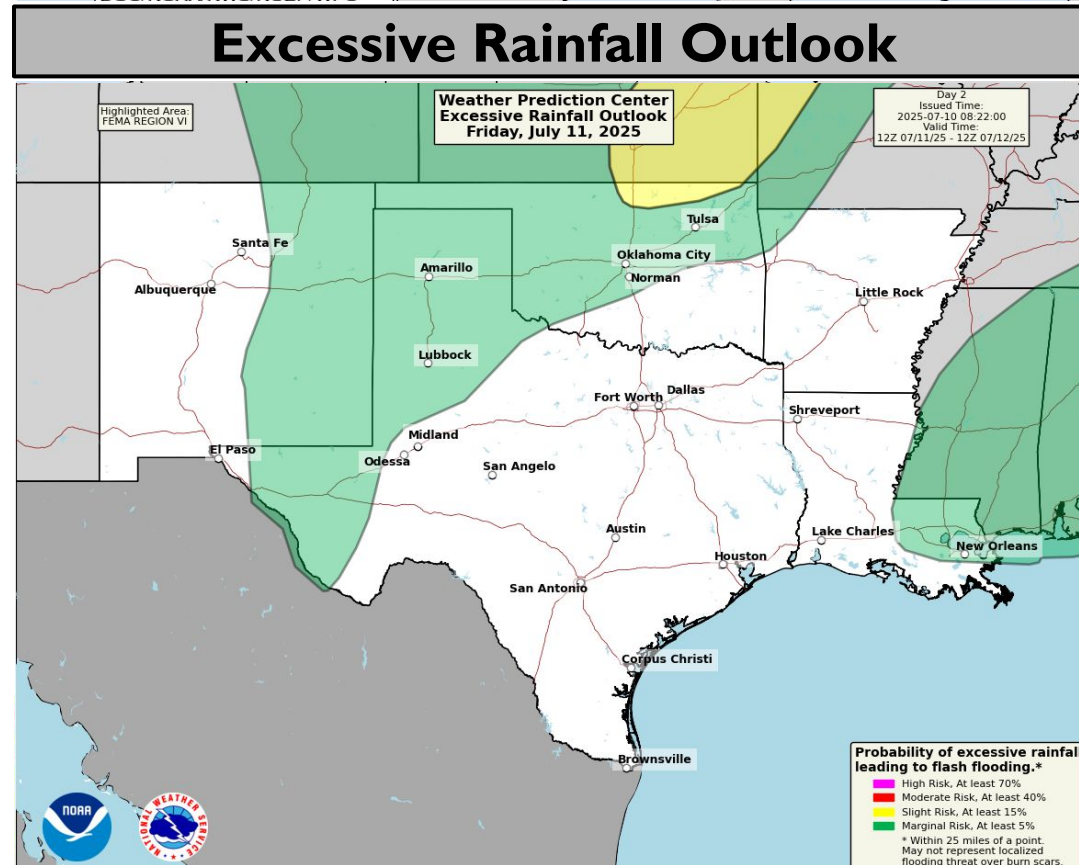
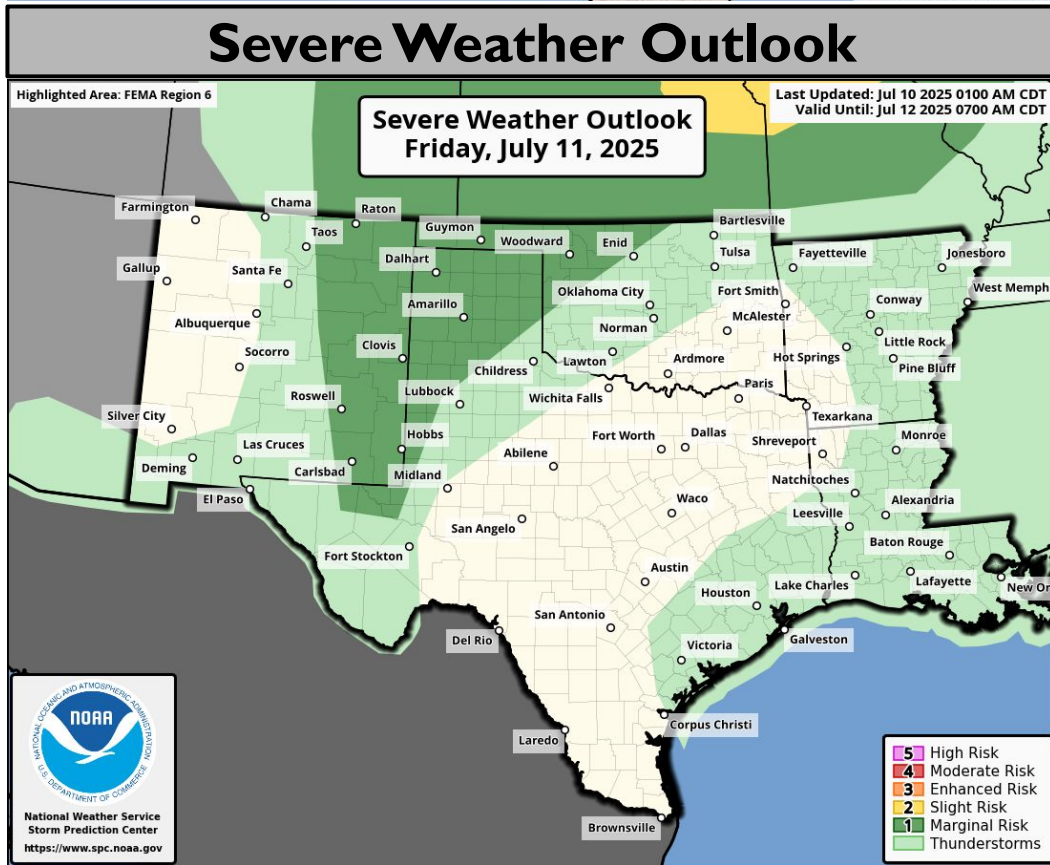

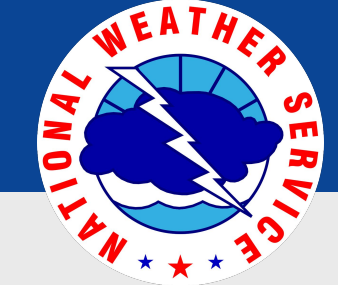


Marginal risk (level 1 of 4) of flash flooding in E NM, W TX, TX/OK Panhandles, OK, SE LA

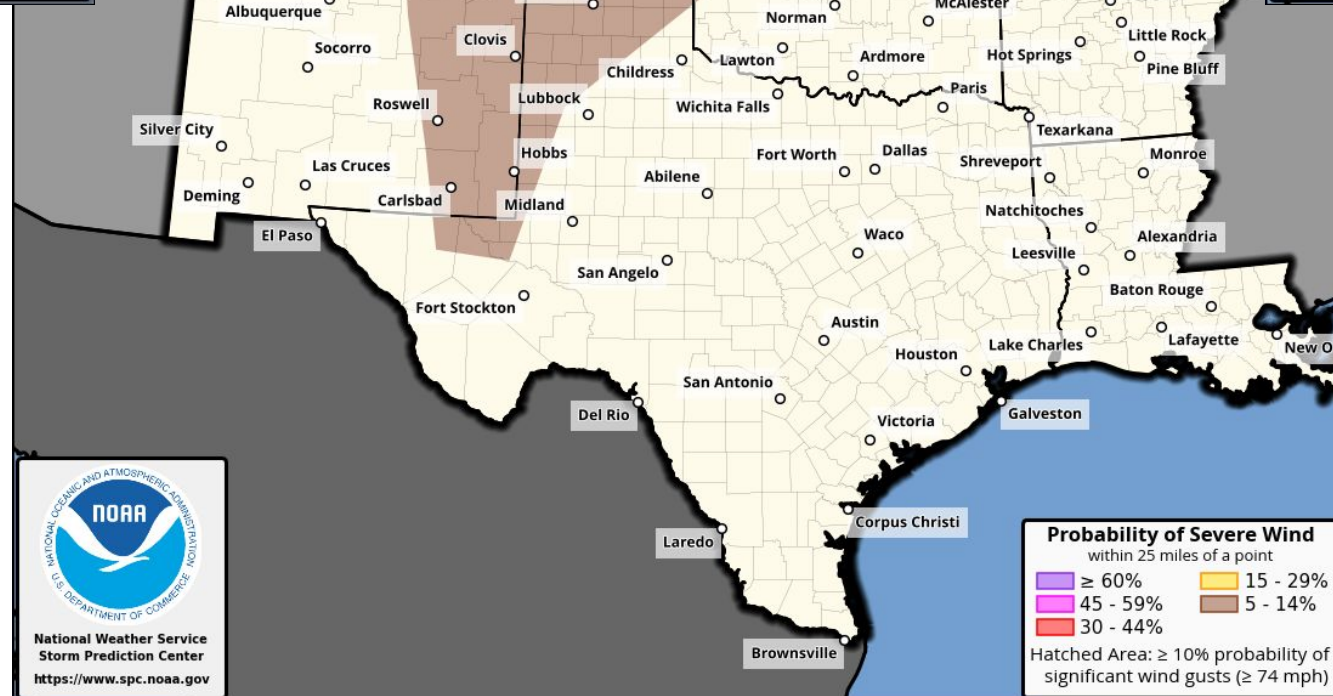
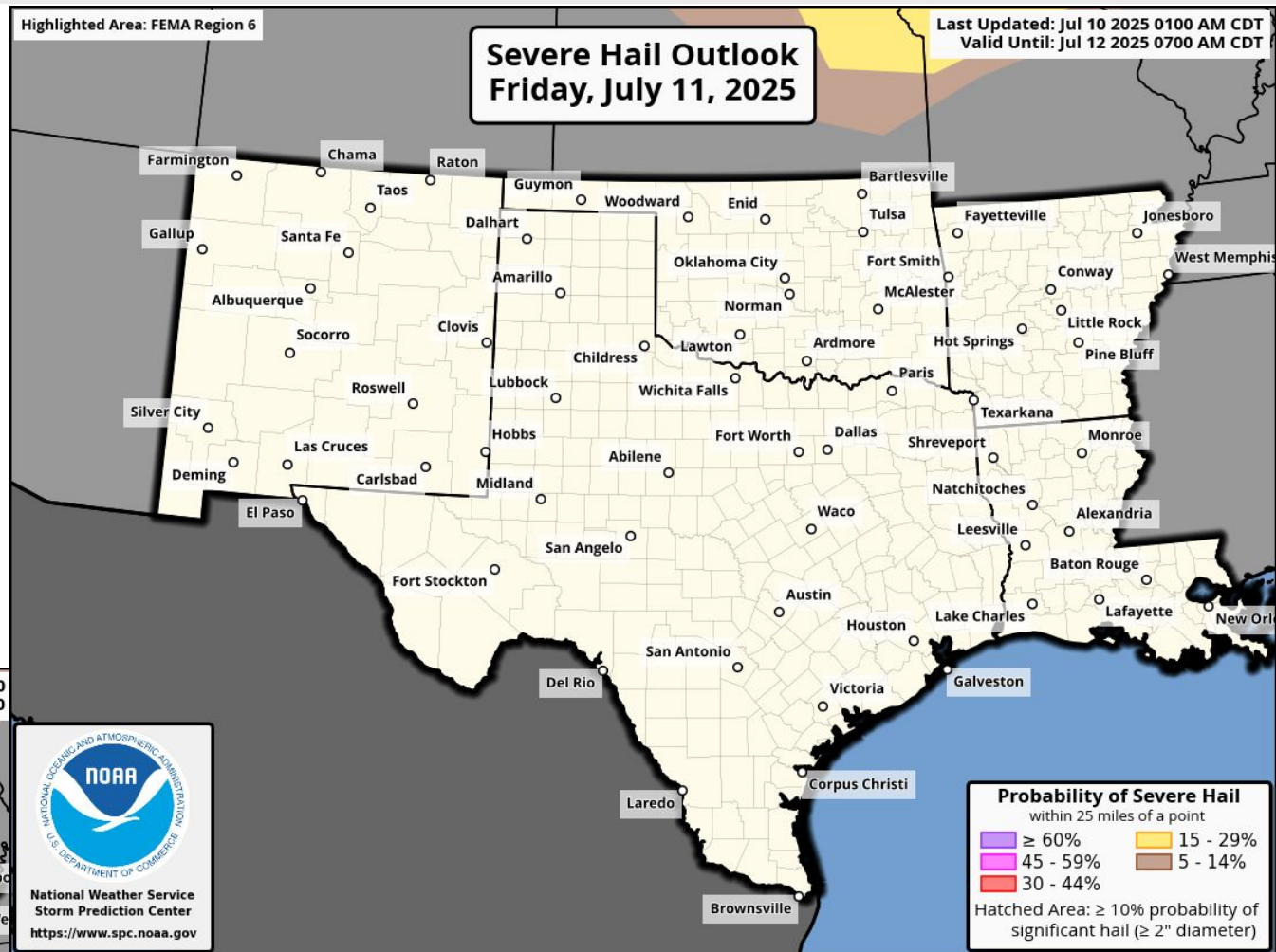
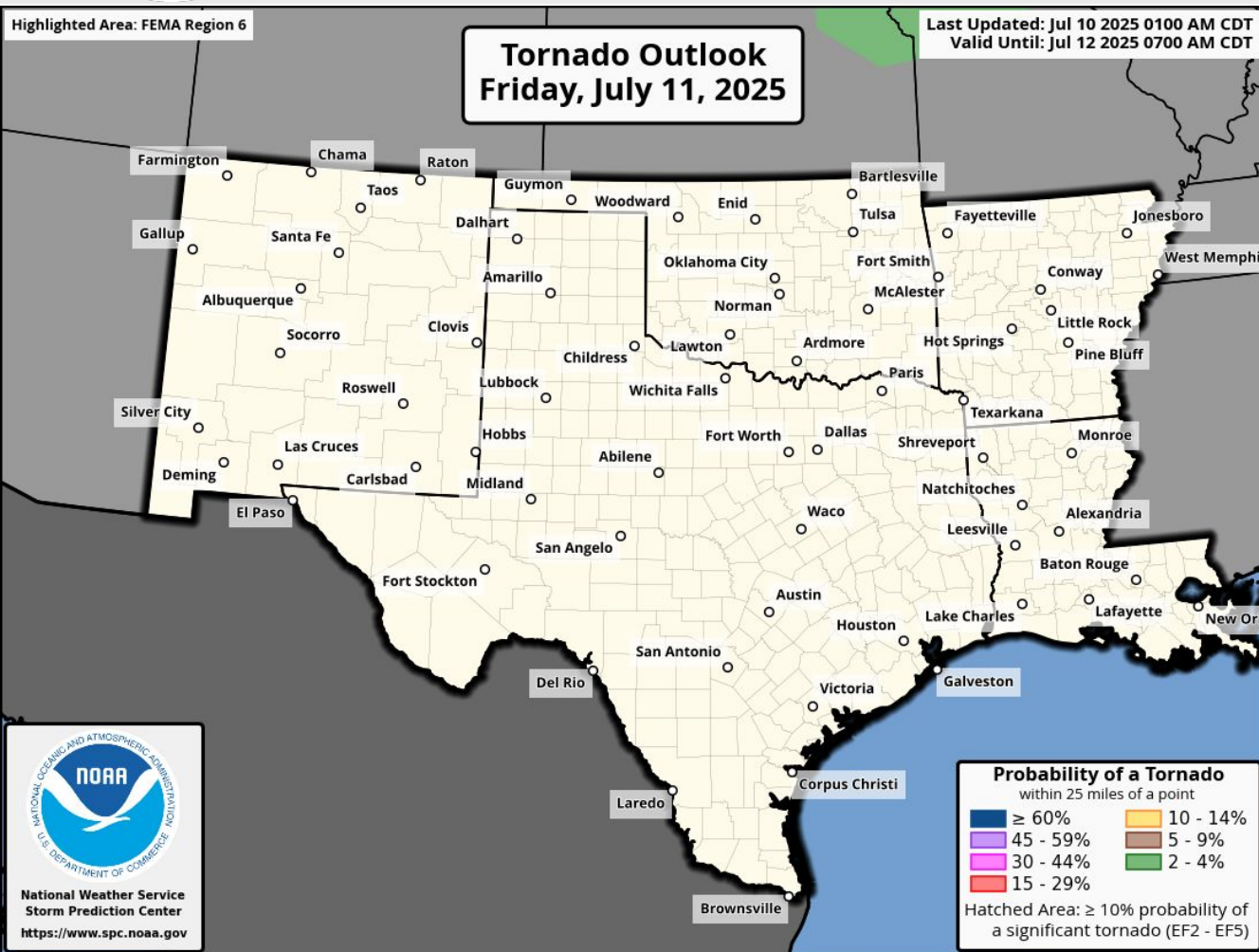
Marginal risk (level 1 of 5) of severe storms for the TX/OK Panhandles and E NM.

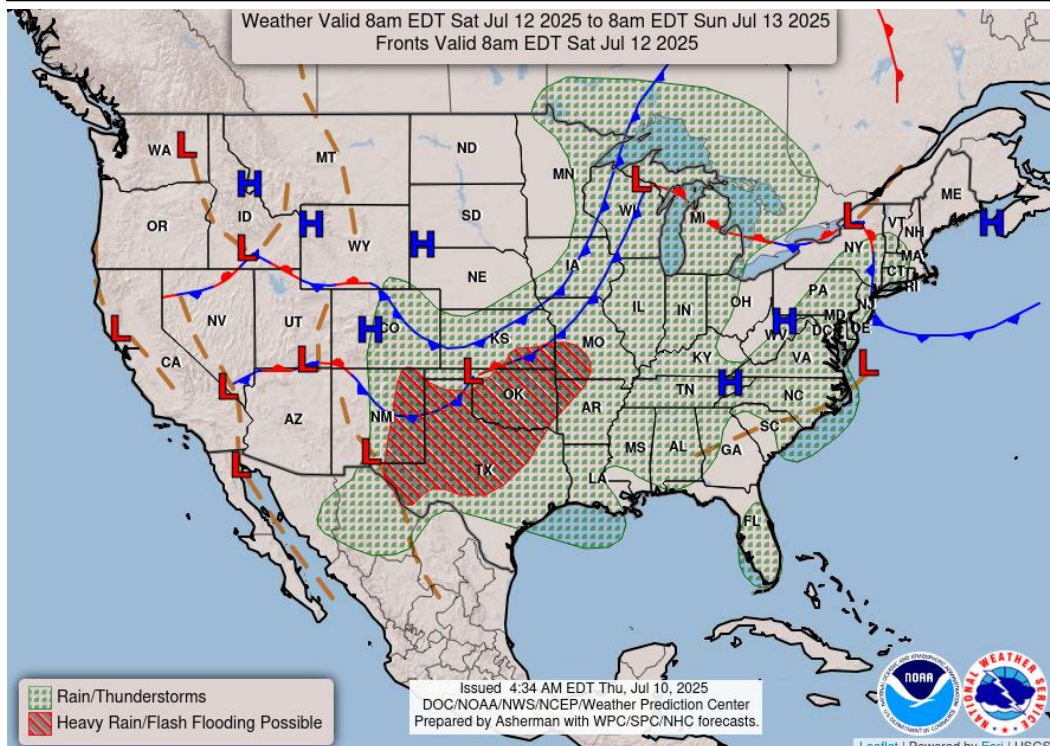
Tomorrow's Tornado & Severe Wind / Hail Probabilities



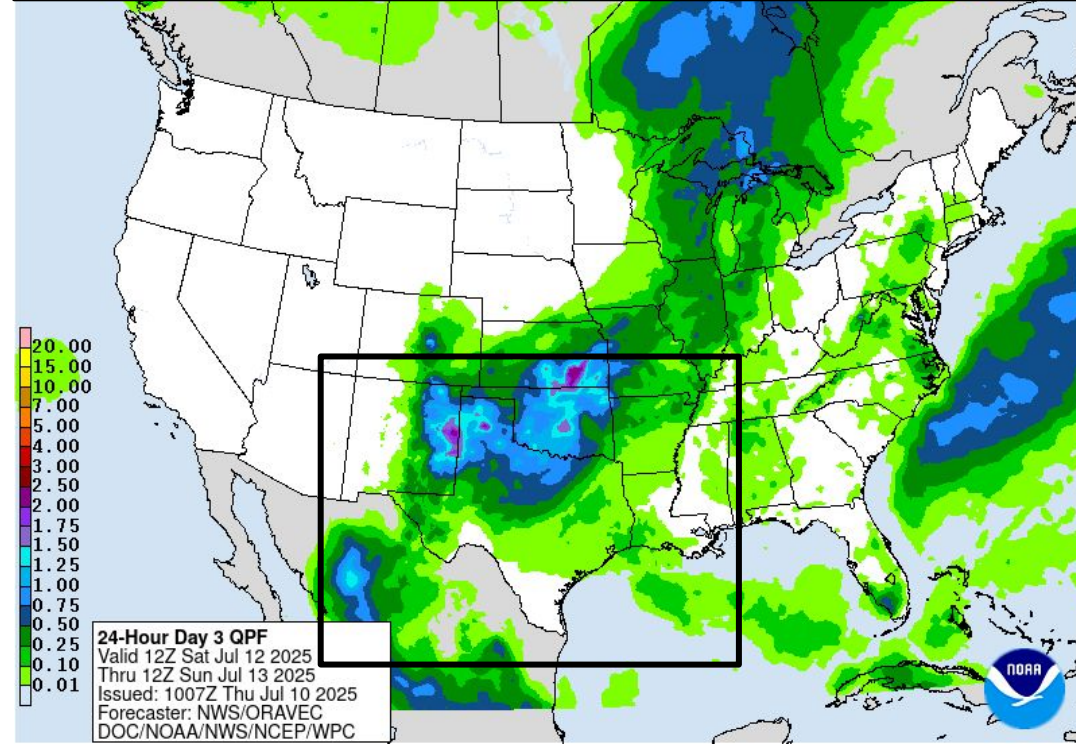

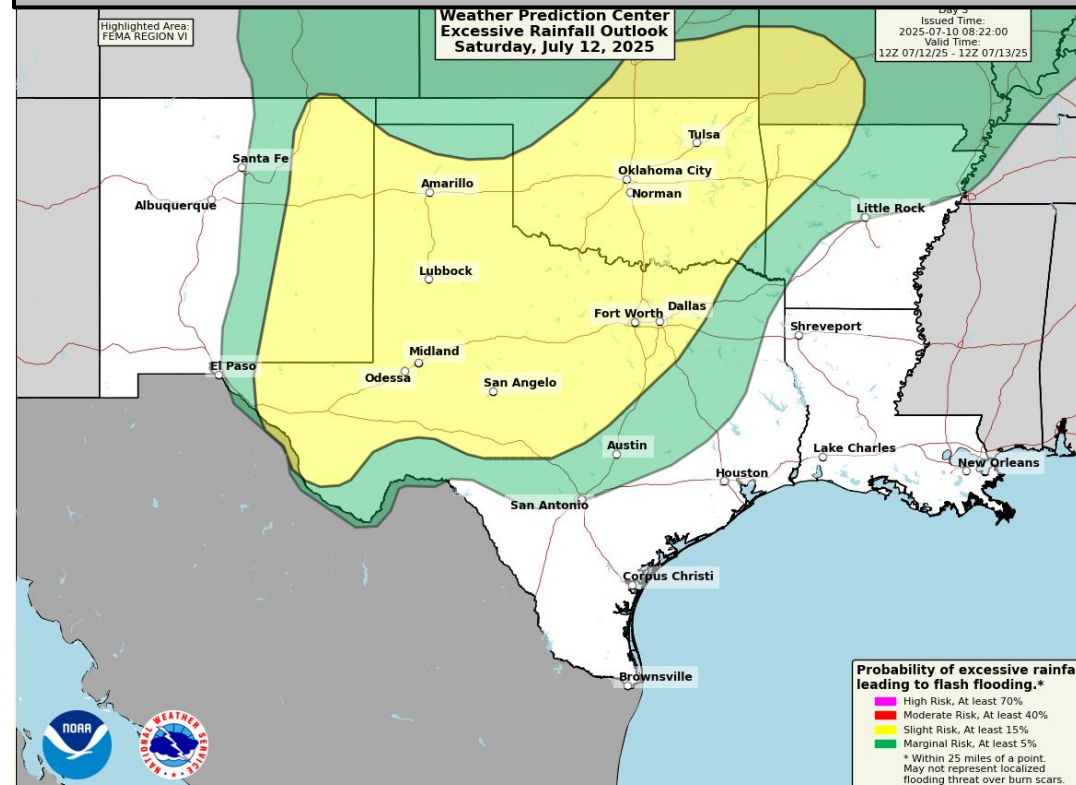

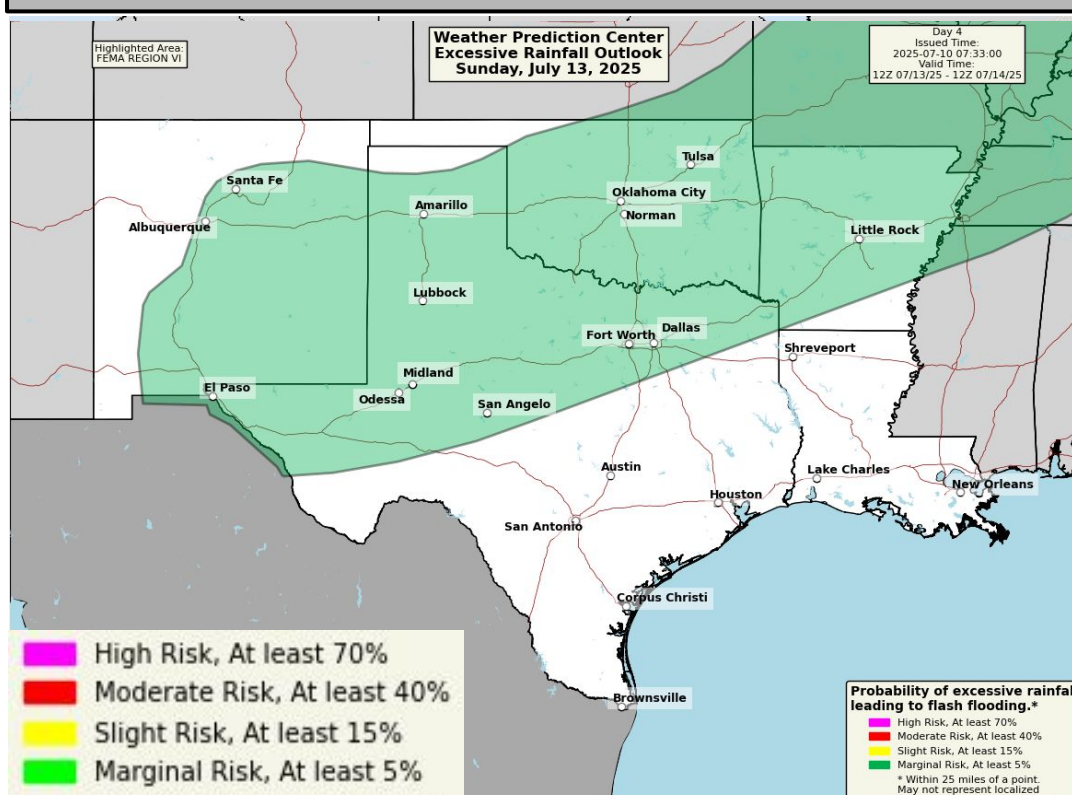


Marginal risk (level 1 of 4) of flash flooding in N TX, NM, OK and AR.

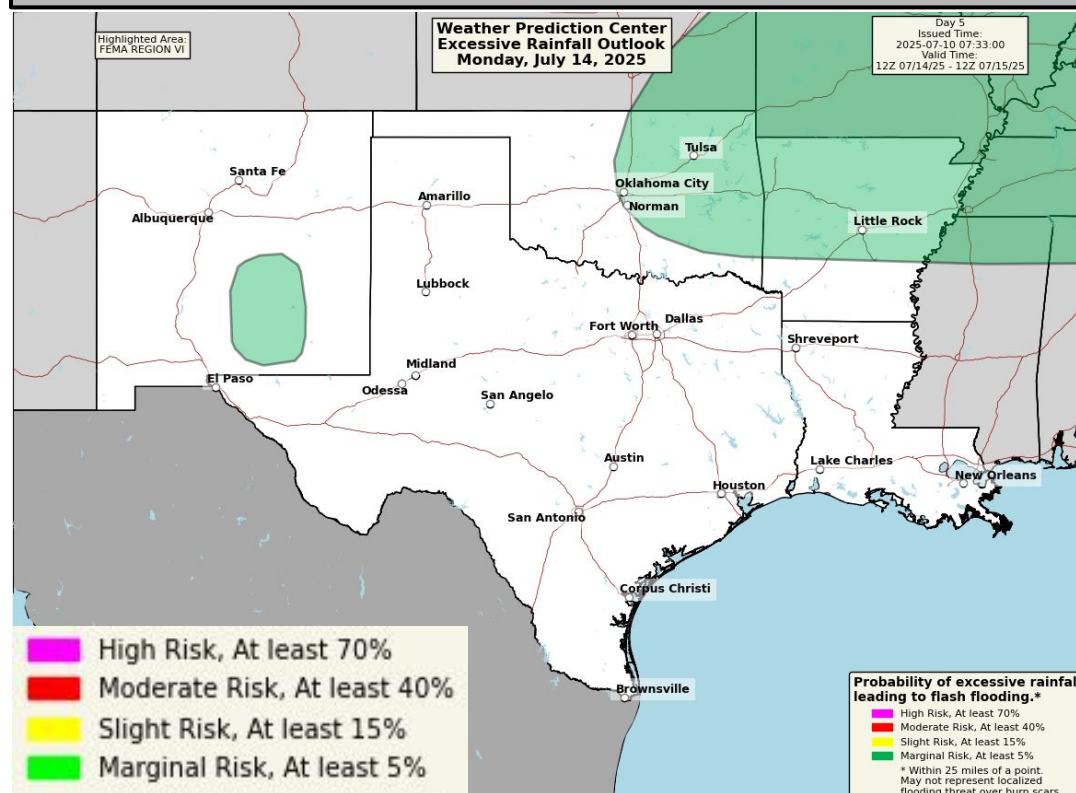


Marginal risk (level 1 of 4) of flash flooding in S NM, E OK, and AR.

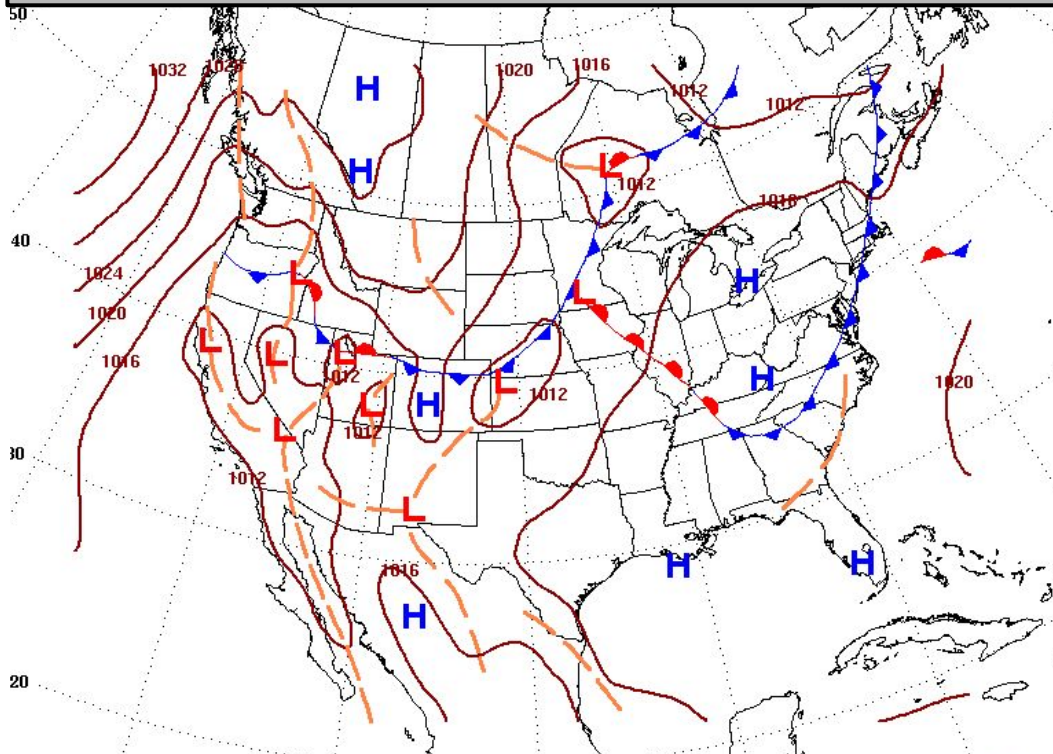
Excessive Rainfall Outlook



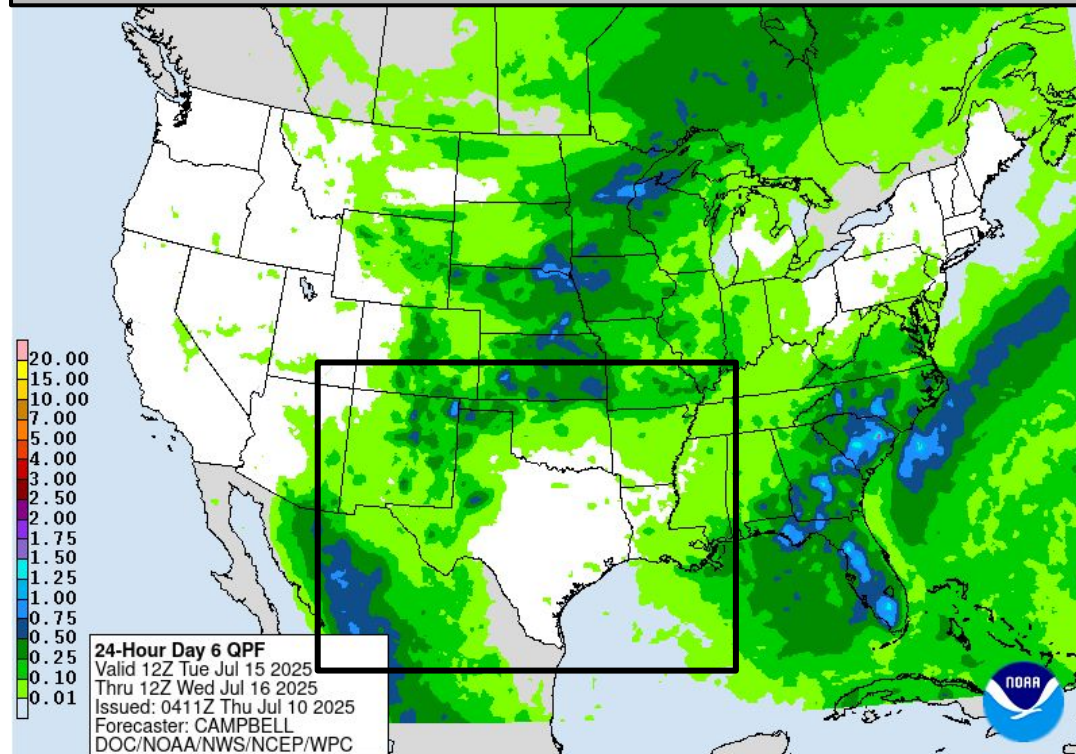
