

# Texas Division of Emergency Management State Situation Report

**STATEWIDE CURRENT SITUATION:** On July 10, Governor Greg Abbott directed the Texas Division of Emergency Management (TDEM) to <u>request</u> additional counties be added to President Donald J. Trump's Major Disaster Declaration for recent catastrophic flooding that began impacting the state last week. Five counties – Burnet, San Saba, Tom Green, <u>Travis</u>, and Williamson – are <u>requested</u> to be eligible for Federal Emergency Management Agency (FEMA) Individual Assistance programs, and four counties – Kendall, Kimble, Menard, and San Saba – are <u>requested</u> to be eligible for FEMA's Public Assistance Program.

A review of damage assessments in Burnet, San Saba, Tom Green, Travis, and Williamson counties shows they exceed federal criteria for disaster assistance and may be eligible for <u>federal programs</u>, which provide financial assistance to assist with qualifying disaster-related expenses. Texans can apply for FEMA disaster assistance online at <u>disasterassistance.gov</u> or by calling 800-621-3362. Additional counties may be added as additional damage assessments are completed in impacted communities.

Additionally, a review of damage assessments in Kendall, Kimble, Menard, and San Saba counties shows they exceed federal criteria for <u>FEMA's Public Assistance</u>
Program, which includes assistance for emergency work and the repair or replacement of disaster-damaged facilities. Additional counties may be added as updated information becomes available.

On July 9, Governor Abbott <u>provided</u> an update on Texas' continued efforts to assist and support Texans and communities impacted by recent severe flooding across the

state.

The State of Texas has deployed over 2,200 personnel and more than 1,200 vehicles and equipment assets. More than 20 state agencies are currently responding to flooding threats across the state.

Texans are urged to continue reporting suspected missing loved ones by calling 830-258-1111 or emailing <a href="mailto:kerrvillemissing@dps.texas.gov">kerrvillemissing@dps.texas.gov</a>.

Members of the public wishing to show their support and help the community can donate through the <u>Central Texas Flood Recovery Fund</u> created by the OneStar Foundation, a 501(c)(3) organization.

Governor Abbott also announced that the Texas Workforce Commission (TWC) is now accepting applications for Disaster Unemployment Assistance (DUA) as a result of recent severe storms and flooding that impacted Texas. Under President Trump's <u>Major Disaster Declaration</u>, workers and self-employed individuals in Kerr County who have been unable to work due to damage sustained from severe weather may be eligible for DUA benefits.

Individuals affected by flooding in the <u>designated area</u> can apply for benefits online through <u>Unemployment Benefit Services</u> or by calling TWC at (800) 939-6631 between 8:00 AM and 6:00 PM, Monday through Friday. Applications for DUA benefits under this declaration must be submitted by September 4, 2025. Individuals should specify that their applications are related to the damage caused by Hill Country flooding.

#### **OPERATIONAL PRIORITIES:**

- Protect life and property.
- Support rapid & effective response.
- Collect and disseminate accurate incident information to improve decision-making.
- Accurately track incident costs associated with assigned resources for cost recovery.

Region 6 (Includes DDs 17, 18, and 24)

DD 18 – New Braunfels (Includes Atascosa, Bandera, Bexar, Comal, Frio, Gillespie, Guadalupe, Karnes, Kendall, Kerr, McMullen, Medina, and Wilson Counties): Level III – (Increased Readiness Conditions)

On July 6, Disaster District Emergency Operation Center (DDEOC) 18 moved to Level II. As of July 7, TEEX PWRT teams are working on lift station issues from Kerrville to Comfort. Damage assessments are ongoing and multiple state agency Critical Incident Stress Management (CISM) Teams are on site. Discussions are on-going regarding Debris Management and establishing temporary debris sites.

#### **Comal County:**

In Comal County evacuations were conducted along river road, below the Canyon Lake

Dam. Heavy rains forced evacuations of lower-lying homes along the Guadalupe River, but residents have been allowed to return home.

# **Guadalupe County:**

In Guadalupe County, eight inches of rain fell early in the morning on July 5. The rain caused flooding along the roadways and eight vehicles were flooded requiring water rescues.

## **Kendall County:**

iSTAT surveys have been completed in Kendall County.

## **Kerr County:**

A family reunification center is located at Trinity Baptist Church on 800 Jackson Road in Kerr Co. The American Red Cross has a shelter located at Calvary Baptist Church on 113 Methodist Encampment Road in Kerr Co. and a medical is located at Kerr Co. First United Methodist Church on 321 Thompson Drive in Kerr Co.

40 Incident Support Task Force (ISTF) personnel are conducting damage assessments in Kerr County. The Volunteer Reception Center has been established and is located at Salvation Army Shelter on 855 Hays Street in Kerr Co.

Donations management is being bolstered with TDEM Incident Support Task Force (ISTF) personnel, and a warehouse has been identified. ISTF has met with Kerr Co. and Kerr County officials regarding debris management, potential locations of temporary debris sites, and search and rescue volunteer operations. ISTF is tracking shelters and reunification centers.

#### Region 8 (Includes DDs 11, 12, 13, and 23)

# DD 12 – Austin (Includes Bastrop, Blanco, Burnet, Caldwell, Fayette, Hays, Lee, Llano, Travis, and Williamson Counties):

On July 5, DDEOC 12 activated to Level III.

Near historic rainfall impacted Travis, Burnet, and Williamson Counties during the night and first responders conducted dozens of water rescues.

## **Burnet County:**

Crews from Travis County extended their response into Burnet County, where they coordinated with local responders, Texas Parks and Wildlife Department, Texas Task Force, and Texas Department of Public Safety boats to rescue dozens of people in Burnet, Marble Falls, and other areas of the county.

Texas Task Force 2 (TX-TF2) assisted with an area wide search in Burnet County on July 7.

#### **Travis County:**

Rainfall started in Travis County with water rescues reported early in the morning hours. Emergency Services Districts (ESDs) and Austin units managed the rescues. The city of Austin requested boat squads at approximately 3:00 AM due to neighborhoods being impacted by fast moving water. Travis County aviation assets worked directly with the SOC to dispatch local and state aircraft to assist TX-TF throughout the day.

Travis County requested a wide area search team to assist with recovery in a neighborhood where fatalities were reported. A Texas Task Force 2 (TX-TF 2) Type 3 team located in Llano was moved to Travis County to meet this need.

#### **Williamson County:**

Flooding in Williamson County started in the Leander area, moved to Liberty Hill and to surrounding cities and communities. An apartment complex was evacuated along the San Gabriel River near downtown Georgetown due to rising waters. Numerous roads are closed in Williamson County due to damage from flooding and water on the roadways, with one railroad bridge destroyed. Several RV parks have been evacuated ahead of rising waters, and some evacuations were conducted with boats.

Texas Intrastate Fire Mutual Aid System (TIFMAS), Emergency Medical Task Force (EMTF), and Texas Division of Emergency Management will begin conducting Individual State of Texas Assessment Tool/Public State of Texas Assessment Tool (iSTAT/pSTAT) surveys in Williamson County.

DD 23 – Killeen (Includes Bell, Coryell, Hamilton, Lampasas, Milam, Mills, and San Saba Counties): Level IV – Normal Operations

## **Hamilton County:**

Hamilton County Sheriff requested assistance from the Oklahoma Task Force Boat Squad for a missing female on the Leon River.

## San Saba County:

San Saba County continues to experience flooding due to the previous heavy rainfall. The San Saba Civic Center shelter has been closed.

#### RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS

# Texas Division of Emergency Management (TDEM): Communications Coordination Group (CCG):

The Texas Department of Public Safety's Office of the Statewide Interoperable Communications (SWIC) has supplied a COML (Communications Unit Leaders), Communications Technician (COMT), and additional personnel for communications coordination support to the IMT. Amateur Radio services have activated local nets, providing backup emergency communication and localized reports. Six Amateur Radio operators are being embedded in search teams conducting operations in Kerr County. Volunteers are from Bexar, Lee, Travis, and Williamson Counties. Federal partners are

monitoring and ready to assist upon request. Finally, the Texas Telecommunicator Emergency Response Taskforce (TXTERT) has provided two call takers and two dispatchers to support the Kerrville Police Department.

As of July 7, there were seven mobile cellular platforms requested, and they are assigned to Kerr, Llano, and San Saba counties. Cellular service is stable. SWIC has supplied a COML to provide communications support.

### **Incident Support Task Force (ISTF):**

ISTF members have been deployed to TDEM Region 5. ISTF Regional Volunteer Agency Liaison (VAL) team is supporting community response and identifying key recovery needs, such as food access, debris removal, and muck-outs. There have been 1,300 requests for Volunteer Organizations Active in Disasters (VOAD) cleanup assistance have been submitted through iSTAT.

On July 5, five ISTF members deployed to the Kerr Co. area. ISTF has members rostered and pending a second wave deployment.

#### Mass Care:

Sheltering:

As of July 8, four shelter sites have a cumulative population of 233 people.

#### Reunification:

Two reunification centers are open:

- Schreiner University
- First United Methodist Church Kerr Co.

## Feeding:

There are nine fixed and mobile sites that have served 6,402 meals. The following partners who are coordinating resources:

- Operation BBQ Relief
- The Salvation Army
- Mercy Chefs
- Southern Baptist Men
- World Central Kitchen
- VOAD

Team Rubicon, Global Empowerment Mission, Convoy of Hope, and ITDRC are supporting efforts with equipment at the reunification centers. Regional VALs are connecting with community and local jurisdiction to coordinate VAL/VOAD Activities.

## Texas A&M AgriLife Extension Service (AgriLife):

One Disaster Assessment and Recovery (DAR) Area Chief is reporting to the IMT. Three DAR agents are assisting the Type 3 VET Team in Kerr County. Eight DAR agents will be staged in Kerr County. Two DAR specialist are responding to the Disaster

Reunification Center (DRC), and three DAR logistics personnel are prepositioned at the Lancer TDEM Warehouse in San Antonio. The AgriLife DAR PIO has been sharing weather safety information via social media channels and is working with other state agency partners on message delivery.

Texas A&M Engineering Extension Service Public Works Response Team (PWRT): On July 10, PWRT members in Kerrville traveled to Hunt to assess damage of the water system with the San Angelo team arriving last night. The PWRT team began pumping operations on the afternoon on July 10 with pumps procured through TDEM Logstics. A member from the Kerrville team will be transitioning to the San Angelo team today. There is one PWRT member who is staffing the SOC, and one staffing the IMT in Kerrville.

On July 9, PWRT members connected with the City of Kerrville staff to address needs. Other members traveled to Hunt to assist the Emergency Management Coordinator and President of the Water Board to address water system issues. A STAR for further assistance at the Hunt Community Water System is on the way to the SOC. A separate team was requested in San Angelo to assist in a water pumping operation. TDEM logistics has been contacted to procure equipment, and all six members will arrive in San Angelo (07/09). One member is staffing the SOC, and one member is staffing the IMT in Kerrville.

On July 7, PWRT members from Team 2 met with the City of Kerr Co. Public Works to identify tasks. The team members then split into three groups. Group 1 traveled to Comfort to assist the Kendall County WCID with a generator repair. Group 2 visited the Surface Water Treatment Plant in Kerr Co. to perform further assessments. Group 3 stayed in the area to assist at Distribution/Collection sites. One member remains as the LNO at the IMT. PWRT continues to staff the SOC for 24 hours.

Texas A&M Engineering Extension Service Texas Task Force 1 (TEEX/TX-TF1): On July 10, Search and Rescue (SAR) personnel and resources continue to conduct secondary searches and rescue and recovery operations on the Guadalupe River in Kerr, Kendall and Comal Counties, and the Sandy Creek area in Travis County. TX-TF1 Swift Water Rescue (SWR) Water Squad (WS) Dallas, WS Fort Worth, and WS El Paso have been demobilized, and WS Wash County has been reassigned to Region 1 for potential flash flooding conditions tomorrow. SAR resources continue to be requested through EMAC and FEMA.

On July 10, resources headed back into the field to begin secondary searches, rescue and recovery operations by land, water, and air. More EMAC and FEMA resources from multiple states including AZ, CA, FL, IN, NV, and WI will arrive to help with the recovery efforts of our fellow Texans. TX-TF1, TX-TF2, and TX-TF3 continue to conduct mission assignments throughout the area of operations, actively conducting secondary searches, rescue and recovery operations in the Kerrville/Hunt area, the Big Sandy Creek area, and assisting local agencies in TDEM Regions 6 and 8.

As of July 8, Search and Rescue (SAR) resources continue to arrive in the area of operations. Swift Water Rescue Boat Squads from Virgina arrived in Austin for check-in and inspection before being assigned in Kerr County. Swift Water Rescue Boat Squads from Florida arrived in Austin for check-in and inspection before being assigned in Kerr

# **Texas A&M Forest Service (TAMFS):**

TAMFS has activated six All-Hazard Strike Teams, 14 Saw Teams, three skid steers, and two mobile command posts. There are three Liaison Officers (LNO's) at the SOC, one LNO and one Staging Area Manager (STAM) with the Incident Management Team (IMT). One PIO was assigned to San Angelo. TAMFS has sent six personnel to assist with logistics and coordination in Disaster District Emergency Operations (DDEOC) 10. The TAMFS Taskforce from Alice transported a Bearcat from Laredo to Kerr County. Five TIFMAS Strike Teams are assisting with search and rescue, and 9-1-1 Backfill in Kerrville. One TIFMAS Strike Team is assigned to Leander. TAMFS has 328 personnel committed to this event.

## **Department of Information Resources (DIR):**

DIR is monitoring the situation using cybersecurity tooling and threat intelligence feeds. No cyber threats related to this weather event have been identified. The Texas.gov homepage banner has been updated to include flood recovery resources and a link to the Kerr County Flood Relief Fund.

# **Public Utility Commission of Texas (PUC):**

As of July 10, overnight thunderstorms in North Texas caused enough outages in the Oncor service territory (DFW area) for them to briefly cross the significant outage threshold. Total outages peaked at about 40k around 9:00 p.m. Oncor was back under 20k outages by 1:00 a.m. As of 3:00 a.m., the Oncor outage count was down to 4,800 and they expect all outages to be restored by the end of day. One Liaison Officer remains assigned to the SOC. PUC has one Liaison Officer (LNO) assigned to the SOC and will support 24-hour operations if needed.

## **Texas Alcoholic Beverage Commission (TABC):**

Twenty-three members of TABC's Special Response Team (SRT) will assist DPS and TPWD in checkpoint, search, and recovery operations. Fifteen SRT members and a victim services coordinator remain on standby and are ready to respond if needed. TABC is actively supporting the state's response to the severe weather event by supporting public safety and disaster recovery efforts.

TABC Special Response Team (SRT) responded to the Kerr Co. EOC to assist with public safety and disaster recovery operations. An Additional SRT remains on standby, and additional law enforcement personnel are available if more are needed.

#### **Texas Commission on Environmental Quality (TCEQ):**

As of July 10, TCEQ is tracking eight drinking water systems that are on a Boil Water

Notice (BWN) serving a population of 43,186. TCEQ has authorized 10 temporary debris management sites with two located in Kerr County.

# Texas Department of Agriculture (TDA):

TDA is staffing 12-hour shifts at the State Operations Center (SOC) to monitor unmet needs in the agricultural community. The free, confidential Agri-Stress Helpline offers 24/7 support via call or text for those experiencing stress or loss. Staffed by trained professionals, it serves the agriculture, forestry, and fishing sectors, providing support and referrals to local mental health resources. So far, it has helped over 285 Texans in 114 counties. Call or text 1-833-897-2474 for assistance.

TDA's Hay Hotline is open for those wishing to donate hay. Donors can register at <a href="https://texasagriculture.gov/Home/Production-Agriculture/Hay-Hotline">https://texasagriculture.gov/Home/Production-Agriculture/Hay-Hotline</a> and will be contacted if requests are received.

TDA's STAR (State of Texas Agriculture Relief) Fund is accepting applications from those who suffered agricultural losses due to the recent weather event. Funds may be used for rebuilding fences, restoring operations, and other disaster-related costs. Applicants in counties included in the Texas Governor's disaster declaration have 90 days from the proclamation date to apply. The deadline is November 4, 2025, at 11:59 p.m. Apply at https://texasagriculture.gov/Home/Production-Agriculture/Disaster-Assistance/STAR-Fund/Severe-Weather.

Through the Emergency Food Assistance Program (TEFAP), TDA food bank contractors distribute USDA-donated food to emergency feeding organizations. Texans can access this food via on-site meals or take-home packages.

#### Texas Department of Public Safety (DPS):

On July 9, San Antonio Commercial Vehicle Enforcement Troopers continue conducting bus inspections at the Lancer Warehouse at the request of TDEM to ensure the safety and readiness of buses designated for transportation operations. Tactical Marine Unit repositioned assets to Travis County assisting TX-TF2 with search efforts.

Texas Highway Patrol (THP) continues to assist with search and recovery efforts. They are conducting traffic control, assisting local law enforcement with emergency calls, and serving as escort teams.

Unmanned Aircraft continue to support partnering agencies in search and recovery efforts. They are conducting mapping overflights for debris piles as they move east (downriver) toward Canyon Lake.

The Criminal Investigation Division (CID) are teamed with SOG conducting recovery efforts. CID personnel are at the morgue assisting Rangers in identification efforts. CID Special Agents are also providing security for local and county officials, and at public meetings.

The Texas Rangers Division is assisting with the collection of DNA samples for transport by AOD to the University of North Texas - Denton for victim identification. Rangers are providing death notifications for identified victims.

The Aircraft Operations Division (AOD) are conducting aerial reconnaissance missions for damage assessments in the area as well as providing flights for officials. Fixed wing aircraft are transporting DNA samples to the University of North Texas - Denton for victim identification.

The Infrastructure Operations Division (IOD) deployed the Sam Houston Command Trailer to the Kerr County EOC. They are supporting local Kerr Co. PD and Kerr County SO with Communication personnel. A 106' radio tower was deployed to Center Point as a repeater to be used amongst search personnel and to communicate with the command trailer

Information Technology (IT) is providing on-site tech support and integrations for critical Frontline systems: TXMAP, TAK, and aircraft video systems.

Intelligence and Counterterrorism (ICT) Division Analysts are collecting, analyzing, and sanitizing information on missing and deceased individuals. They are also assisting with mapping operational routes for DPS assets to enter the impacted area. ICT Communication operators are augmenting emergency call intake from Kerr Co. PD and Kerr County SO.

Victim Employee Support Services (VESS) assisted with death notifications and continue working with the affected families by providing psychological support. They have conducted several debriefings with emergency personnel in the operational area, and more are planned in the coming days.

## Texas Department of State Health Services (DSHS)

On July 10, DSHS continues its mortality surveillance operations. Southwest Texas Regional Advisory Council (STRAC) has deployed two Mortuary Enhanced Remains Cooling Systems to Kerrville. STRAC has deployed two additional morgue trailers to support fatality management operations in Boerne and Kerrville.

Costal Bend Regional Advisory Council (CBRAC) has deployed two morgue trailers to Kerr County, one is in Ingram, and one Kerrville. DSHS Public Health Region (PHR) 8 has deployed one morgue trailer and one Mortuary Enhanced Remains Cooling Systems (MERC) in Kerrville. Texas Mass Fatality Response Team (TMORT) members remain activated and have two members supporting fatality operations at Grimes Funeral Home.

The San Antonio Regional Medical Operations Center remains activated for operations. The Capital Area of Texas Regional Advisory Council Regional Medical Operations

Center was demobilized on July 9. Public Health Region (PHR) 8 has assigned personnel to support Unified Command operations and have activated assets to Kerr County in support of fatality management operations. DSHS deployed a strike team of two morgue clerks to Kerrville (Grimes Funeral Home) to manage the chain of custody of decedents, handle intake and release, and ensure family and funeral home verifications are completed.

DSHS is supporting a first responder vaccine clinic at the RELLIS Staging Area (RSA) with Hepatitis A and Tetanus, Diphtheria, Pertussis (TDAP) vaccine, and cold storage capability which will begin on July 10. The total responders vaccinated is 54 Tdap and 54 Hep A.

Emergency Medical Task Force (EMTF) stood up operations of one Type VI Mobile Medical Unit (MMU) unit, one Type IV Air Medical Strike Team (AMST), and one Overhead Team in Kerr County on July 9. EMTF has activated a Peer Support Team to provide peer support and Critical Incident Stress Management (CISM) to providers in mitigating potential mental health issues.

On July 9, Public Health Region 8 assigned personnel to support Unified Command operations and have activated assets to Kerr County in support of fatality management operations. Additionally, a Sanitarian from PHR 8 is deployed to assist at the Unified Command. On July 10, DSHS is supporting a first responder vaccine clinic at the RSA with Hepatitis A, Tetanus, Diphtheria, Pertussis, and vaccine coolers. EMTF stood up operations of [1] Type IV MMU unit and [1] Type IV AMST, and [1] Overhead Team in Kerr County on July 9. The Type IV MMU trailer operations will move into a larger unit and begin 24/7 operations on July 11. Emergency Medical Task Force (EMTF) activated a Peer Support Team to provide peer support and critical incident stress management to assist active providers in mitigating potential mental health issues.

## **Texas Department of Transportation (TxDOT):**

As of July 7, TxDOT has 34 locations on state-maintained roads impacted by floodwater, with nine closed due to highwater and 25 are closed due to damage.

As of July 6, TxDOT has 36 locations on state-maintained roads impacted by floodwater, nine are closed due to highwater, and 21 are closed due to damage. TxDOT crews have been monitoring roads, clearing debris, cleaning drainage areas, and providing traffic control. State Highway (SH) 29 in Burnet County has reopened, and temporary main-lane closures were in place the last several days to provide egress to firefighting equipment. TxDOT crews and emergency staff are rostered and are on standby to respond. TxDOT has 24/7 staffing in the SOC.

# **Texas Emergency Medical Task Force (EMTF):**

The following EMTF Resources are activated across the state:

EMTF 7 - one Severe Weather Package (SWX PKG) in Kerr Co.

- EMTFs 2 and 9 have one SWX PKG in Llano
- EMTF 11 has one SWX PKG in Leander
- EMTF 6 has one SWX PKG in Leander
- EMTF 4 has one SWX PKG in San Antonio staged at the Lancer Warehouse in San Antonio
- Two MISTs at the SOC with SCO
- One MIST at the RELLIS IMT
- One MIST at the Kerr Co. IMT
- Six TMORT personnel in Kerr Co.
- Three SWX PKGs are on standby (EMTFs 1, 2, 6)

SWX Activation Totals: 2,505 encounters, 80 treated, 60 transported

## Texas Health and Human Services Commission (HHSC):

On July 10, HHSC disaster behavioral health staff embedded at Unified Command continue to coordinate and support the First Responder Assistance Center (FRAC) and Family Assistance Center (FAC). The Central Texas Flooding Emotional Support Line went live at 8:00 AM. Texans statewide can call 833-812-2480 to connect with support. FEMA granted funding for HHSC to operate the Other Needs Assistance (ONA) program. One HHSC staff member remains in place at the DRC in Kerrville.

On July 9, a four-person HHSC Disaster Behavioral Health team relieved the initial team at the Unified Command in Kerrville. Staff continue to coordinate and support behavioral health services to the First Responder Assistance Center (FRAC) and Family Assistance Center (FAC).

HHSC Emergency Management deployed one Other Needs Assessment (ONA) staff to the DRC for today's opening. HHSC EM has designated staff in place to support ongoing DRC operations.

## **Texas Military Department (TMD):**

On July 9, TMD activated Search and Extraction (SAE) MRP and Fatality Search and Recovery (FSRT) MRP to provide support for search and recovery operations.

As of July 8, TMD received four UH-60 aircraft and crew from Arkansas National Guard via EMAC to assist in transporting stranded persons in the impacted Hill Country. TMD activated North Dakota Air National Guard MQ-9 operators supporting Texas Remote Piloted aircraft through an EMAC.

TMD has activated (8x) Ground Transportation Platoon MRPs, (2x) Ground Transportation Company Headquarters, (1x) Battalion Mission Command, an Air Operations Center MRP, (3.5x) Rotary Wing Medium MRPs, a Rotary Wing Heavy (-) MRP, a Tactical Air Control Party (TACP), (1x) General Support Unit (GSU), (2x) ETN Teams conducting damage assessments, a Remote Piloted Aircraft, and a SOC Support Team in support of our State Agency partners Texas Division of Emergency

Management (TDEM), TX-Task Forces 1 & 2, and Department of Public Safety DPS Marine Unit in response to severe flooding in parts of Central Texas. TMD has activated 280 personnel, 47 vehicles, and 9 aircraft. EMAC has activated 31 personnel and 4 aircraft in support of 25-0026 02JUL Severe Weather.

# **Texas Parks and Wildlife Department (TPWD):**

As of July 10, TPWD has a combined total of 444 rescues and evacuations. Game Wardens continued conducting hasty searches further down river in corridors 95-98 and secondary searches in corridors 64-67. Items of interest were located and turned over to Kerr County Sheriff's Office.

One helicopter is deployed to Kerrville and specialized units including SAR boat teams, UAS pilots, and ATV teams are actively engaged in SAR missions and other assigned duties. Texas Game Wardens in Travis and Williamson Counties are actively engaged in Search and Recovery Missions in collaboration with TX-TF 2 in the Sandy Creek area.

# **Texas Department of Housing and Community Affairs (TDHCA):**

TDHCA is actively supporting the state's response to the severe weather event by supporting its community action agency partners at the local level and coordinating resources with HUD at the federal level.

The following partners are working with local officials to identify and assist impacted households with immediate food/gas/hotel needs.

# American Red Cross (ARC):

The ARC has provided mass fatality care services in Kerr County to families of the deceased and initiated Integrated Care Condolence Teams (ICCT) for July 11. A shelter resident transition (SRT) has been initiated for shelter decompression in Kerr County. Staff locations have been identified in every impacted county for Mobile Community Outreach Teams (MCOT). Mobile Disaster Emergency Services (DES) are in Tom Green County. Relationship Managers contacted all emergency management partners to provide updates and confirm new mission requests across 15 counties without activated EOCs.

Personnel are staffed for EOCs in the City of Kerrville, City of San Angelo, Travis County, and SOC. Detailed damage assessment (DDA) were conducted in Burnet, San Saba, Tom Green, Travis, and Williamson Counties that will end July 12.

The ARC has distributed 480 bottles of water, 200 Comfort Kits, 226 cots, and 270 blankets.

## The Salvation Army (TSA):

The TSA is supporting feeding operations and Emotional and Spiritual Care in Ingram (City West Church). In Kerrville, the San Antonio Canteen is stationed at the Wal-Mart providing drinks, snacks, and distributing relief supplies. In San Angelo, the canteen stationed at Hargraves Auto, provided meals to first responders and survivors. The San Antonio RRU is roving throughout Hunt to continue service. A volunteer reception center is set up in the Kerrville Social Services Building. The Big Lake RRU is roving affecting neighborhoods to provide food, hydration, and snacks. To date, TSA has provided 4,853 meals and 32,366 drinks.

# **Southern Baptists of Texas Convention Disaster Relief (SBTC):**

SBTC has a Quick Response Feeding Unit (QRU) operational at the First Baptist Church in Kerr Co. On July 6, an IMT, QRU, Chaplains, showers, laundry units, and mud out units arrived in San Saba. SBTC has provided 1,650 volunteer hours, 343 ministry contacts, and 997 meals.

#### **Texans on Mission (TXM):**

TXM deployed chaplains and assessors to Kerrville on July 6. TXM was able to purchase and distribute dehydration medications for horses. There have been 48 work orders processed with 40 remaining. TXM have worked 1889 hours, distributed 324 meals, and completed 26 assessments.
