FEMA Region 6 Weather Threat Briefing

Tuesday, July 22, 2025

Disclaimer: The purpose of this briefing is to provide a <u>Regional</u> weather threat assessment and is meant as a general overview. County/Parish decision makers should consult their local NWS forecast offices for the latest detailed, local weather information.

• Flash Flooding:

- Slight risk (level 2 of 4) for NM, Far W TX today.
- Marginal risk (level I of 4) for NM,TX/OK Panhandles, SE LA tomorrow; in NE NM, NW OK, S LA Thursday; and SETX, S LA Friday.
- Burn Scar flash flooding in NM: Moderate to major risk (levels 2-3 of 4) through Wednesday with minor to moderate (levels 1-2 of 4) risk Thursday. Minor risk (level 1 of 4) Friday.
- <u>Heat:</u> Heat advisories over E OK, AR, LA, ETX today, with an Extreme Heat Warning for heat index temperatures of II0-II5 F over portions of AR and LA. Heat is expected to increase across the Region this week and into the weekend.
- <u>Tropical</u>: The disturbance over the Tropical Atlantic now has a near 0% chance of development in the next 48 hours, and the next 7 days. No impacts to FEMA 4 are expected.





Rainfall rates of 1-2" per hour in the most intense storms.








Watches, Warnings, and Advisories

Heat Advisories for E OK, AR, E TX, and LA today. Temps feel as hot as 105-110 F. Extreme Heat Warnings in portions of AR and LA. Temps feel as hot as 110-115 F.


Flood Watch for NM from I PM CDT through II PM CDT, including Burn Scars. Rainfall rates of I-2 inches per hour may trigger debris flow flooding.















Heat Risk across much of FEMA 6.


Monitoring for heavy rainfall in NM,AR, LA.






