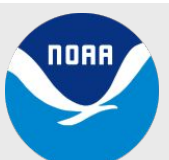

Summary

- **Heat:** Eastern portions of **FEMA 6** will be experiencing dangerous heat through the week, with the highest risk for heat-related impacts in **E AR** and **E LA** through **Wednesday**. Heat eases by the end of the week.
- **Flash Flooding:**
 - **Burn Scar** flash flooding peaks today in **NM** with **Major** risk (level 3 of 4) then back to **Moderate** (level 2 of 4) through **Thursday**.
 - **Marginal** risk (level 1 of 4) for flash flooding for **NM/Far W TX** through most of the week. **Slight** risk (level 2 of 4) for the **TX/OK** Panhandles on **Thursday**. Precip in **S LA** starting **Tuesday** has a marginal risk, but may rise to slight.
- **Tropical:** No tropical impacts expected in **FEMA 6** over the next **7** days.

Isolated minor river flooding in E AR is forecast to recede by the end of the week. Rural secondary crossings, roadways, and croplands will be flooded.

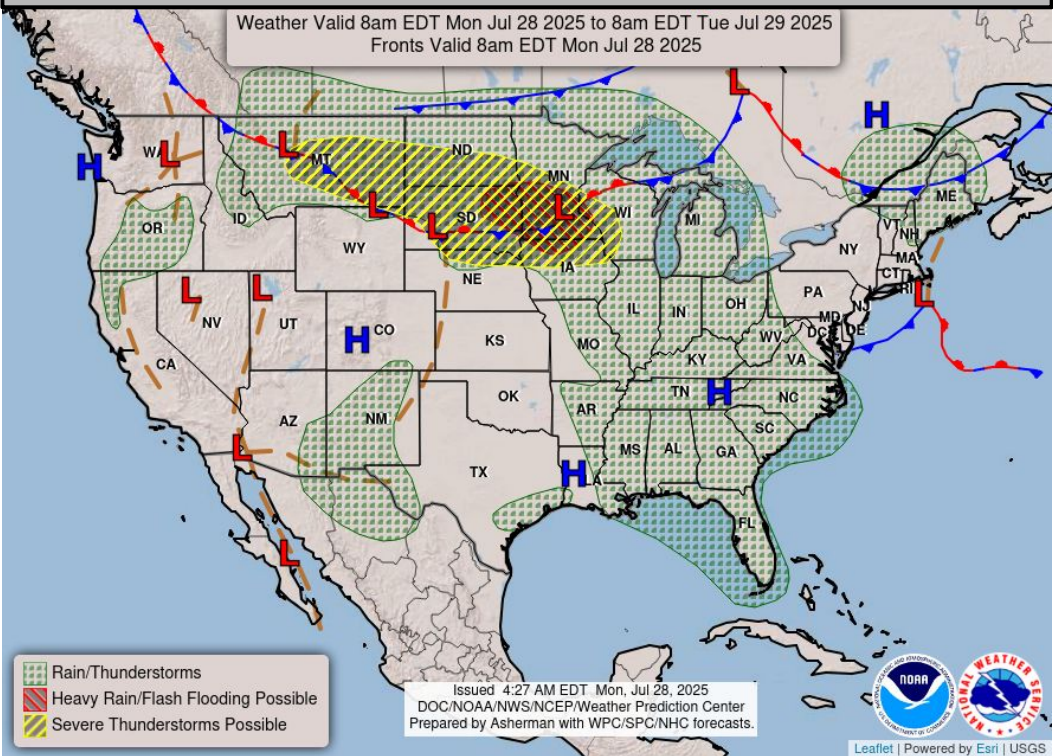
Note: Numerical levels (e.g. level 1 of 4) will not be assigned to riverine flooding due to the varying levels of impacts across flood categories.



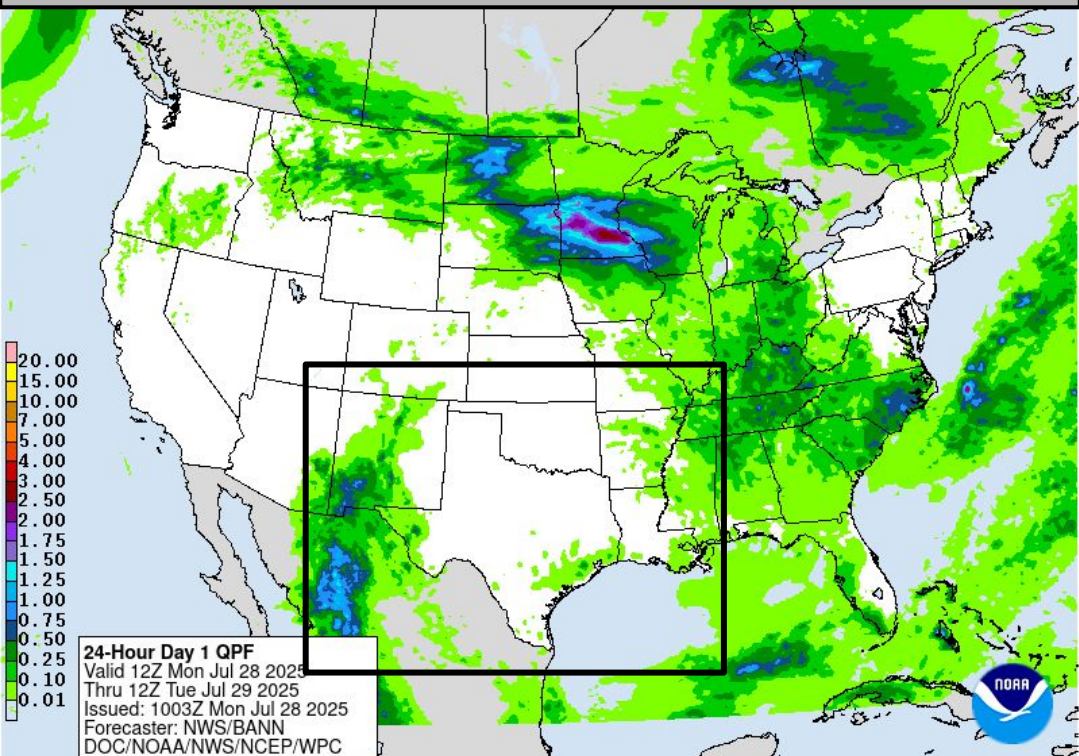

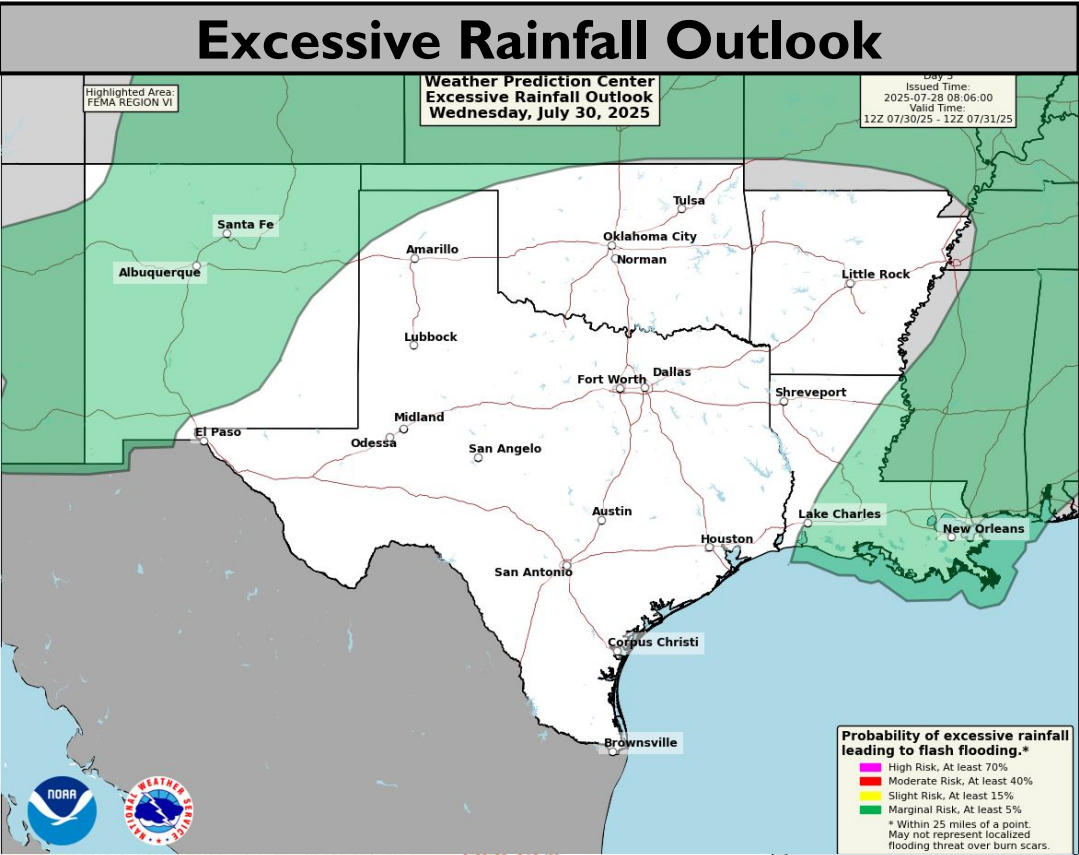
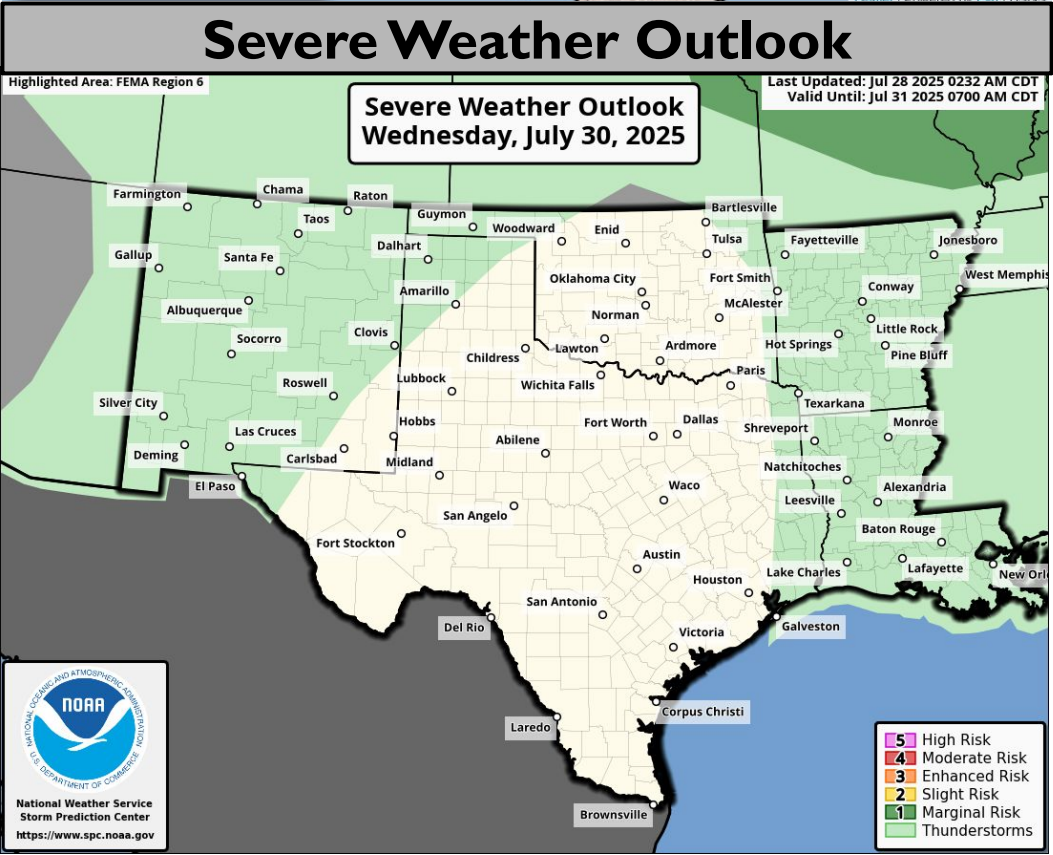
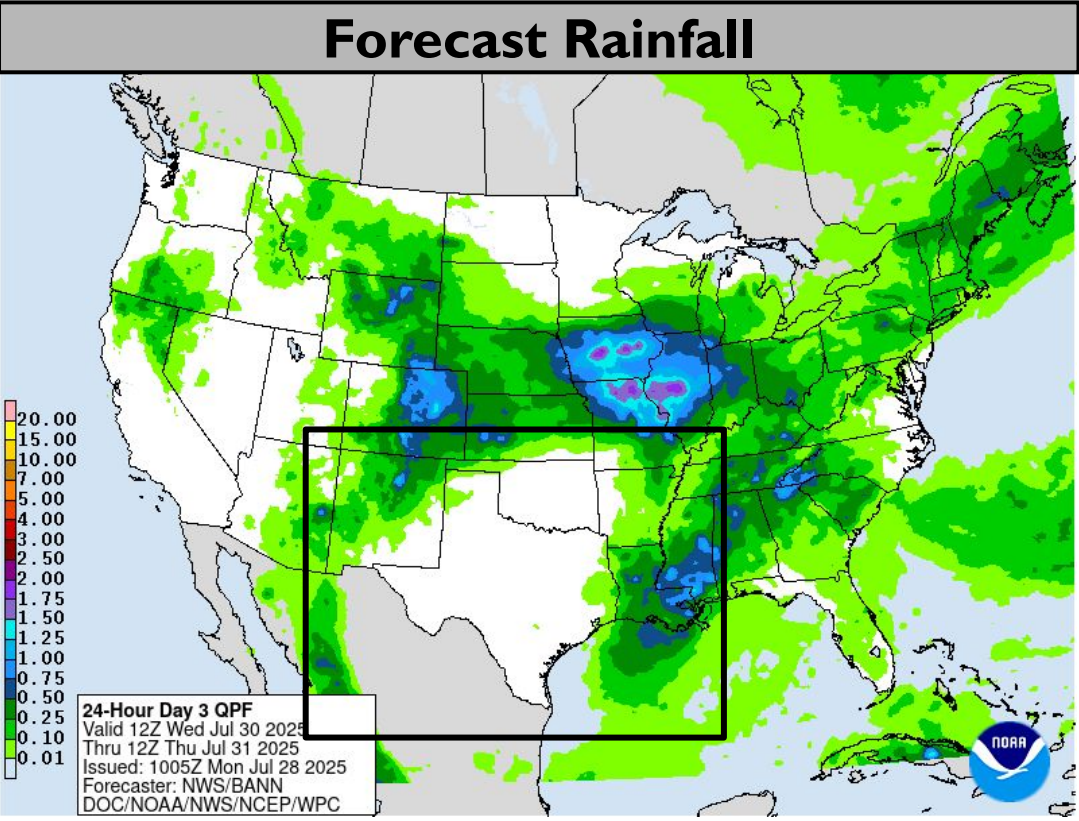
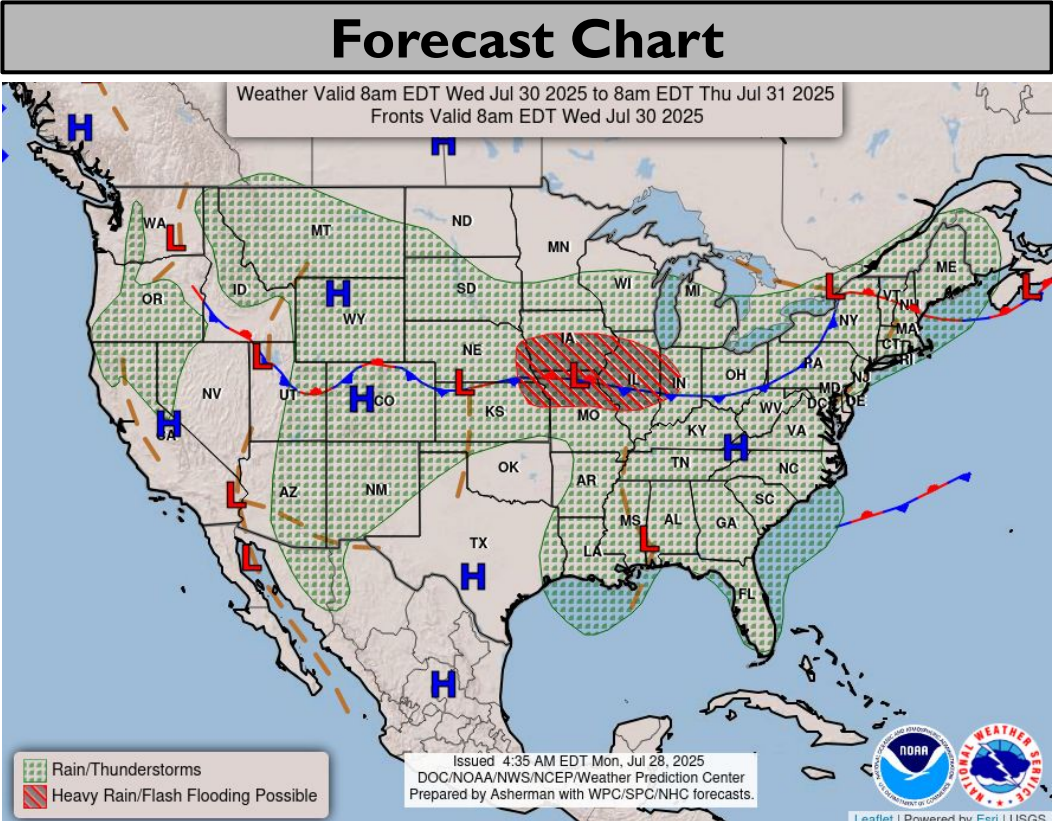


Tomorrow's Tornado & Severe Wind / Hail Probabilities

Green	Little to None Safety: Rarely a Direct Threat to Life and Property Impact Potential: Typically Results in Little Inconvenience to Daily Routines	Severe: Marginal Risk from SPC Flooding: Minor flooding expected over localized areas Tropical: None Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active	<ul style="list-style-type: none"> Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees Something that happens almost every day in a particular season such as seabreeze storms in coastal TX

Purple	Extreme Safety: Property Damage Unavoidable, Immediate Action to Save Life will be Needed Impact Potential: Typically Results in Long-Lived Widespread Major Disruption to Daily Life	Severe: High Risk from SPC Flooding: Major flooding expected over a widespread area (including urban locations) Tropical: A Major Hurricane (Cat3 or greater) expected to move towards or near any coastline Fire: Large area of critical conditions for 2 or more days, Warnings for 3 or more days, Long term (months) of severe to extreme drought	<ul style="list-style-type: none"> A Category 4 hurricane is headed towards the SE LA; major storm surge, flooding and damaging winds anticipated to begin tomorrow Widespread severe storms expected, tornado outbreak probable with long-lived, very widespread and particularly intense storms
