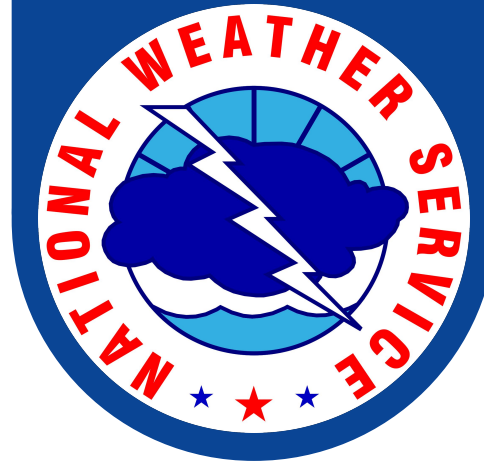



Summary

- **Heat:** Dangerous heat risk continues through the week for the eastern portions of FEMA 6, with the highest risk for heat-related impacts in E AR and E LA through Thursday. Heat eases by the end of the week as rain chances return.
- **Flash Flooding:**
 - Burn Scar flash flooding continues with a Moderate to Major (levels 2-3 of 4) risk through Friday.
 - Slight risk (level 2 of 4) over E NM, OK/TX Panhandles today.
- **Tropical:** No tropical impacts expected in FEMA 6 over the next 7 days.



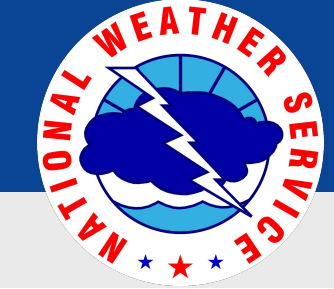
Active Tropical Cyclones



Isolated minor river flooding in E AR is forecast to recede by the end of the week. Rural secondary crossings, roadways, and croplands will be flooded.


Note: Numerical levels (e.g. level 1 of 4) will not be assigned to riverine flooding due to the varying levels of impacts across flood categories.






Excessive Rainfall Outlook





Green	Little to None Safety: Rarely a Direct Threat to Life and Property Impact Potential: Typically Results in Little Inconvenience to Daily Routines	Severe: Marginal Risk from SPC Flooding: Minor flooding expected over localized areas Tropical: None Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active	<ul style="list-style-type: none"> Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees Something that happens almost every day in a particular season such as seabreeze storms in coastal TX
