Summary

- **Flash Flooding:** Slight risk (level 2 of 4) over S-Cntrl TX today and S NM today; Flood Watches are in effect through this evening. Marginal risk (level 1 of 4) over NM/Far W TX Saturday through Wednesday.
 - **NM Burn Scars:** Persistent monsoonal activity leads to a Major risk (level 3 of 4) through midweek.
- **Heat:** Hazardous heat expands across LA, AR, TX and OK through this weekend into early next week. Temps feel as hot as 109 degrees.
- **Tropical:** Hurricane Erin will move west/northwest over the next several days and is expected to stay out in the Atlantic Ocean. No impacts to FEMA Region 6.

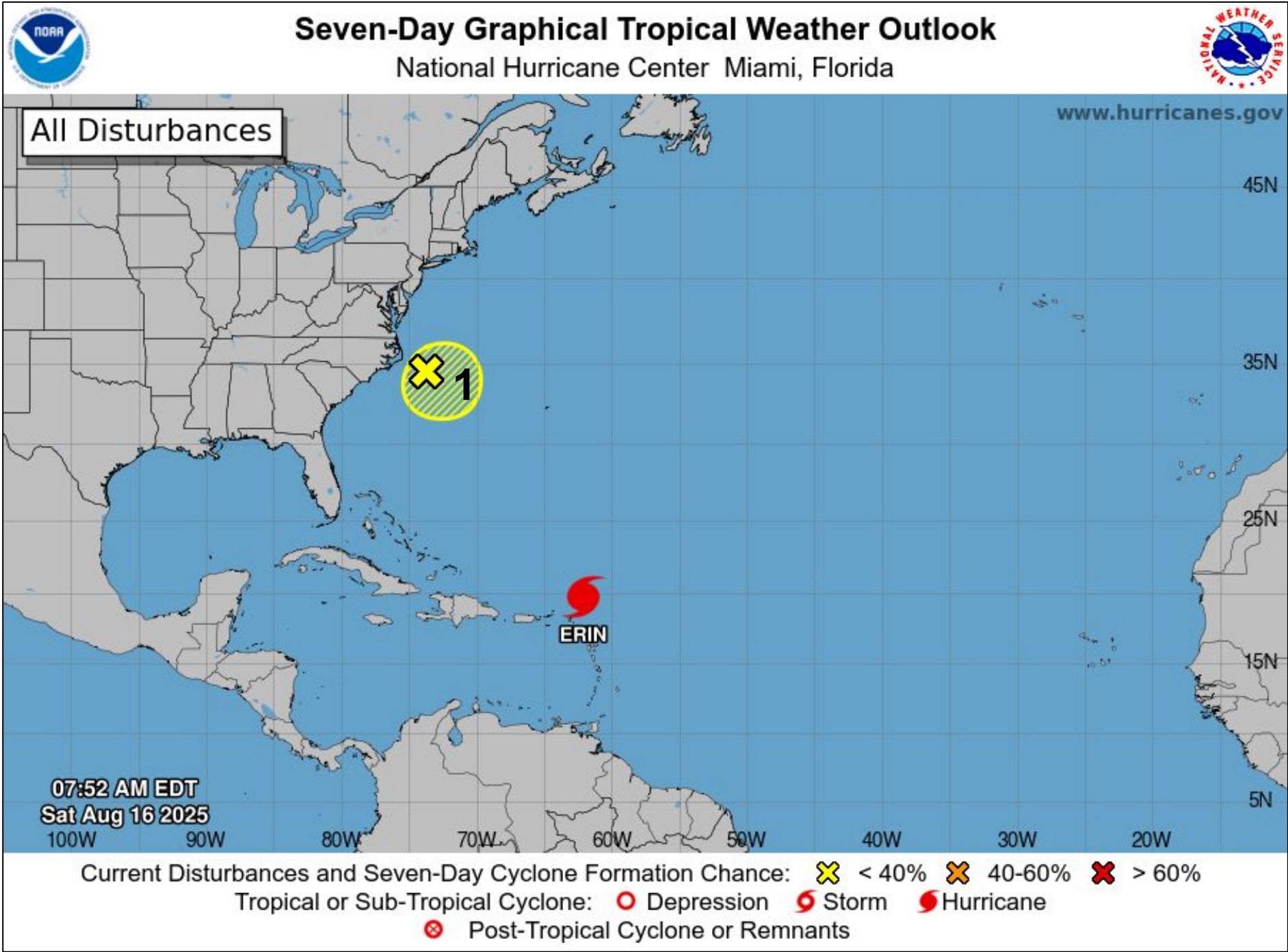

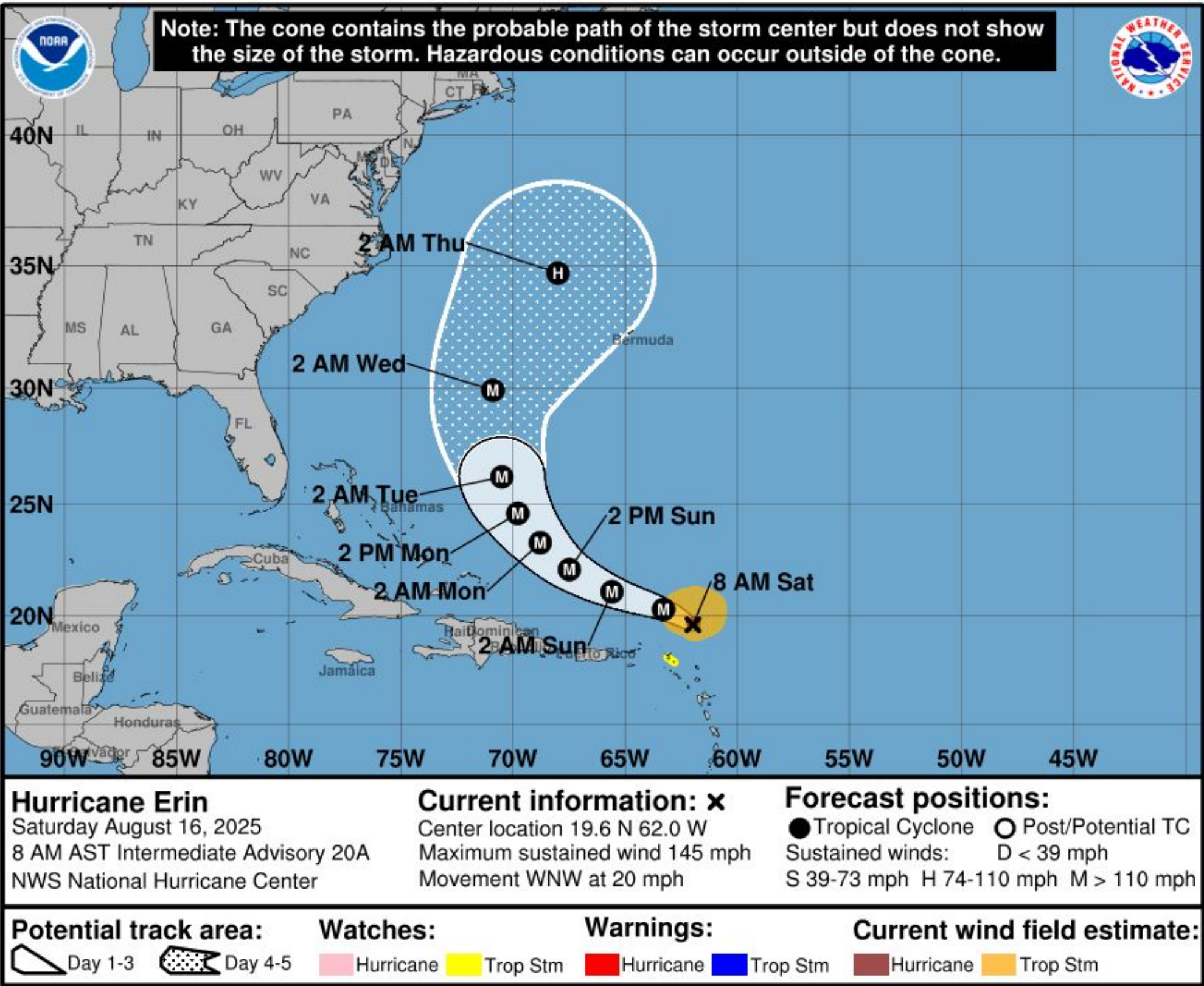

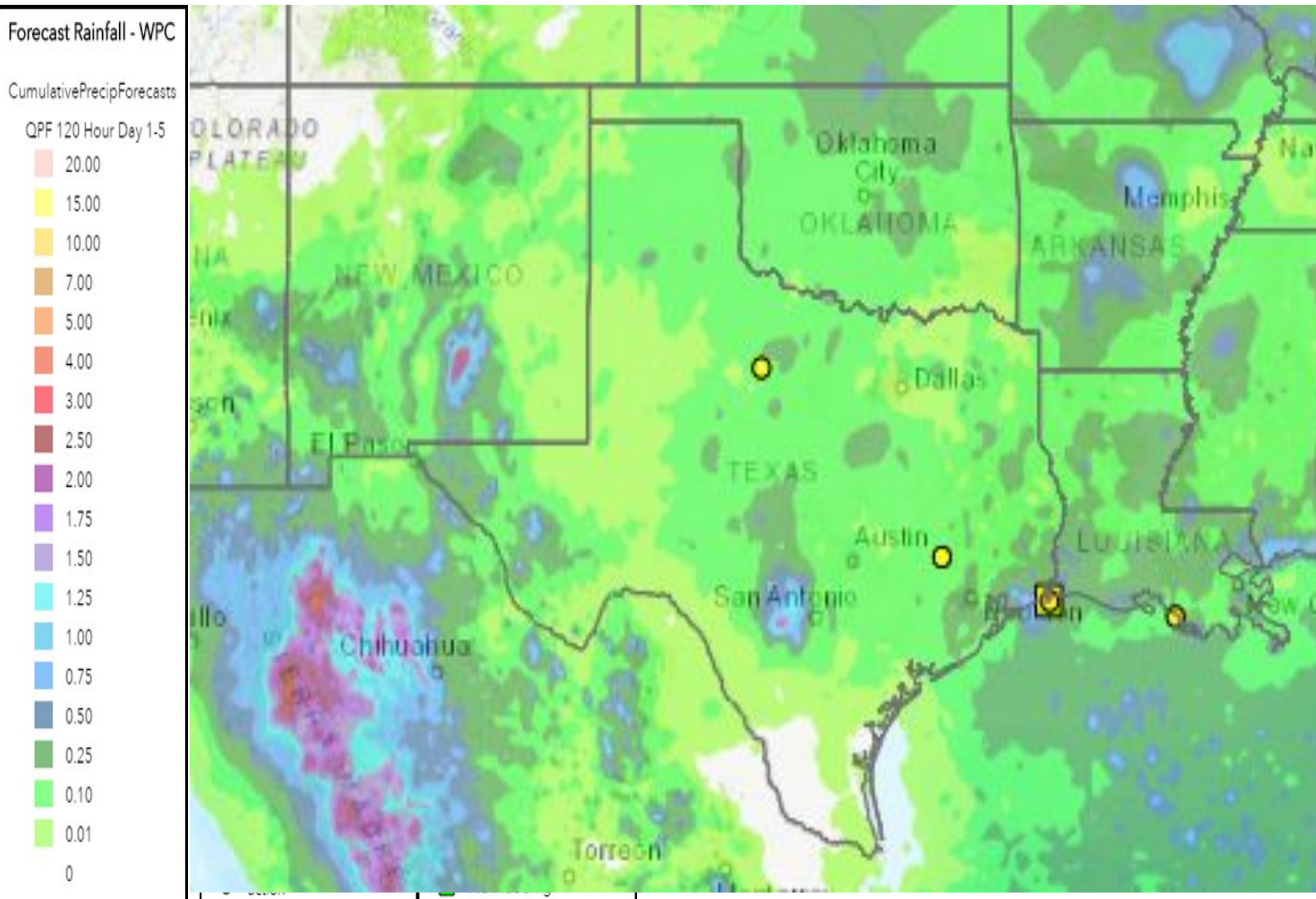

Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall



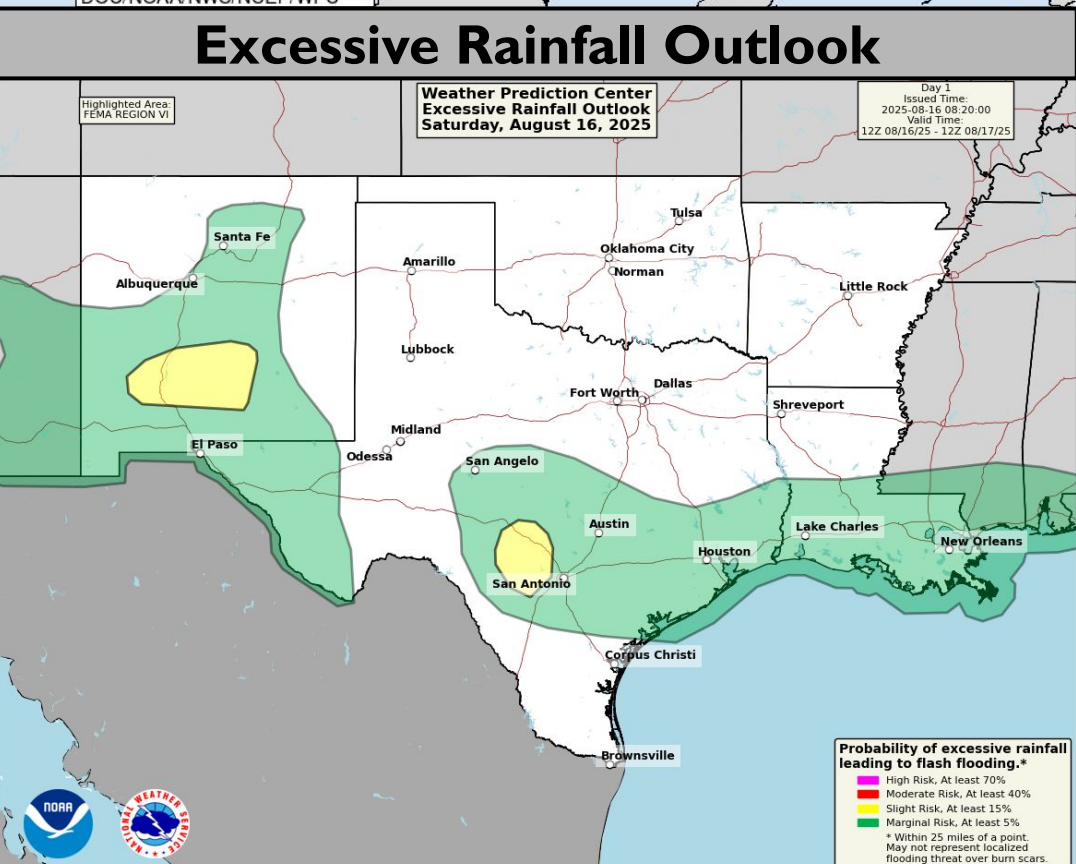
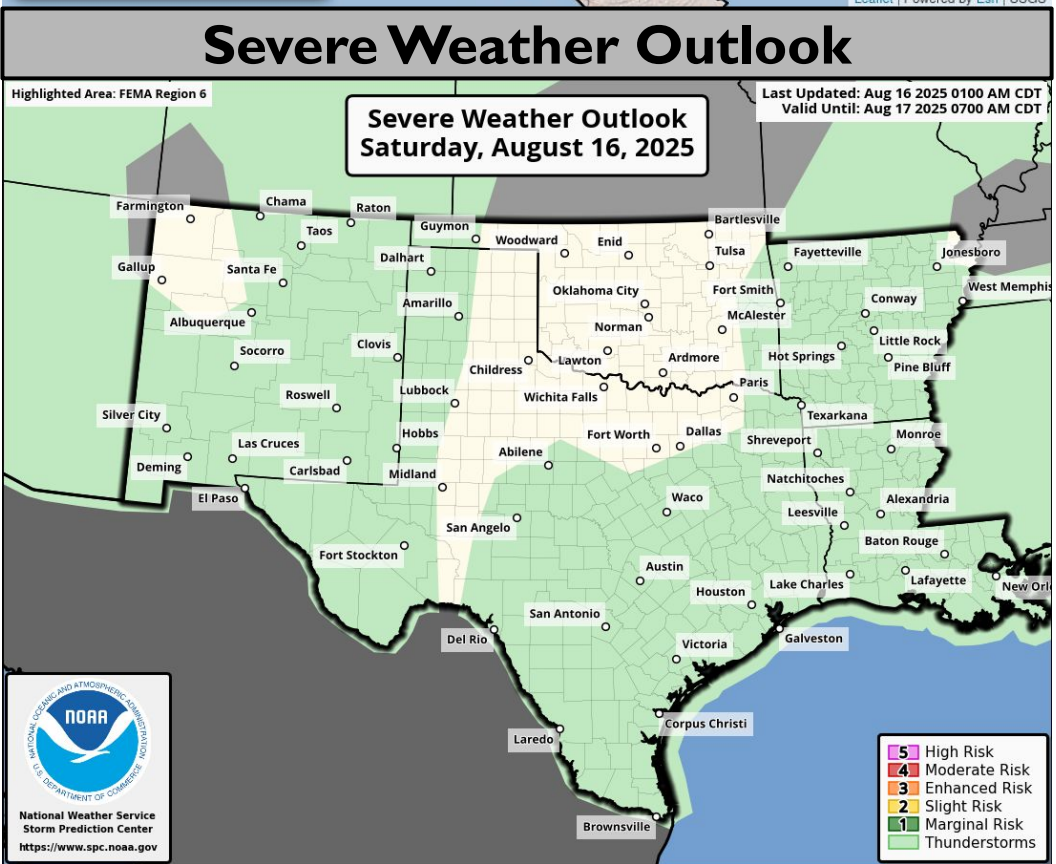
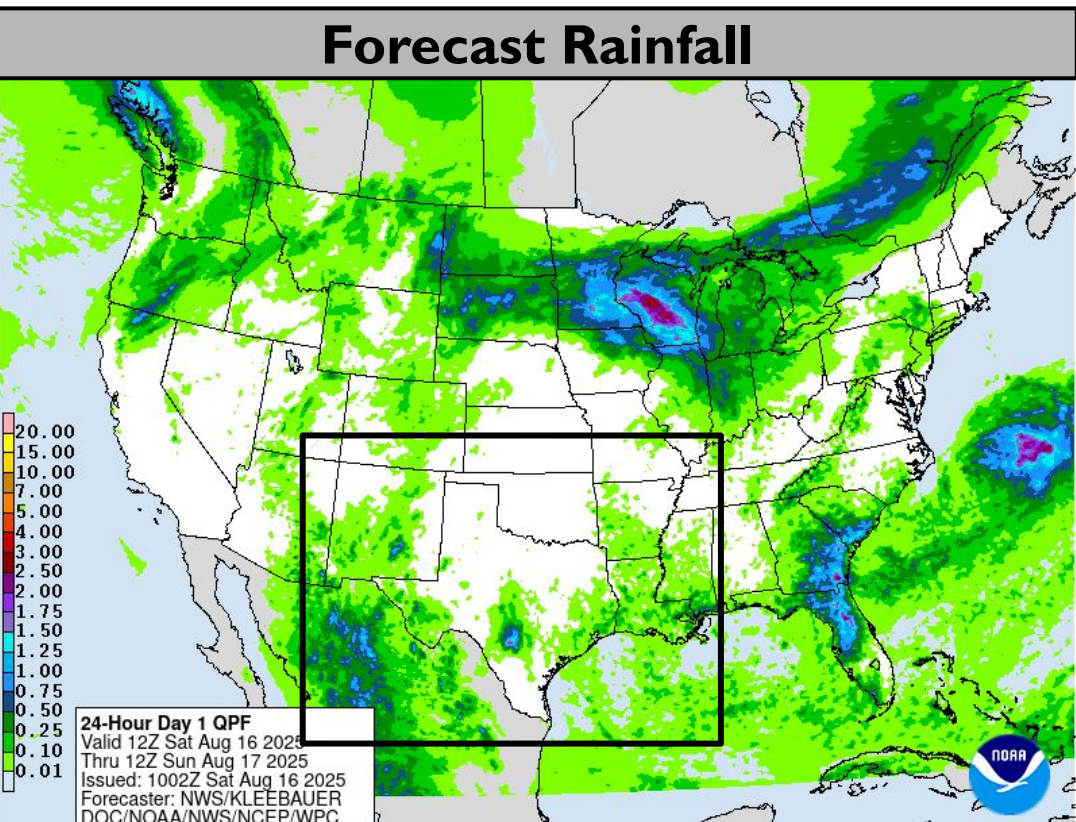
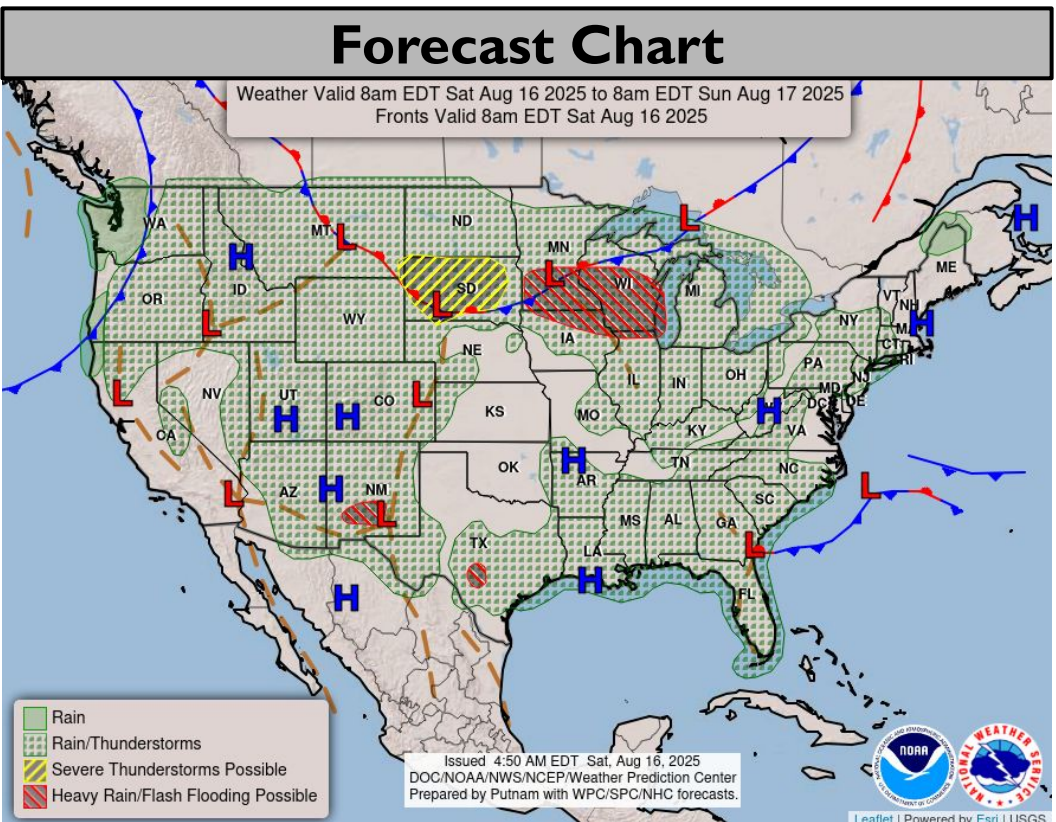

Flood watch in S-Central TX through 7pm CT. 3-5" of rain could fall somewhere within the Flood Watch area.

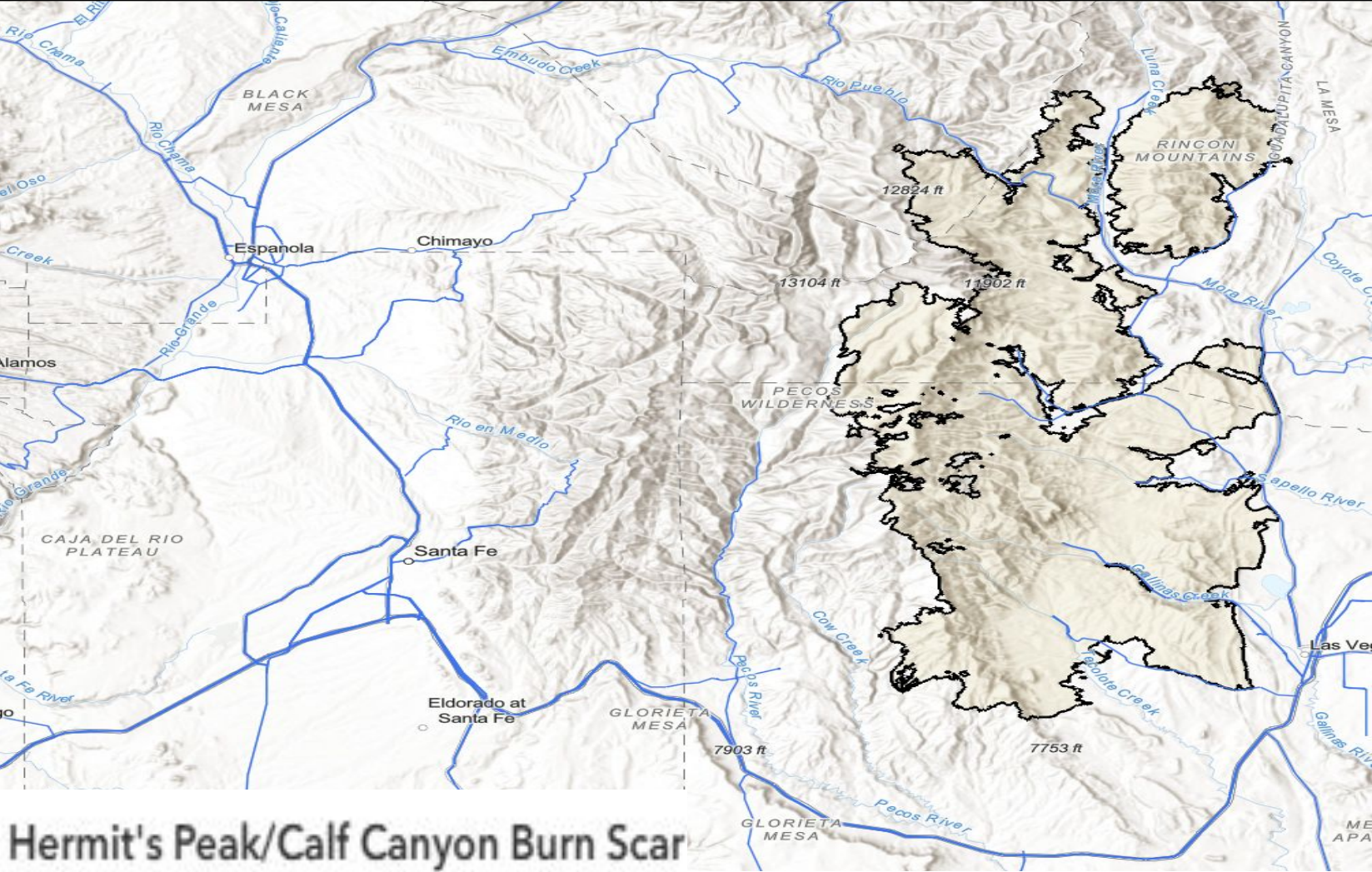
Flood watch over the burn scar areas of S NM through 10pm CT.

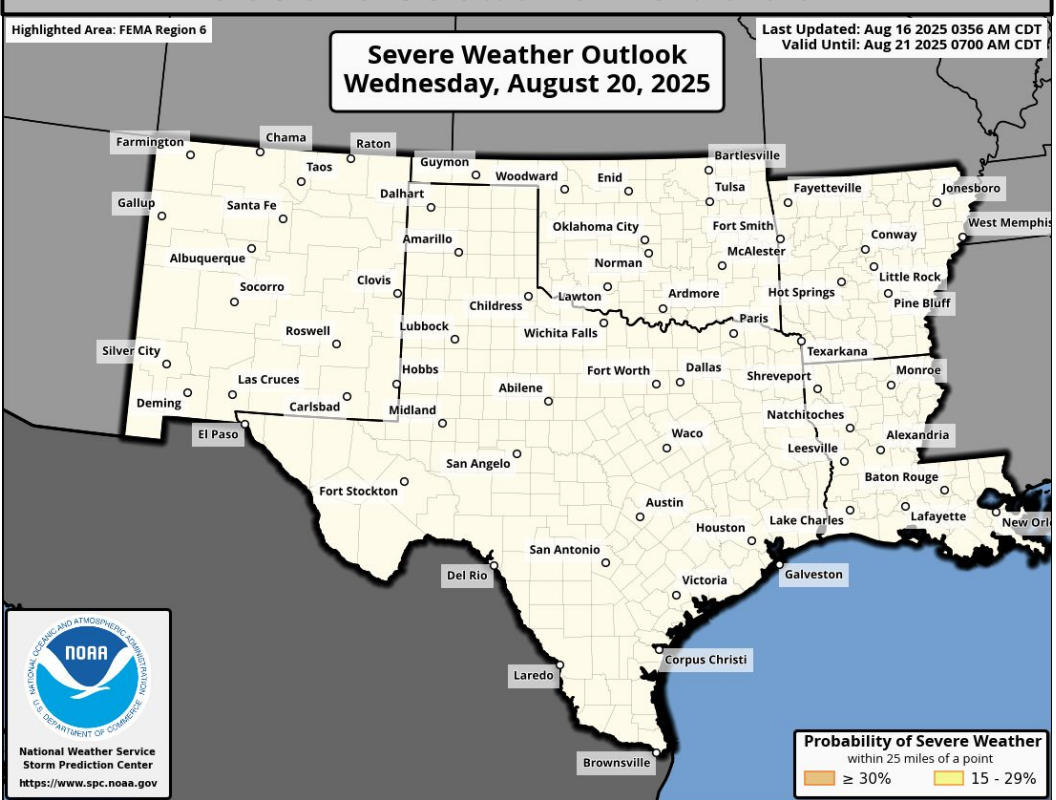


Forecast Rainfall

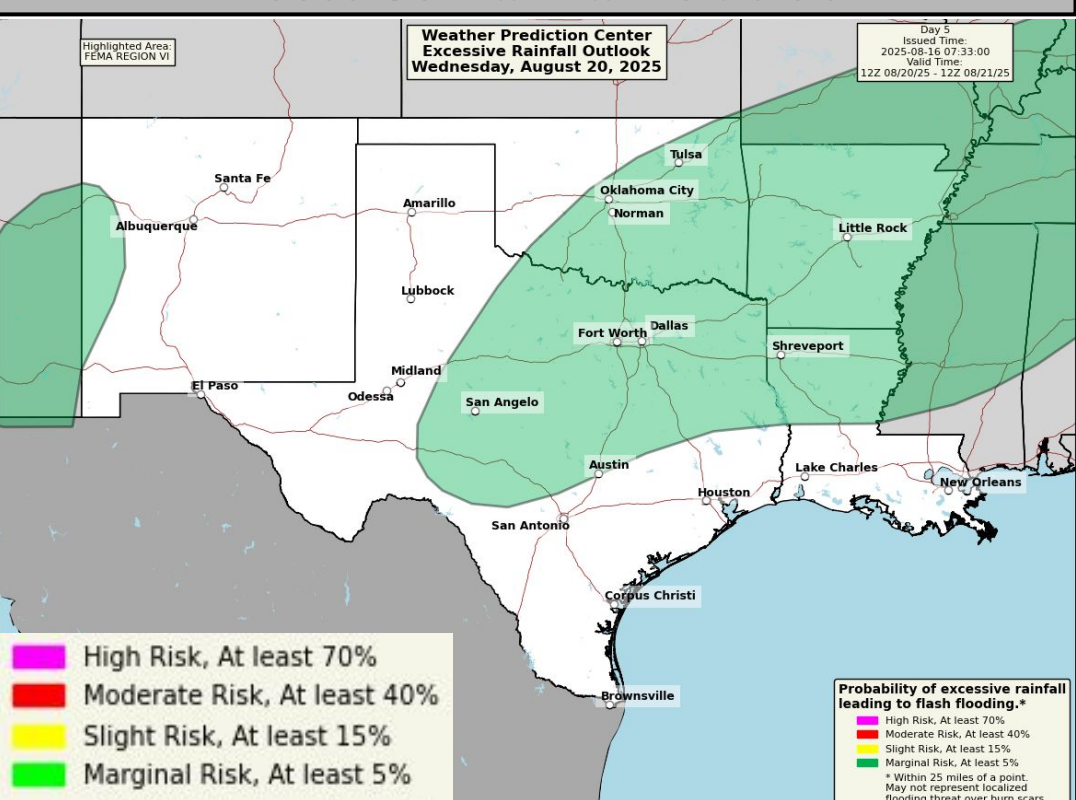


Marginal risk (level I of 4) for flash flooding in W NM, TX, OK, AR, and N LA.

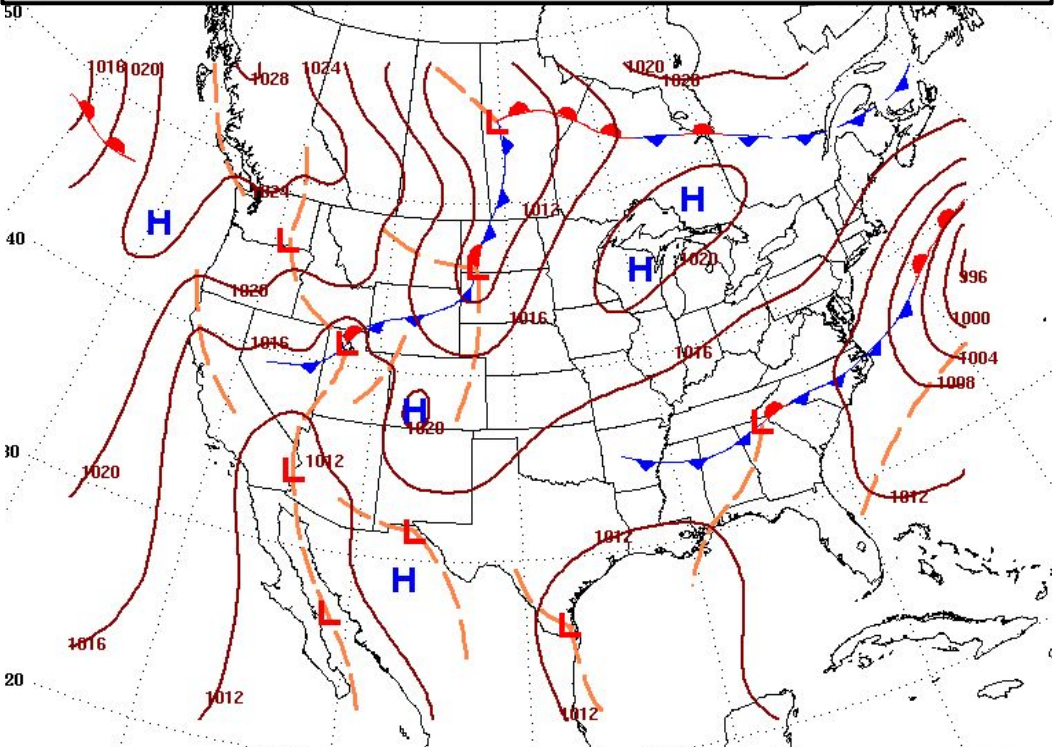
Excessive Rainfall Outlook



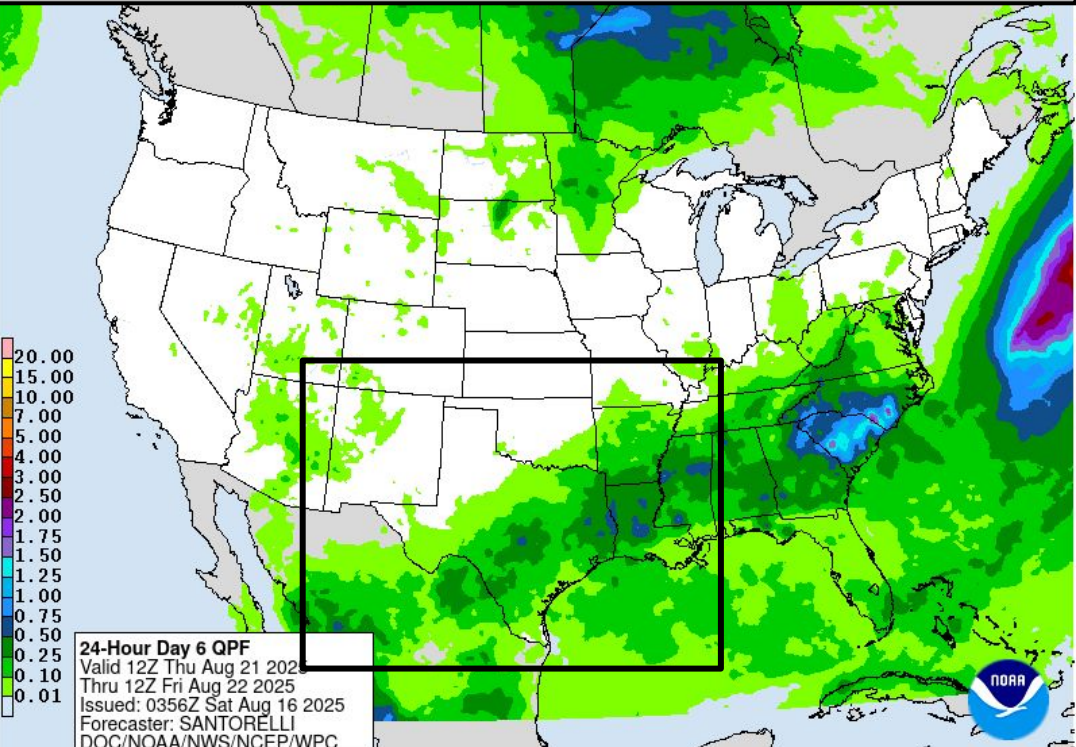

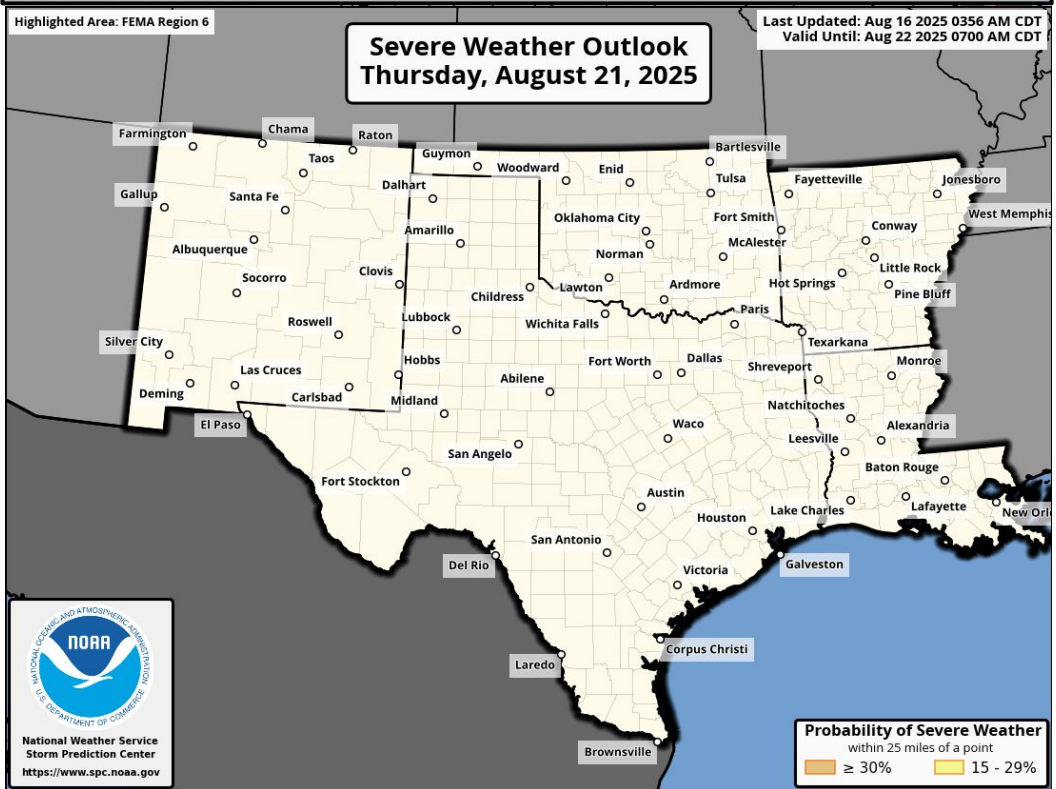


Forecast Rainfall

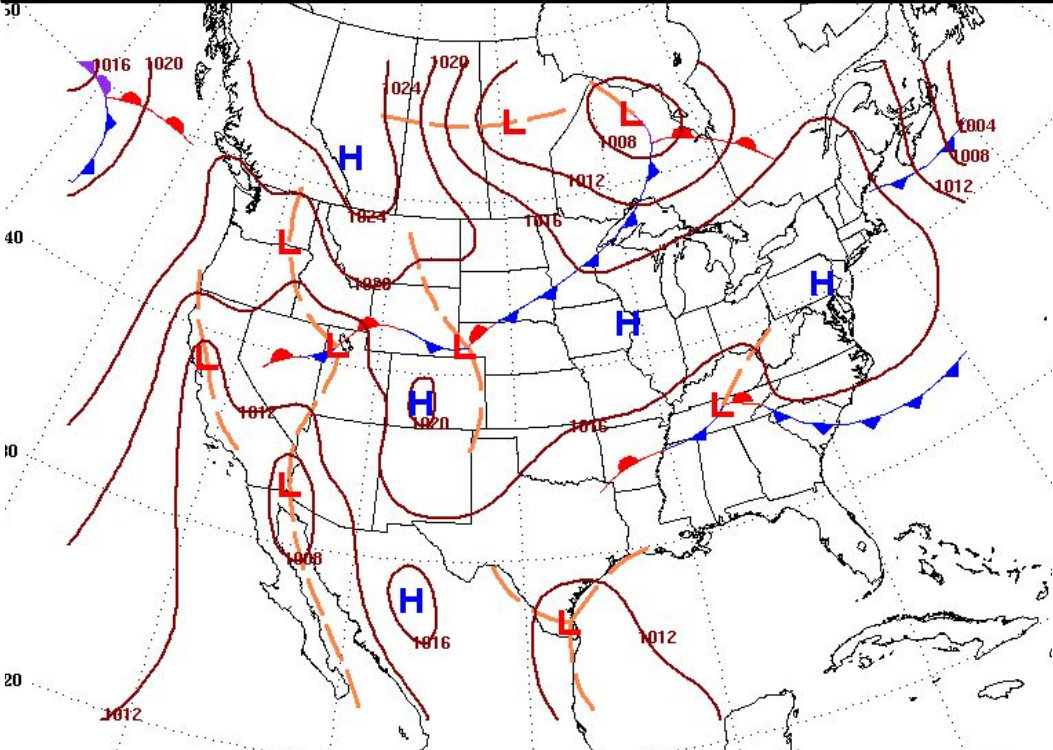

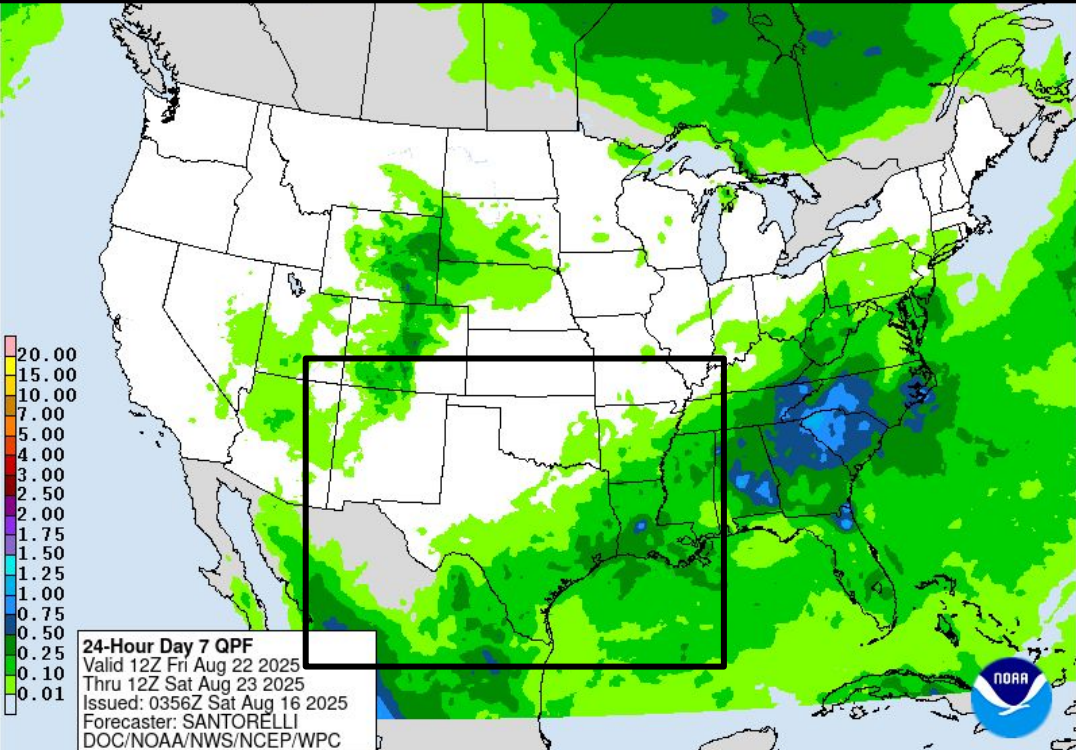

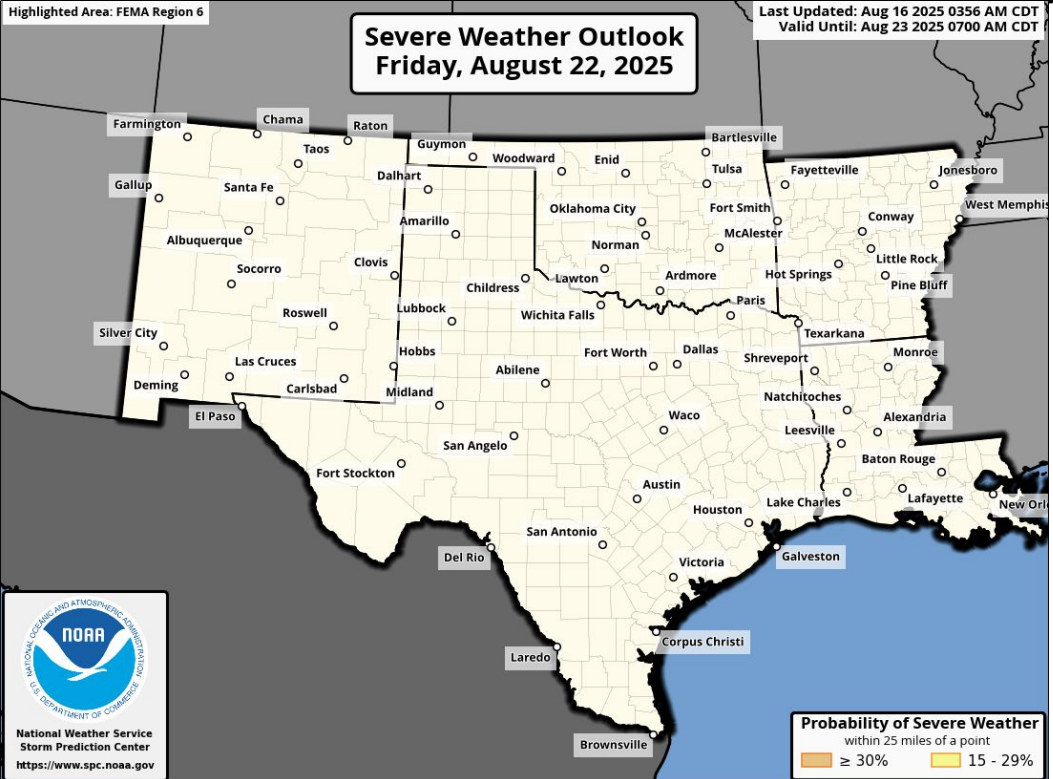


Forecast Rainfall

Green	Little to None Safety: Rarely a Direct Threat to Life and Property Impact Potential: Typically Results in Little Inconvenience to Daily Routines	Severe: Marginal Risk from SPC Flooding: Minor flooding expected over localized areas Tropical: None Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active	<ul style="list-style-type: none"> Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees Something that happens almost every day in a particular season such as seabreeze storms in coastal TX
