FEMA Region 6 Weather Threat Briefing

• Flash Flooding:

- Slight risk (level 2 of 4) for N OK, NW AR today. Thursday the threat focuses in OK and the ArkLaTex region then spreads southward through most of FEMA 6 on Friday. The next round of rain comes Saturday back into N NM & TX/OK Panhandles. Monsoon moisture lingers over the weekend into next week.
- NM Burn Scars: Moderate risk (level 2 of 4) through Thursday across NM then ramping up to Major (level 3 of 4) through Saturday.

• Tropical:

No impacts to FEMA 6 from TS Fernand.







Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall




Minor with possible moderate rises on rivers in E OK or AR today through Thursday due to heavy rainfall. River rises will depend on where the rain falls.









Tomorrow's Tornado & Severe Wind / Hail Probabilities
















