Summary

- **Flash Flooding:**

- **Slight risk (level 2 of 4) for E NM, TX/OK Panhandle, E TX, N LA today. Slight risk continues Saturday over E NM, NW-C TX, SW OK. By Sunday the focus will be S NM, Far W TX.**
- **NM Burn Scars: Major risk (level 3 of 4) today through Monday.**

- **Severe Storms:**

- **Marginal risk (level 1 of 5) for isolated damaging hail and wind today for NE NM, NW TX/OK Panhandles, SE TX, SW LA.**

- **Tropical:**

- **Eastern Atlantic has a low chance (30%) for development in the next 7 days. No impacts in the next 7 days.**

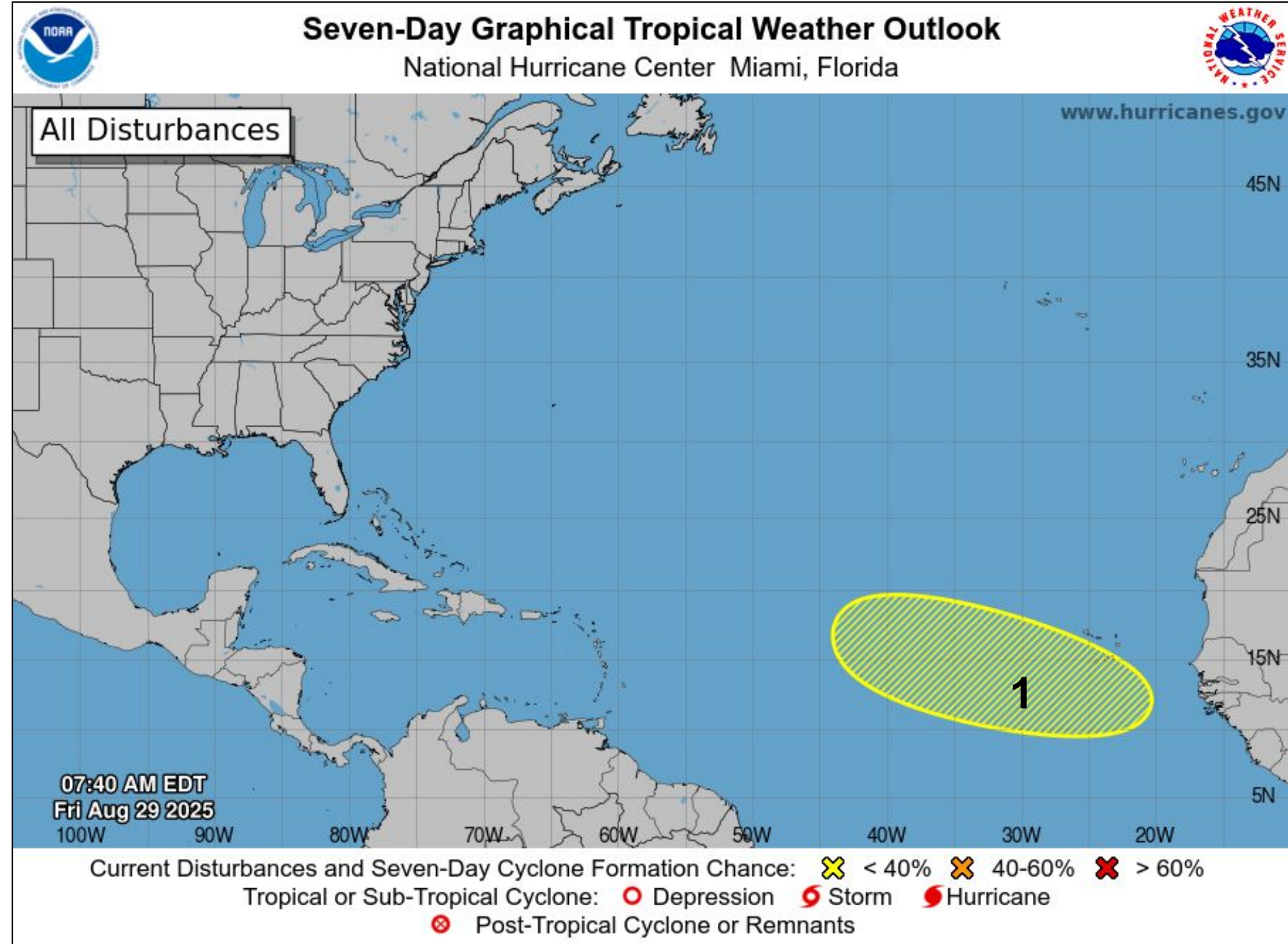

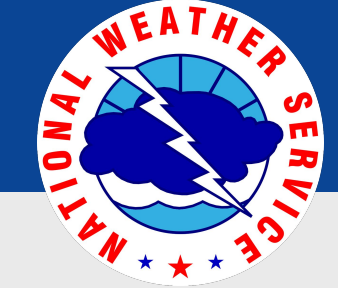

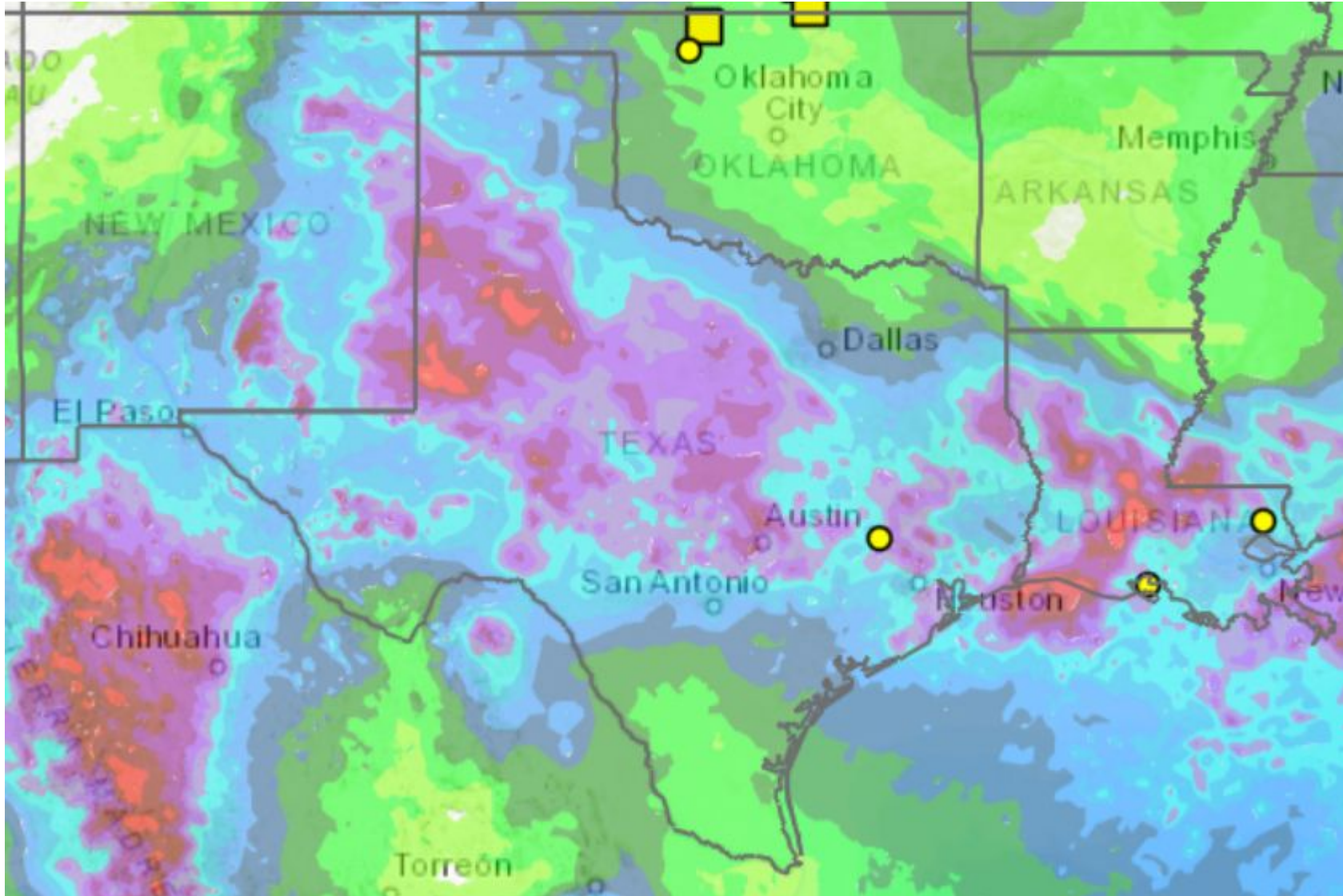

Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall



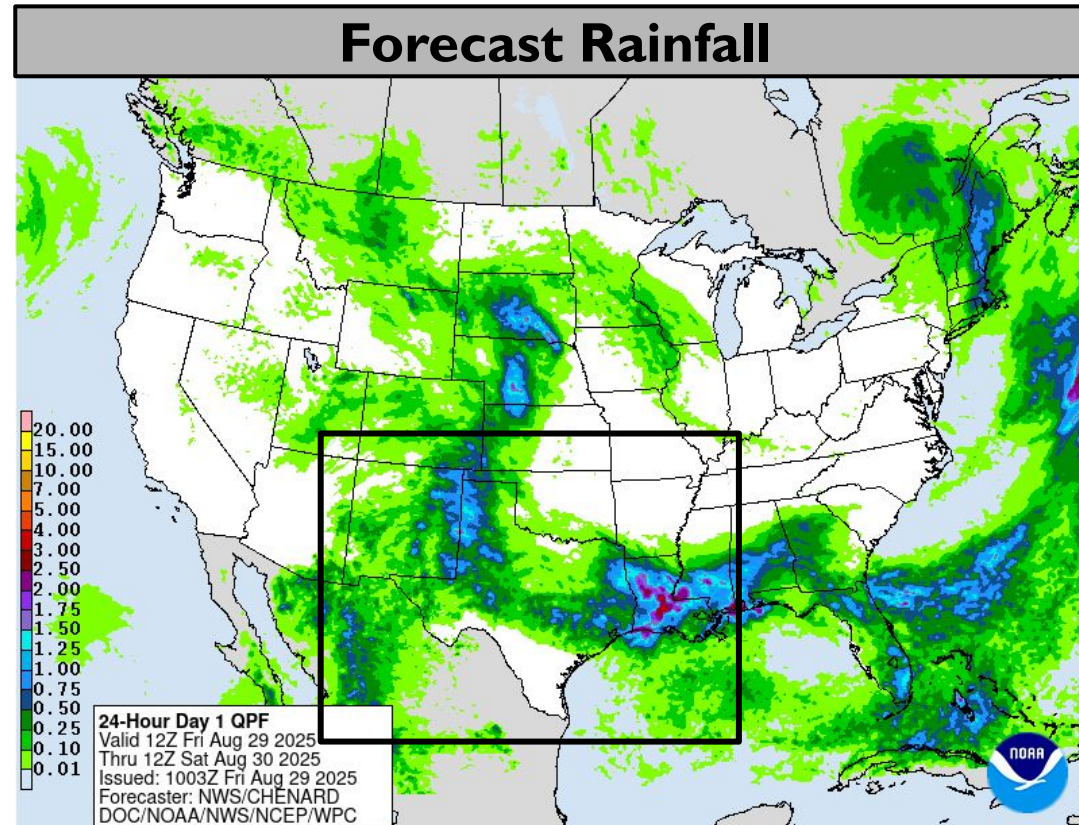
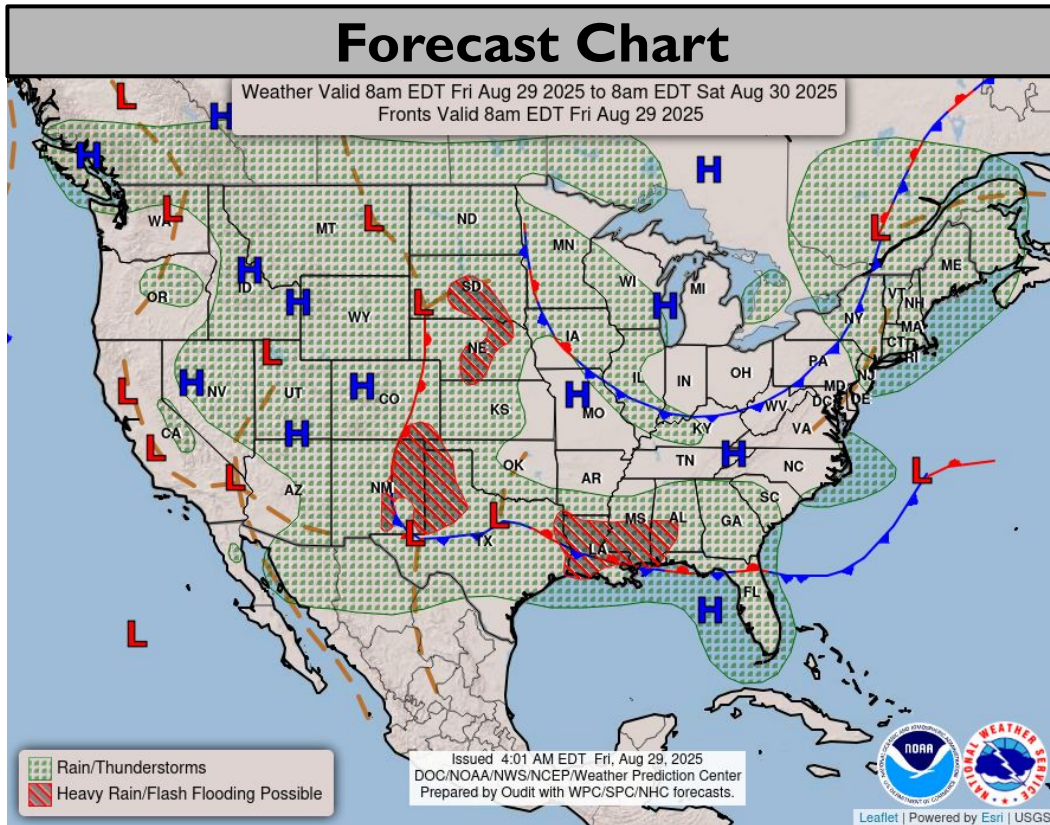

2-4" of rain conceivable for NW-C TX this afternoon/tonight, and up to 5-6" of additional rainfall for S LA.

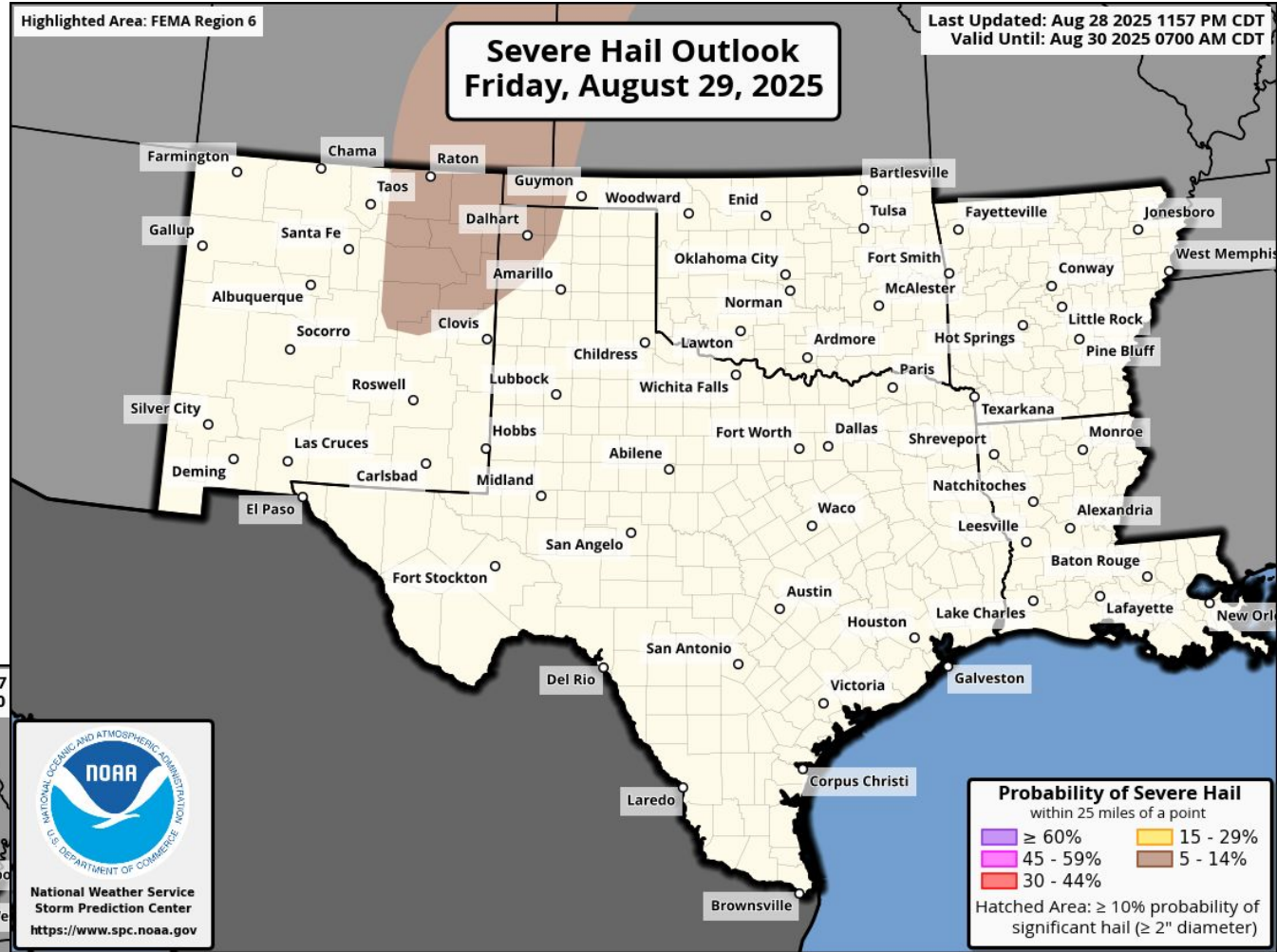
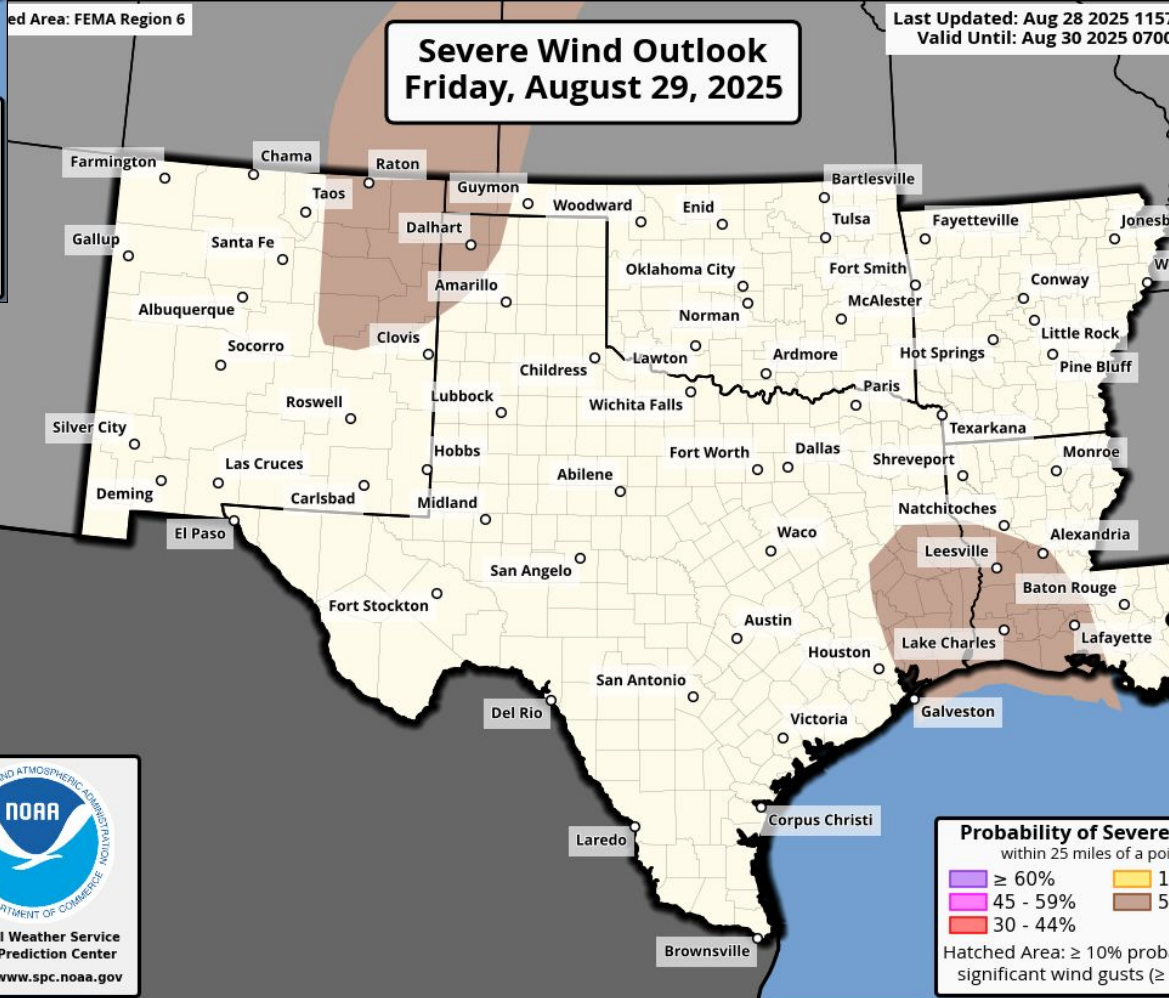
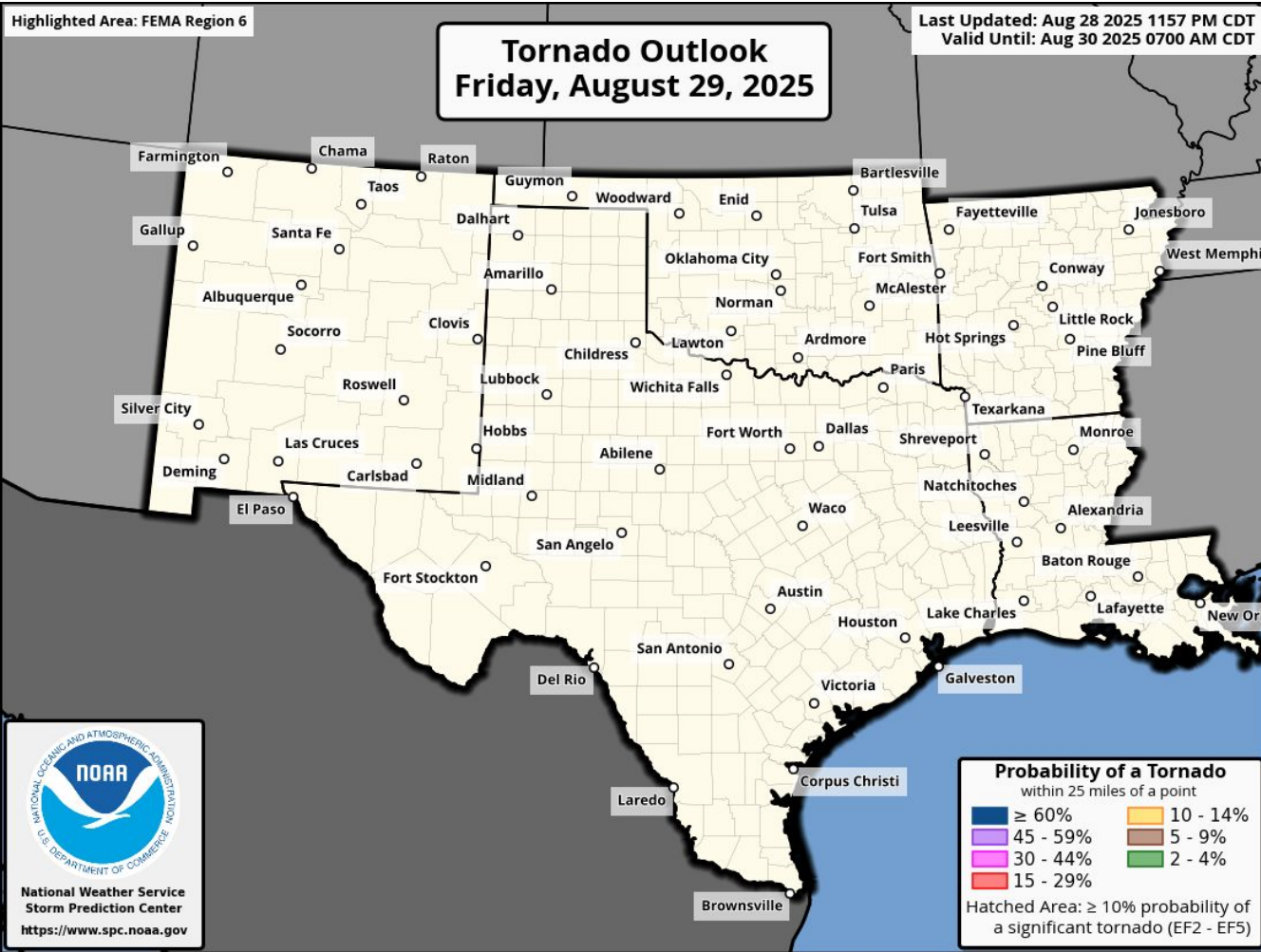

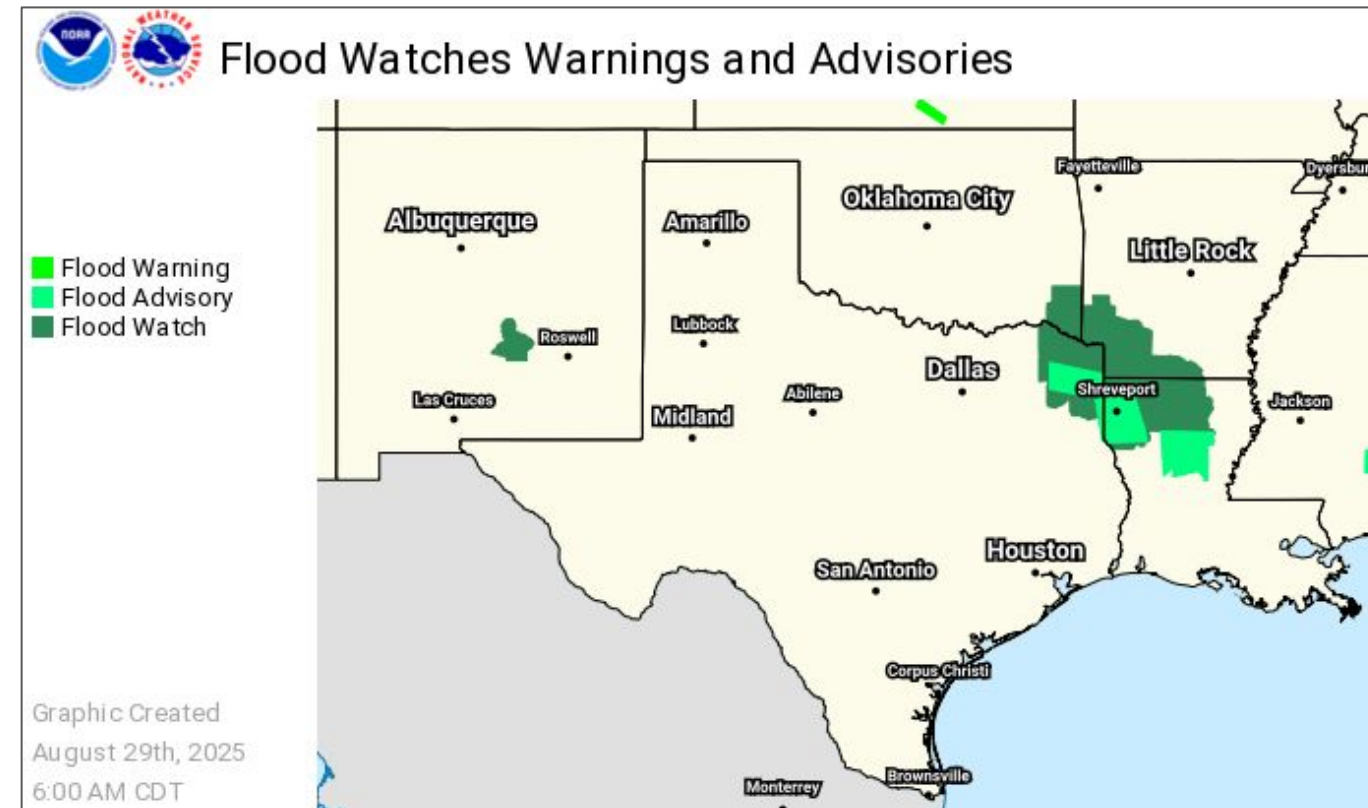
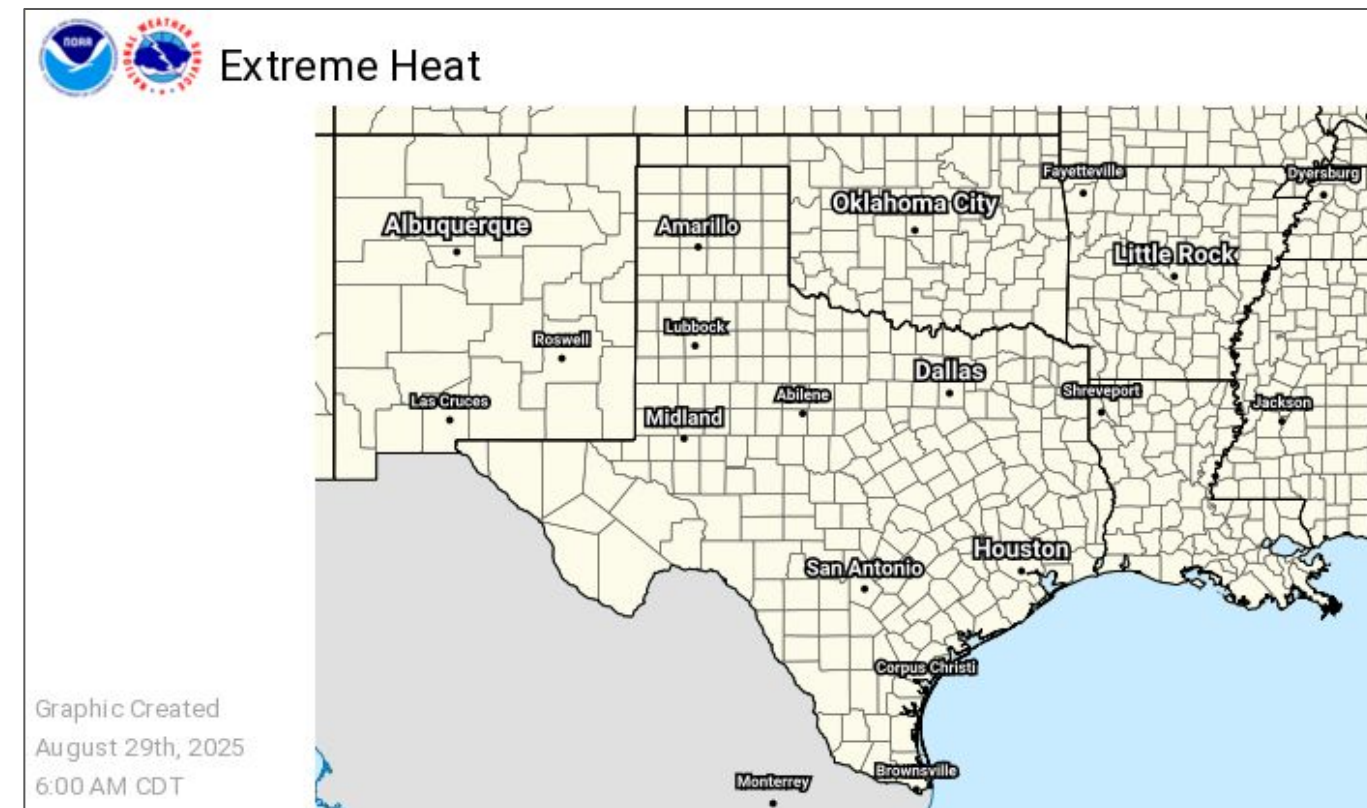
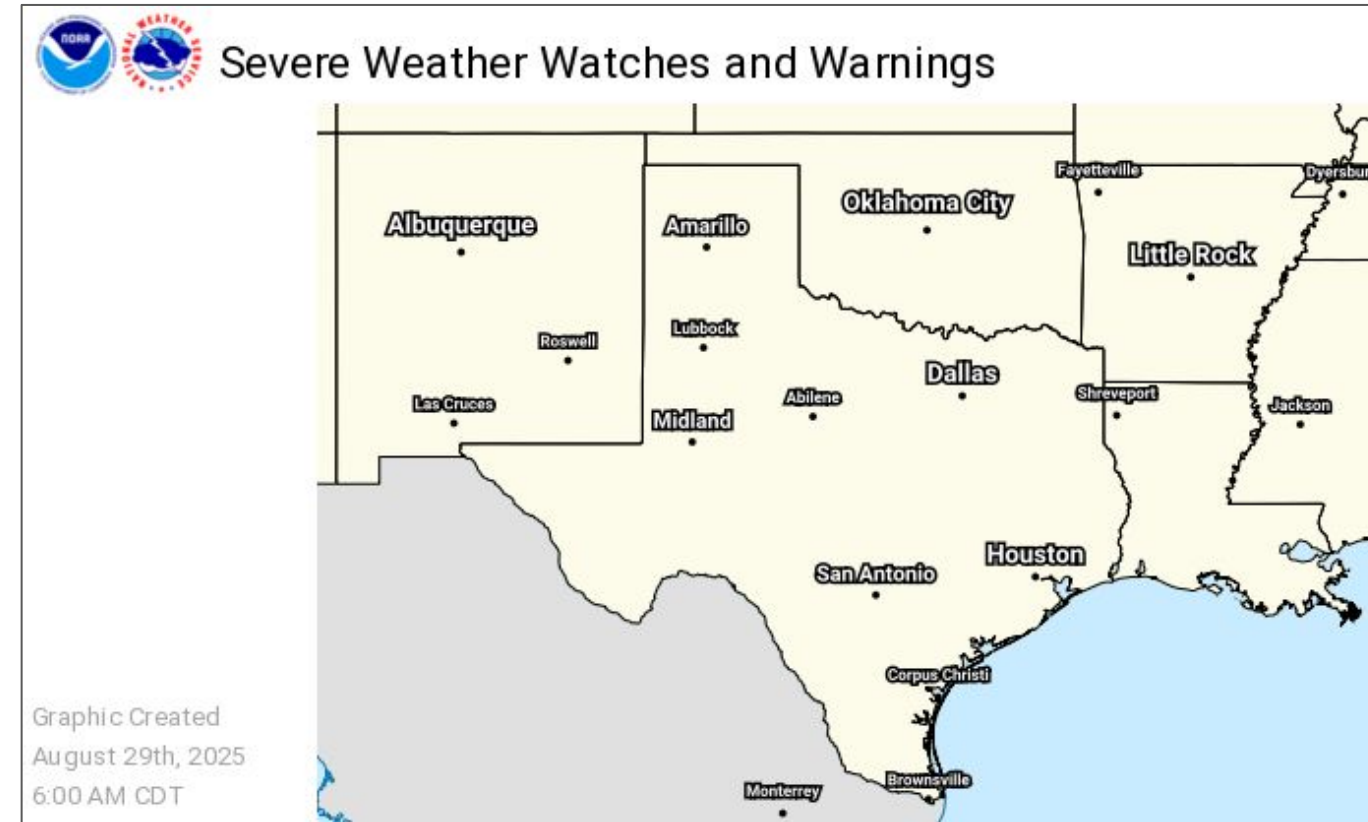
Today's Tornado & Severe Wind / Hail Probabilities





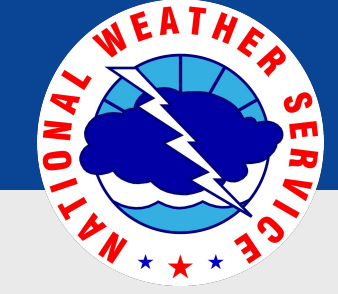
Watches, Warnings, and Advisories

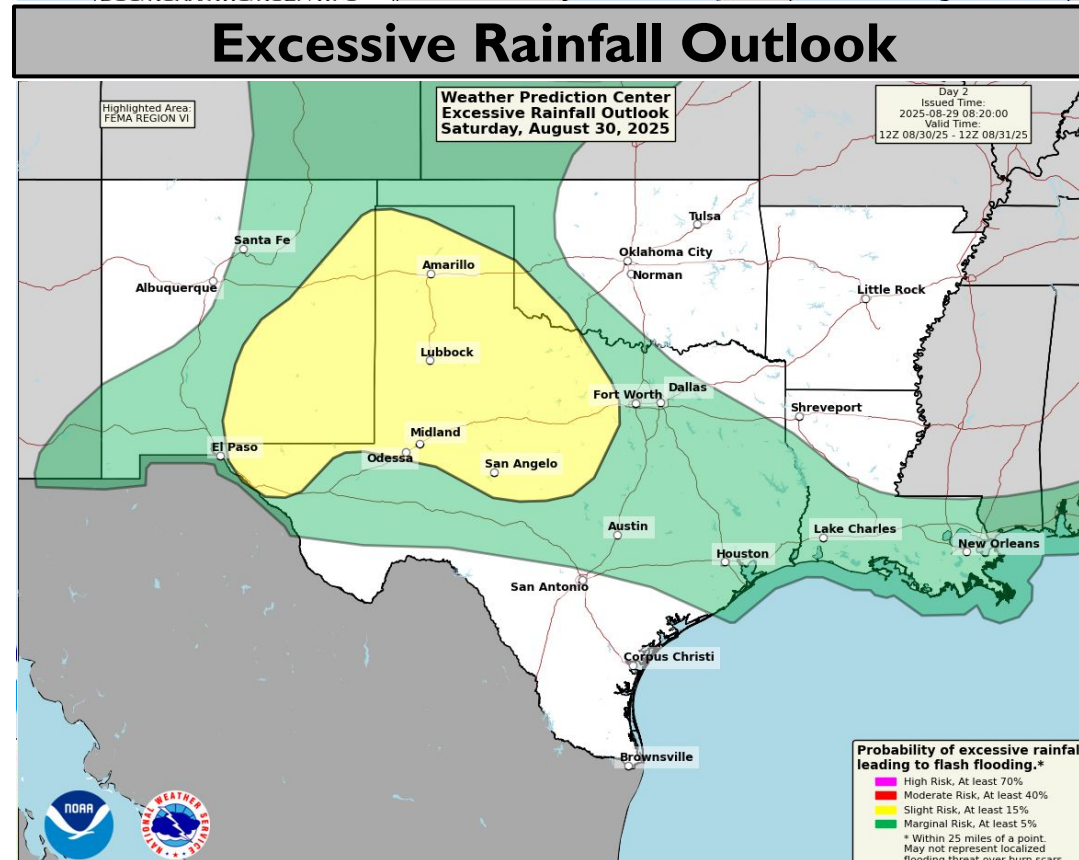
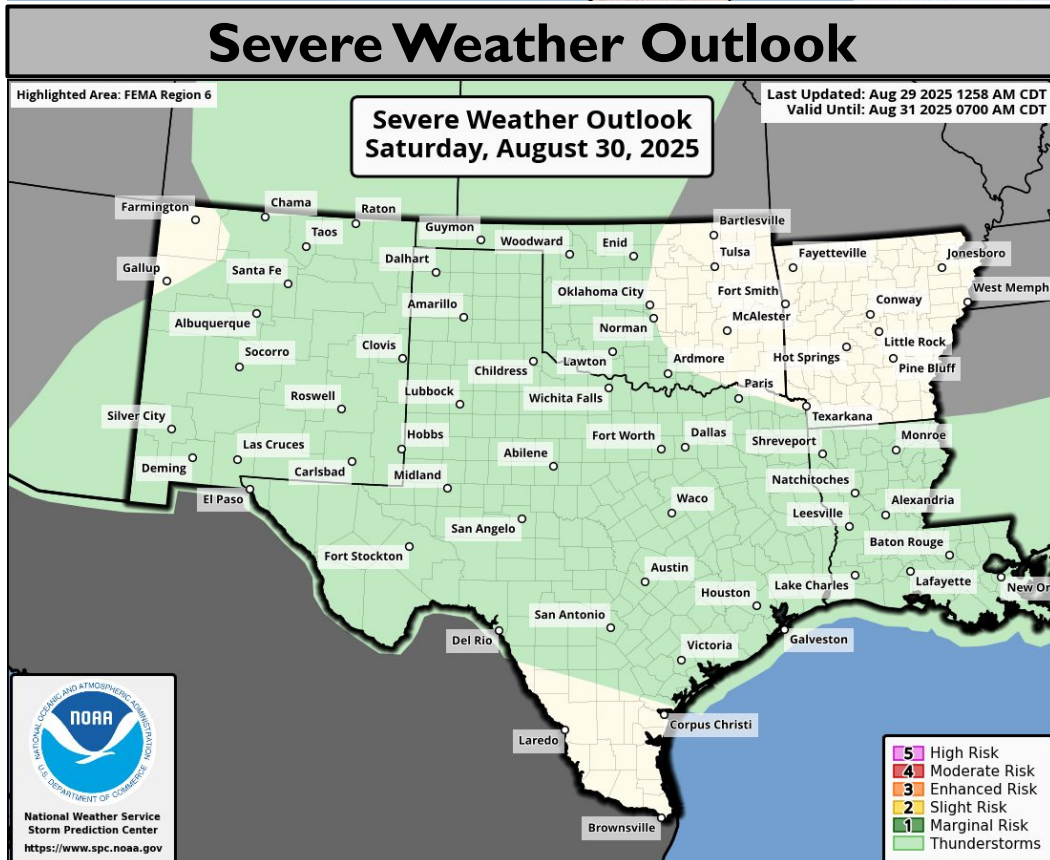
- **WPC's Excessive Rainfall Outlook is *Not Applicable* to burn scars.**

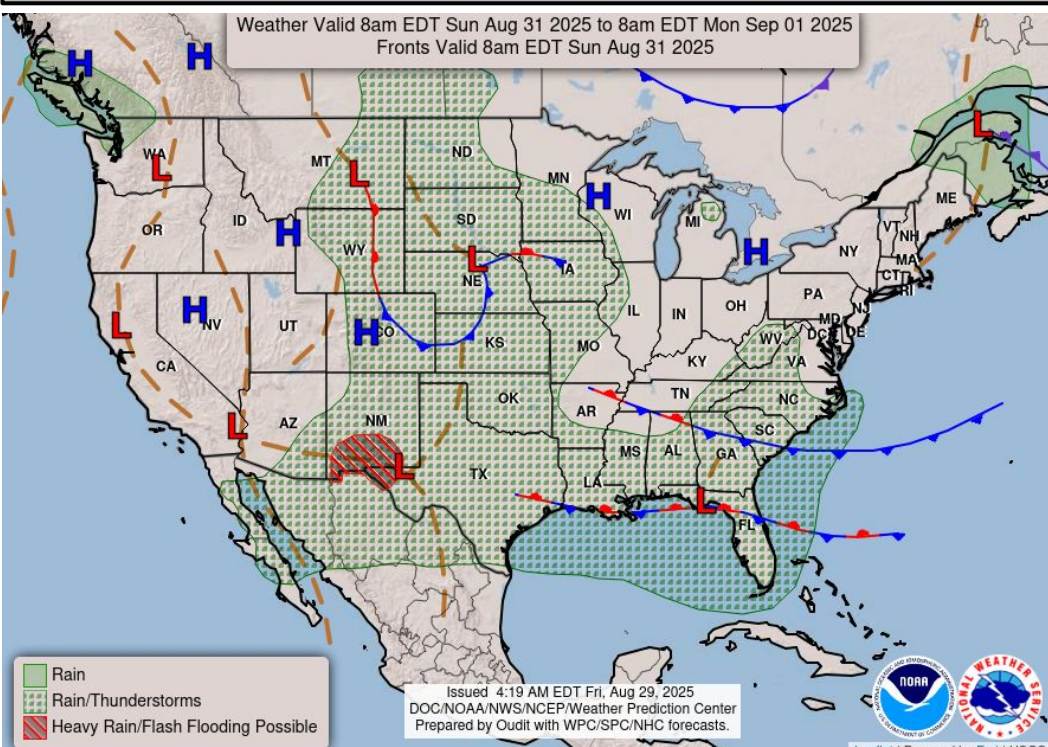
Tomorrow's Tornado & Severe Wind / Hail Probabilities



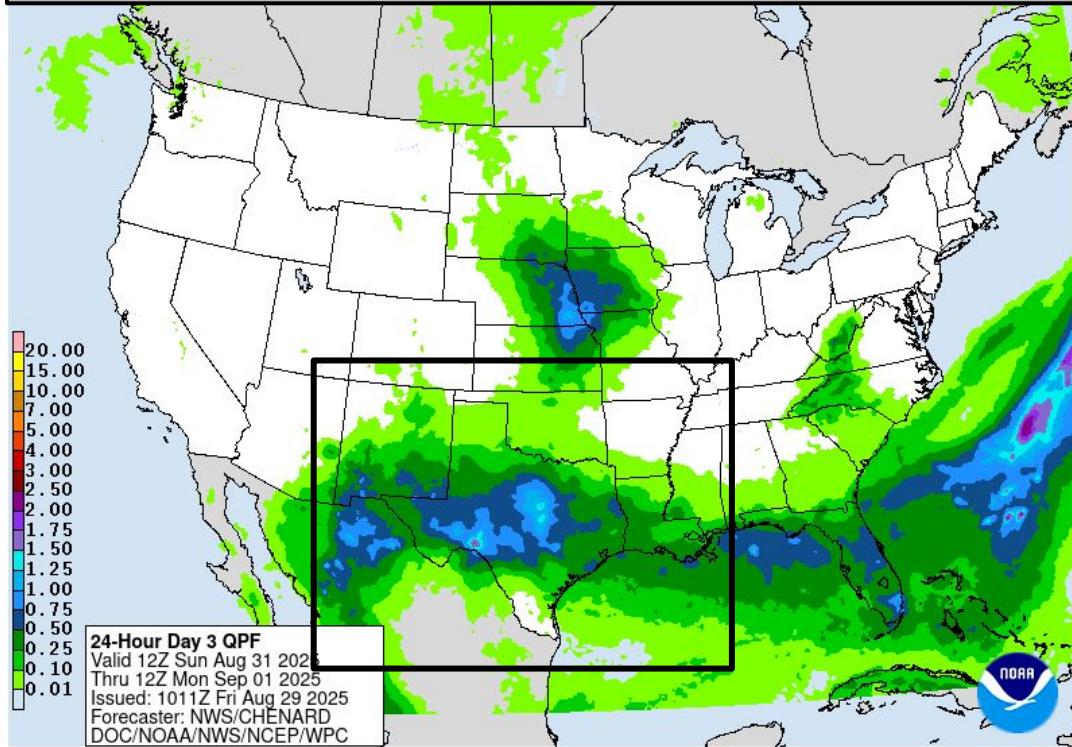

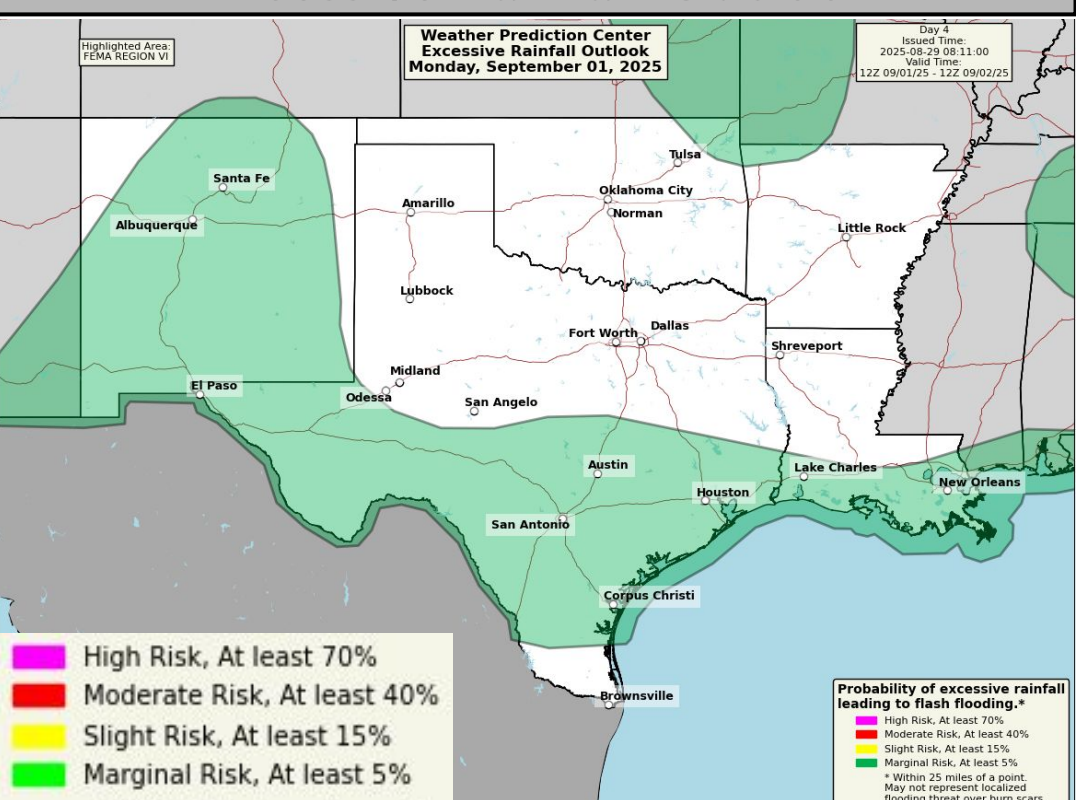

Excessive Rainfall Outlook

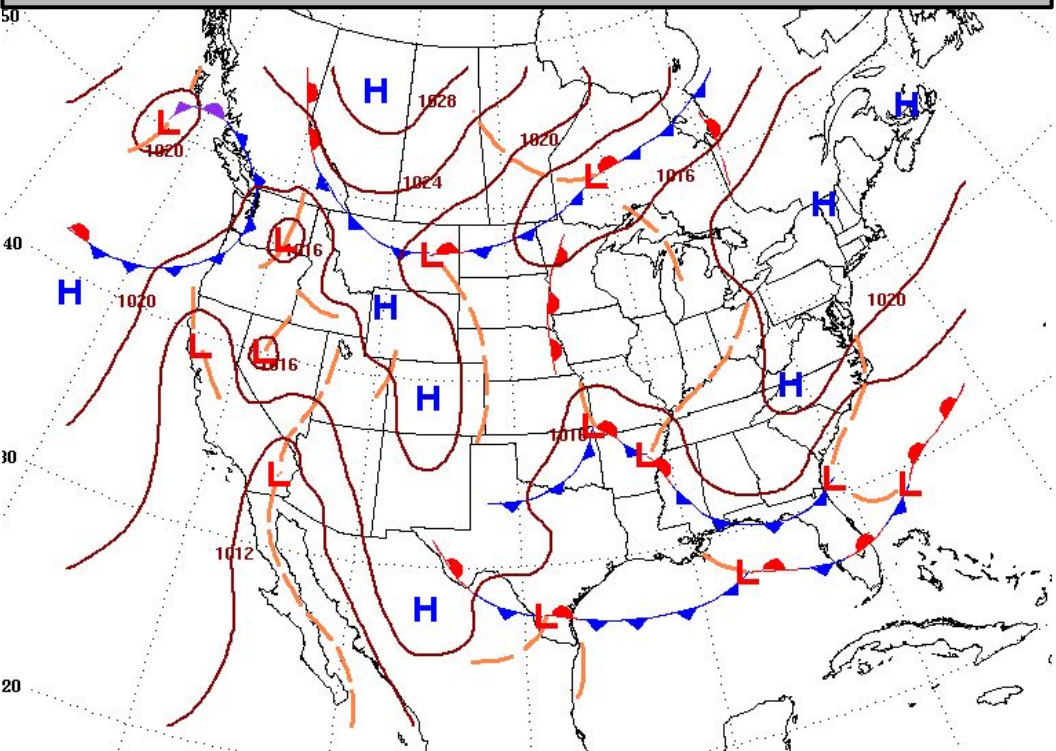

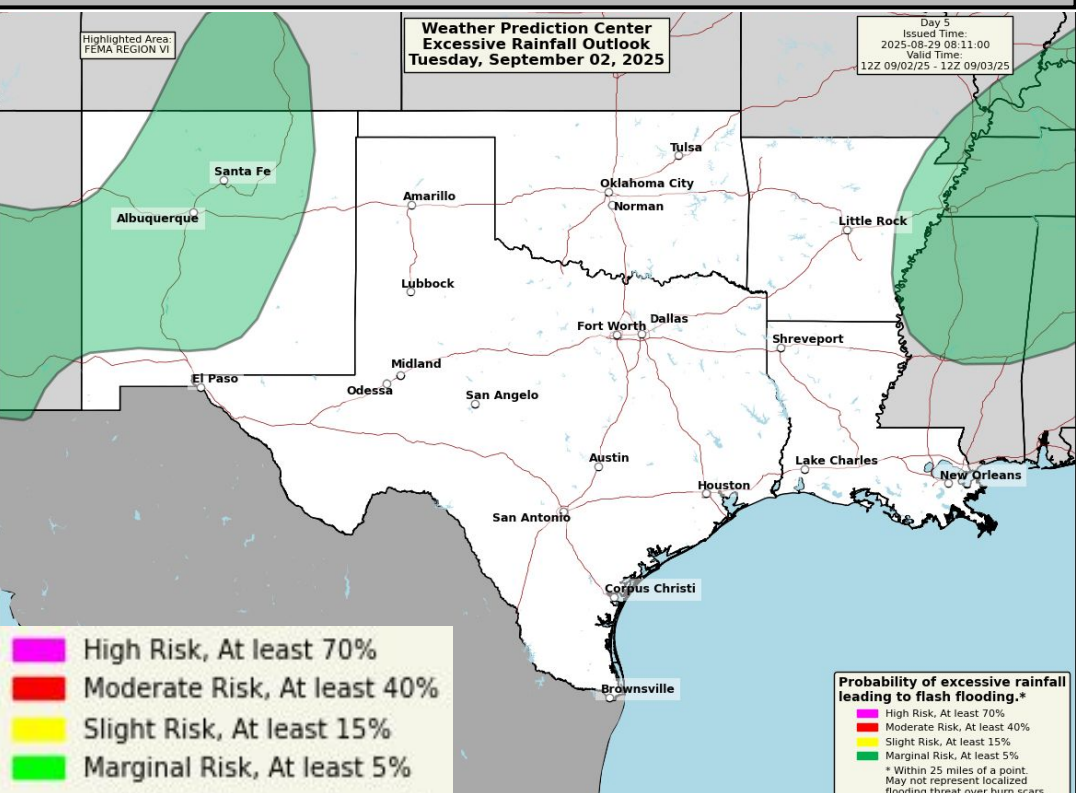


Marginal risk (level 1 of 4) for heavy rainfall in NM, E AR.

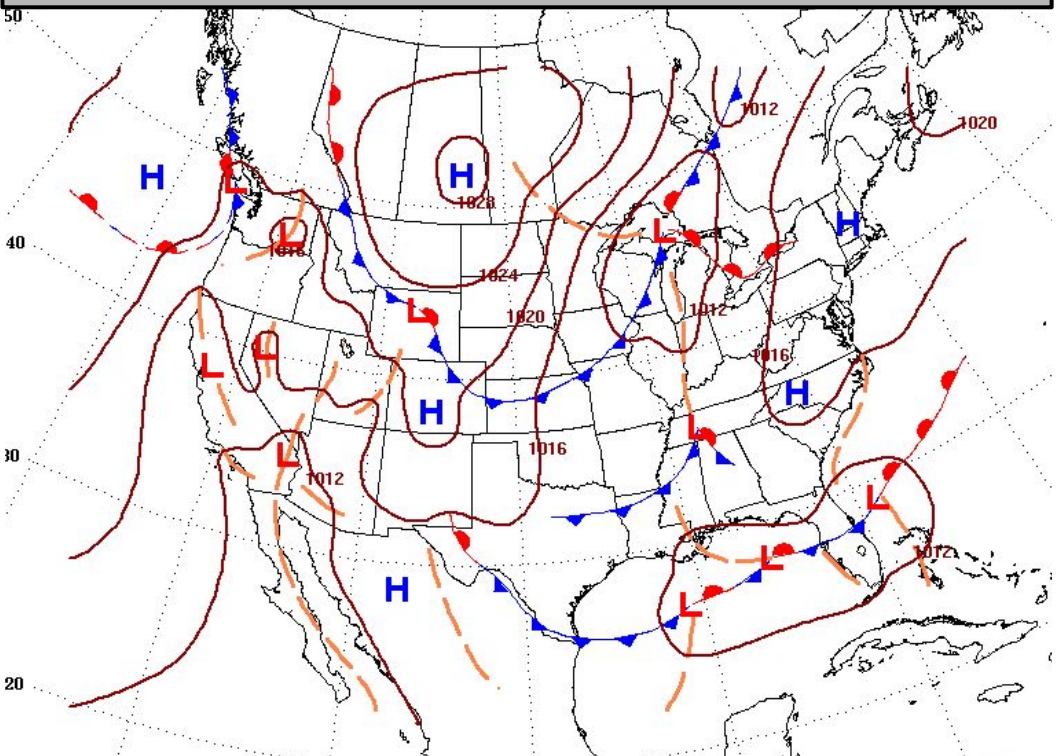
Excessive Rainfall Outlook



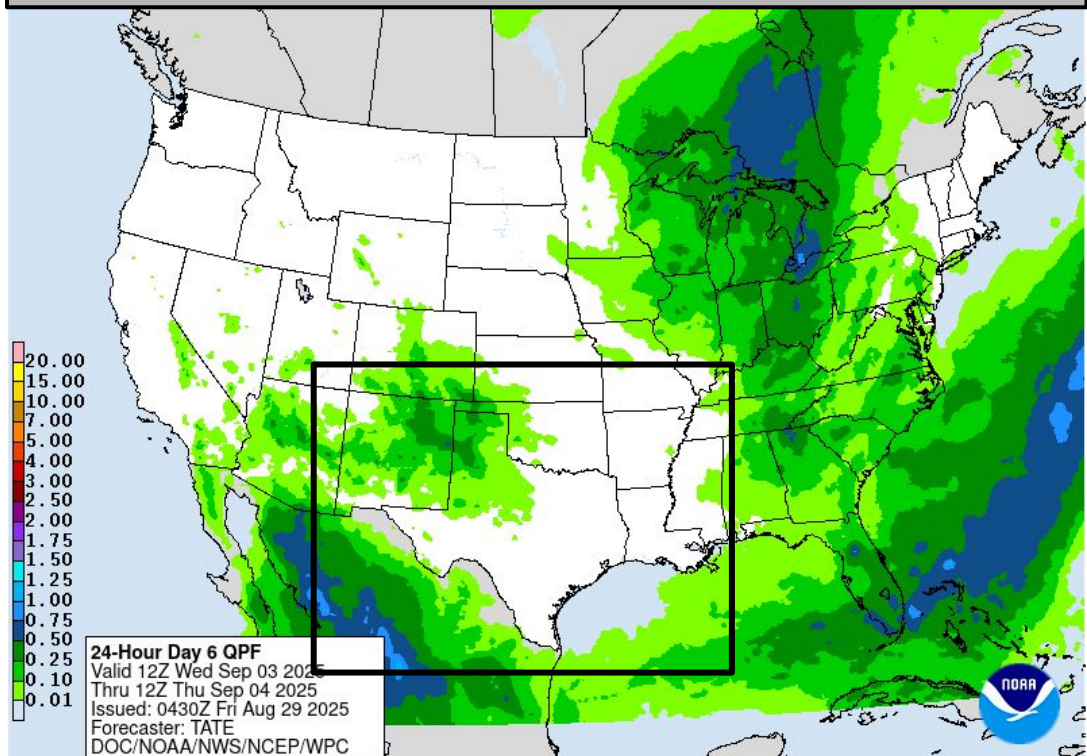

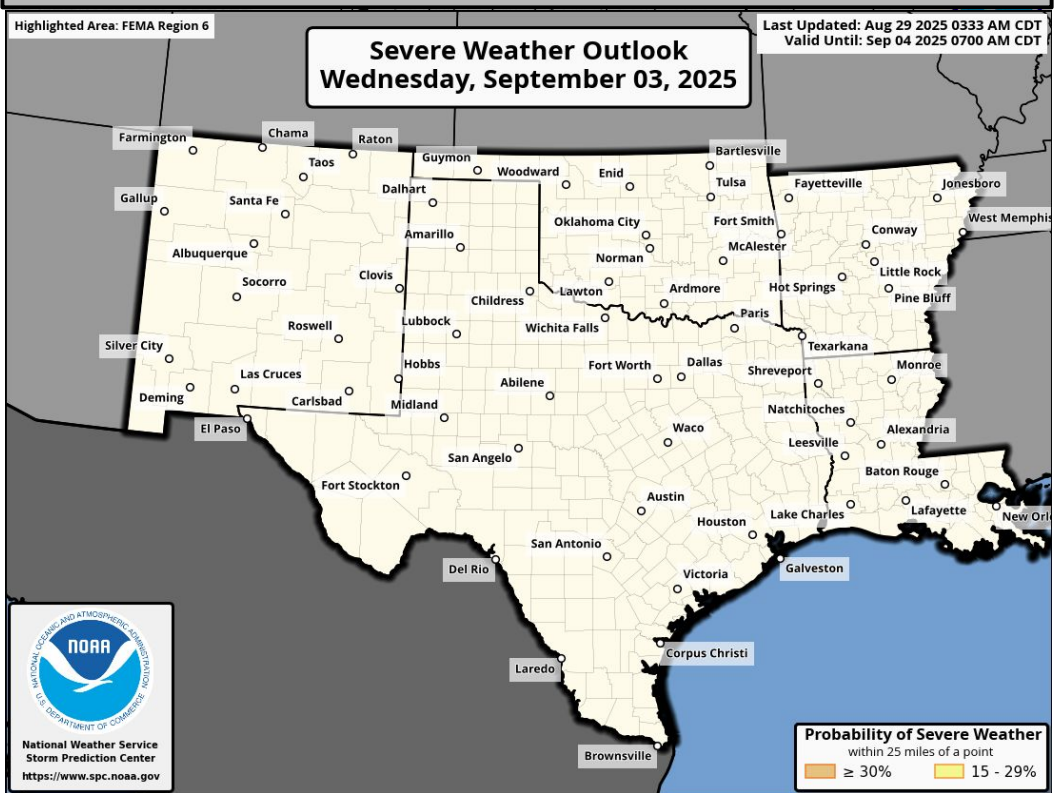


Forecast Rainfall
