# FEMA Region 6 Weather Threat Briefing

Friday, August 29, 2025

#### • Flash Flooding:

- Slight risk (level 2 of 4) for E NM,TX/OK Panhandle, ETX, N LA today. Slight risk continues Saturday over E NM, NW-CTX, SW OK. By Sunday the focus will be S NM, Far W TX.
- NM Burn Scars: Major risk (level 3 of 4) today through Monday.

#### • Severe Storms:

Marginal risk (level I of 5) for isolated damaging hail and wind today for NE NM, NW TX/OK
 Panhandles, SE TX, SW LA.

#### • Tropical:

Eastern Atlantic has a low chance (30%) for development in the next 7 days. No impacts in the next 7 days.





Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall








#### Tomorrow's Tornado & Severe Wind / Hail Probabilities






