# Summary

- **Flash Flooding:**

- **Slight risk (level 2 of 4) over SW NM today-Sun, including Far W TX Sat & Sun.**
- **NM Burn Scars**
  - **S NM - moderate (level 3 of 4) today, high (level 4 of 4) Sat & Sun, moderate (level 3 of 4) Mon**
  - **N NM - minor (level 2 of 4) today, moderate (level 3 of 4) Sat, high (level 4 of 4) Sun, moderate Mon**

- **Severe Weather:**

- **Marginal risk (level 1 of 5) for severe storms today in SW NM due to isolated hail and strong wind gusts.**

- **Tropical Weather:**

- **Hurricane Gabrielle is forecast to move eastward across the Atlantic. No impacts to FEMA 6.**
- **Tropical storm Humberto has formed. This storm is expected to remain out in the Atlantic Ocean and not impact FEMA 6.**
- **High chance (90%) for a wave over the Dominican Republic to develop over the next 7 days. FEMA 6 impacts are not expected over the next week.**

**Isolated minor flooding in NW LA may lead to flooded lowlands through tomorrow.**

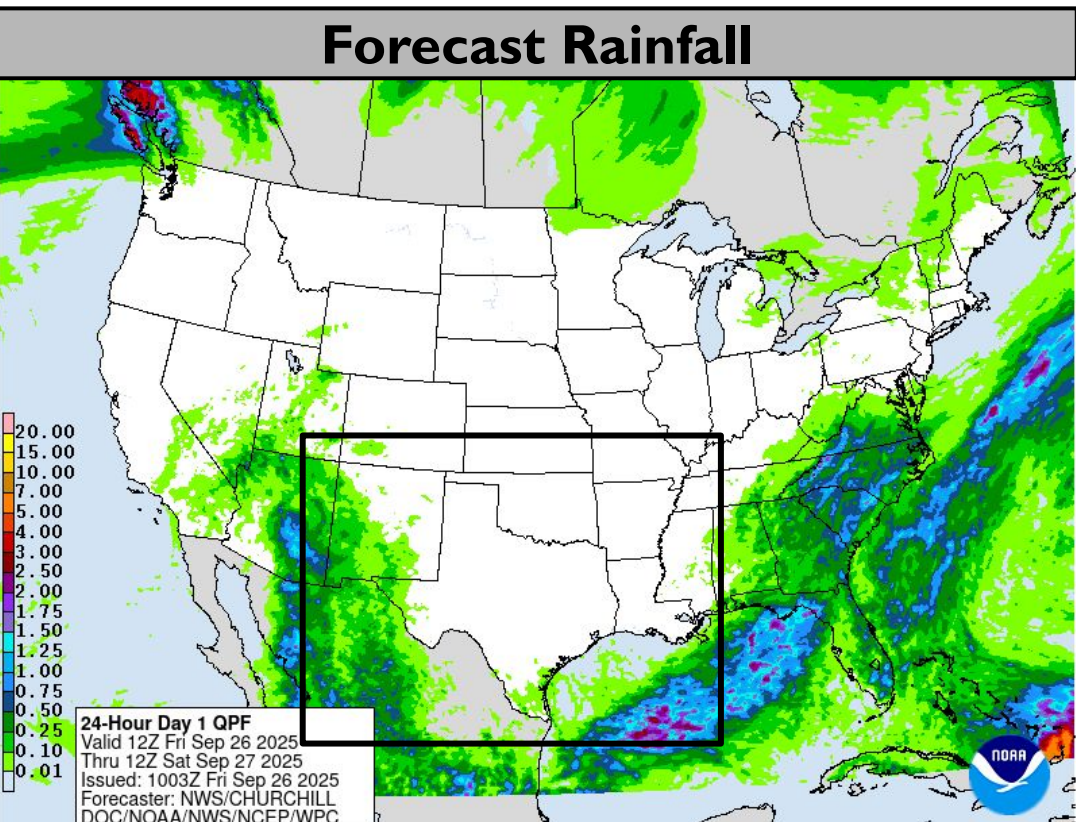
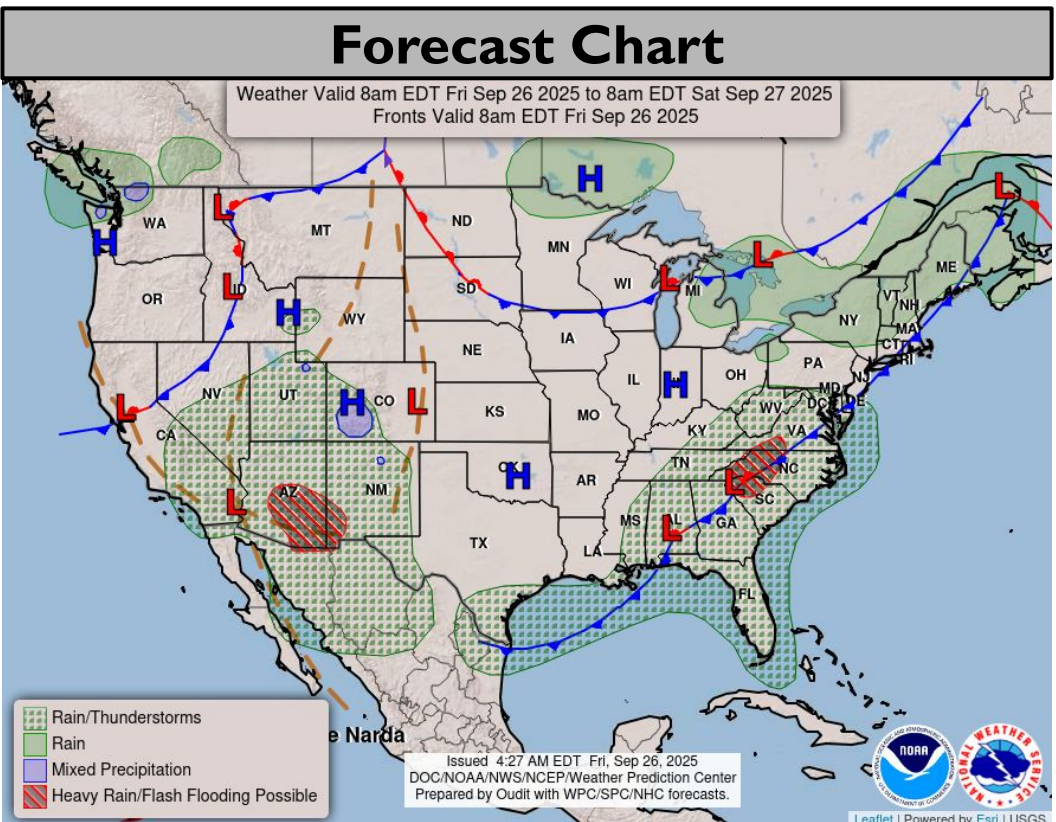

Green	<b>Little to None</b> Safety: Rarely a Direct Threat to Life and Property Impact Potential: Typically Results in Little Inconvenience to Daily Routines	Severe: Marginal Risk from SPC Flooding: Minor flooding expected over localized areas Tropical: None Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active	<ul style="list-style-type: none"> <li>Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees</li> <li>Something that happens almost every day in a particular season such as seabreeze storms in coastal TX</li> </ul>
