**STATEWIDE CURRENT SITUATION:** On September 15, Gov. Greg Abbott announced that the U.S. Small Business Administration (SBA) approved his request for a rural area disaster declaration for the catastrophic flooding that took place in July. The Texas counties included in the rural area disaster declaration are Coke, Concho, Kendall, Mason, and Sutton.

On September 11, Gov. Abbott <u>requested</u> an SBA rural area disaster declaration for the catastrophic flooding that took place over the July 4th weekend across the state. The counties requested in the declaration are Coke, Concho, Kendall, Mason, and Sutton.

On September 5, Gov. Abbott <u>announced</u> that the Texas Workforce Commission (TWC) has received federal approval to extend the deadline for Disaster Unemployment Assistance (DUA) applications relating to severe flooding that occurred over the Fourth of July weekend. Individuals who may be eligible for DUA now have until September 29, 2025, to apply for assistance.

On September 2, Gov. Abbott <u>announced</u> that at his request, the Federal Emergency Management Agency (FEMA) has extended the Individual Assistance registration period for Texans impacted by flooding that occurred over Fourth of July weekend. Individuals who live in <u>qualifying counties</u> now have until September 28th to submit damages and make claims to FEMA.

On August 20, Gov. Abbott <u>announced</u> that the federal government has updated President Trump's Major Disaster Declaration to include Uvalde County in response to a request from Texas following the recent flooding across the state.

On August 20, Gov. Abbott <u>announced</u> the Governor's Small Business Disaster Recovery Fair in Kerrville where he will deliver keynote remarks. As Texas continues to help communities recover and rebuild following the devastating flooding in July, the Governor's Small Business Disaster Recovery Fair will bring together state and federal agency partners and resource providers to share information, resources, and assistance for small businesses impacted by the historic floods.

On August 12, Gov. Abbott <u>directed</u> the Texas Division of Emergency Management (TDEM) to request that Uvalde County be added to President Trump's Major Disaster Declaration following last month's flooding across Texas.

On July 30, Gov. Abbott <u>announced</u> 10 additional Texas counties have been added to President Trump's Major Disaster Declaration following recent flooding across the state. Those counties include Edwards, Guadalupe, Kimble, Lampasas, McCulloch, Menard, Real, Reeves, Schleicher, and Sutton.

#### **OPERATIONAL PRIORITIES:**

- Protect life and property.
- Support rapid & effective response.
- Collect and disseminate accurate incident information to improve decision-making.
- Accurately track incident costs associated with assigned resources for cost recovery.

#### RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS

# **Incident Support Task Force (ISTF):**

Demobilization is ongoing, with members supporting operations in Burnet, Kerr, San Angelo, San Saba, Tom Green, Travis, and Williamson counties.

#### Mass Care:

Long-Term Recovery Groups (LTRGs) are transitioning from VOAD-led response to sustainable, local recovery.

#### Texas A&M AgriLife Extension Service (AgriLife):

AgriLife logged 522 damage reports, 185 requesting aid, with four DAR staff activated.

# Texas A&M Engineering Extension Service Texas Task Force 1 (TEEX/TX-TF1):

TX-TF1 continues debris removal and search/rescue in the Guadalupe River Basin.

#### Texas A&M Forest Service (TAMFS):

One TIFMAS ST consisting of 14 personnel are assisting TX-TF1 in Kerr County.

#### **Department of Information Resources (DIR):**

Texas.gov features recovery resources and a link to the Kerr County Flood Relief Fund.

# Texas Commission on Environmental Quality (TCEQ):

TCEQ has authorized 30 temporary debris management sites.

# **Texas Department of Agriculture (TDA):**

The Agri-Stress Helpline provides 24/7 support at 1-833-897-2474. Hay donors may register online and will be contacted if requests arise.

# **Texas Department of Public Safety (DPS):**

50 DPS personnel are engaged with partners in recovery and providing security.

# **Texas Department of State Health Services (DSHS):**

DSHS has approved the extension of active EMTF assets through October 31.

# **Texas Emergency Medical Task Force (EMTF):**

In Kerr County, ESF-9 and EMS supported operations, with 56,700 patient contacts, 511 treated, and 195 transported.

# **Texas Department of Housing and Community Affairs (TDHCA):**

Three subrecipient agencies are working on long-term recovery in the 21-county area.
