FEMA Region 6 Weather Threat Briefing

Friday, October 10, 2025

Disclaimer: The purpose of this briefing is to provide a <u>Regional</u> weather threat assessment and is meant as a general overview. County/Parish decision makers should consult their local NWS forecast offices for the latest detailed, local weather information.

• Flash Flooding:

- Marginal to Slight risk (levels I-2 of 4) across portions of W NM today through Monday.
- Ruidoso Burn Scar: Minor risk (level 1 of 4) this weekend, likely increasing into next week.
- Burn Scar Note: Burn scar flash flooding is generally a threat from June 15 September 30, aligning with monsoon season. Slides have been extended into mid October for the South Fork Salt McBride(Ruidoso) burn areas due to the presence of moisture from Eastern Pacific tropical systems. Slides will be discontinued once this threat has ended.

• Fire Weather:

- Limited fire danger in E/SETX into LA today and Saturday.
 - Fuels are dry, but RH and winds do not meet critical conditions
- Elevated conditions (level I of 3) in NW TX/OK Saturday and Sunday.

Tropical Weather:

TS Jerry is moving through the central Atlantic. No impacts to FEMA 6.







Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall









Today's Tornado & Severe Wind / Hail Probabilities











Flood Watch over NW NM through Saturday afternoon as repeated rounds of rainfall expected.









Major (level 3 of 4)	Flood Watch Issued OR Debris Flow Probability > 50%
Extreme (level 4 of 4)	Life Threatening Flash Flooding Likely - Historic Type Day

- WPC's Excessive Rainfall Outlook is Not Applicable to burn scars.
- *Note* 2nd year burn scars can be more dangerous than year 1.




Tomorrow's Tornado & Severe Wind / Hail Probabilities






Marginal risk (level 1 of 4) for flash flooding over NM.





"Day 3-7" Hazards Outlook








