





Inland from 12AM tonight through 9 AM Sat

Marine from 8PM tonight through 10AM Sat

 Inland: All counties and parishes along and south of I-10

 Marine: Lakes, bays, and nearshore (0-20 NM) marine zones

 **Visibilities below 1/4 mile.** Areas of patchy fog may quickly transition to dense fog over close proximities.


- Slow down & increase distance


A Dense Fog Advisory is in effect for Matagorda Bay through Saturday morning.





Report of 823 (No Change) fires and 101,399 (No Change) acres have been burned this year. There are 103 (No Change) counties with burn bans. The Keetch–Byram Drought Index list contains 159 (+7) counties with an average over 400.
