FEMA Region 6 Weather Threat Briefing

Tuesday, June 02, 2026

Summary

- **Flash Flooding:**

- Slight risk (level 2 of 4) on today/Wednesday over E NM, TX Panhandle-W TX.
- Marginal risk (level 1 of 4) Thursday over S NM, OK, TX; Friday over SE NM, OK, TX, W AR; Saturday over OK, TX, W AR, W LA.
- Monitoring Sunday over OK, N TX, AR; and Monday over OK, AR.

- **Severe Storms:**

- Marginal risk (level 1 of 5) today over the TX/OK Panhandles, E NM, W OK; and over the TX/OK Panhandles, W TX on Wednesday.

- **Burn Scar Flooding:**

- Today and Wednesday will see a high risk with a moderate risk Thursday and Friday over the Sacramento Complex.

- **Fire Weather:**

- Dry lightning may ignite wildfires over W NM today.
- Elevated (level 1 of 3) in NW NM Saturday.

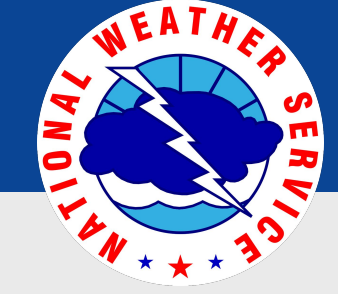
5-Day Precipitation Forecast & River Flood Status

Cache River at patterson in AR will be in Minor flood stage through the weekend. No significant impacts.

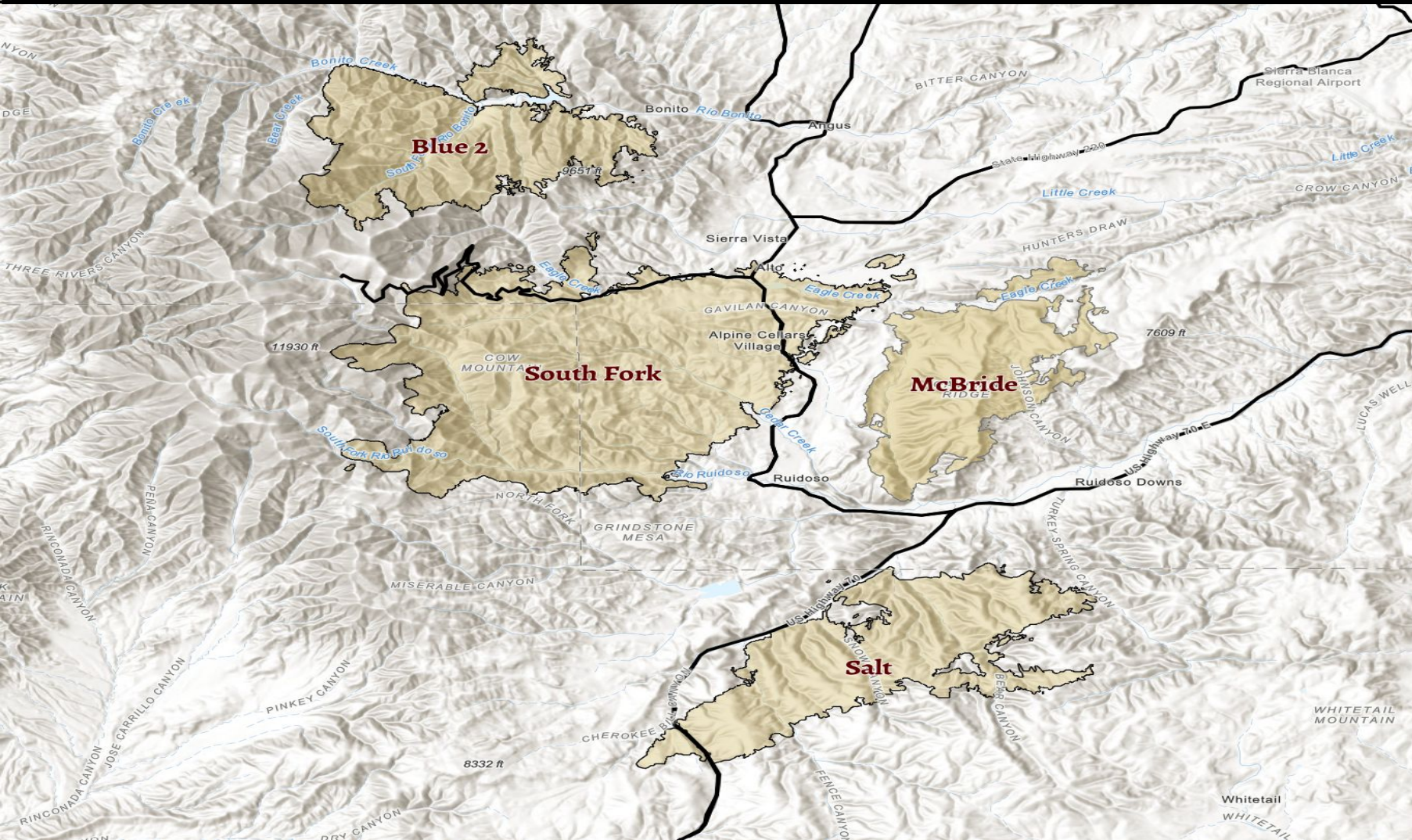

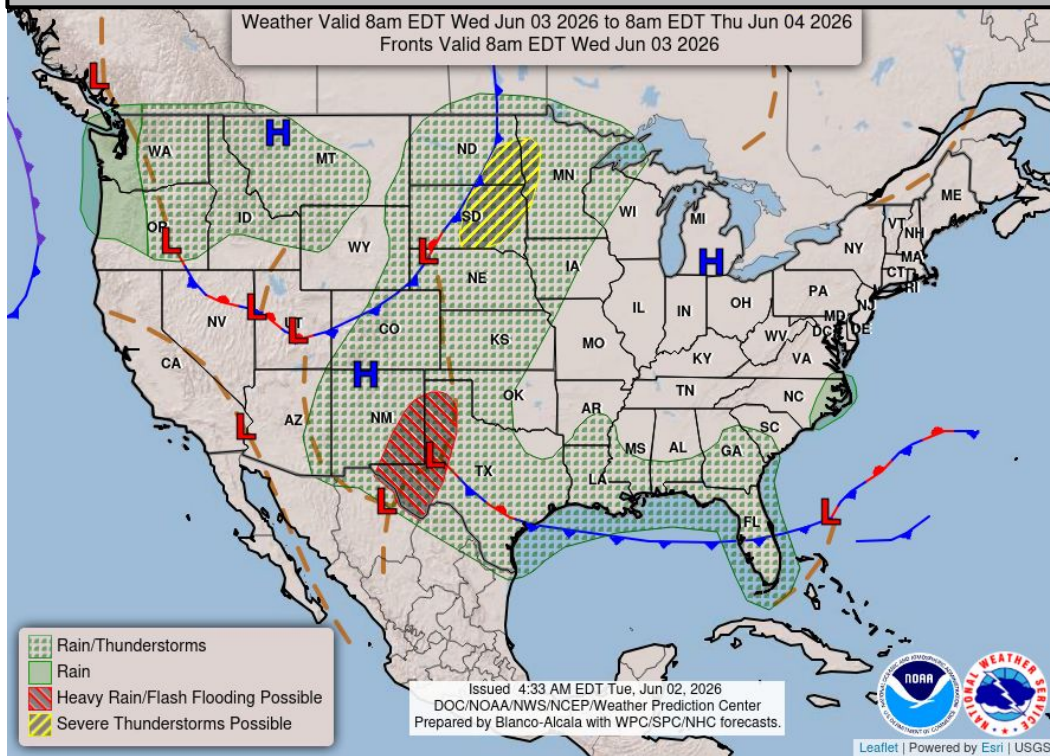
Today's Tornado & Severe Wind / Hail Probabilities



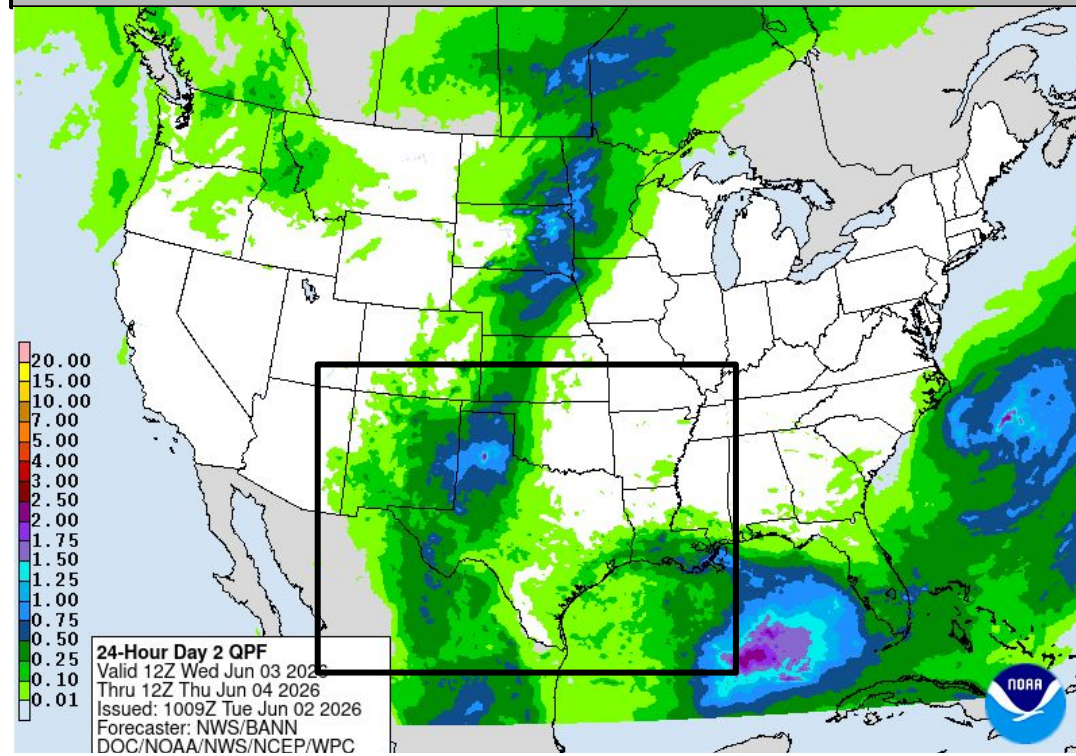

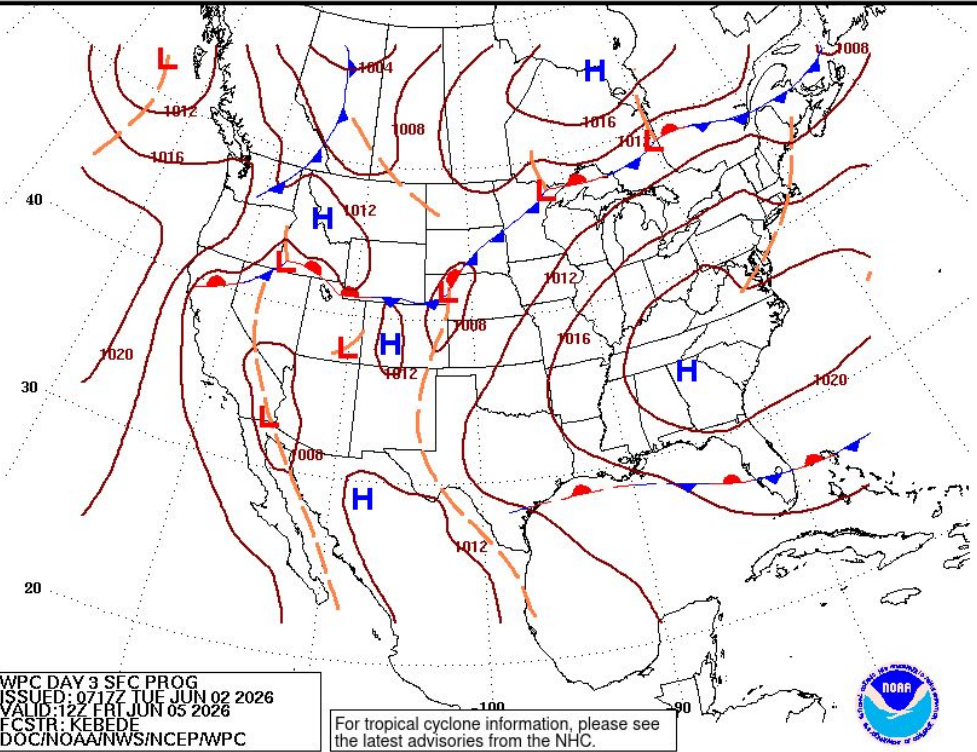
Thursday's Severe Weather Probabilities/CIG Level



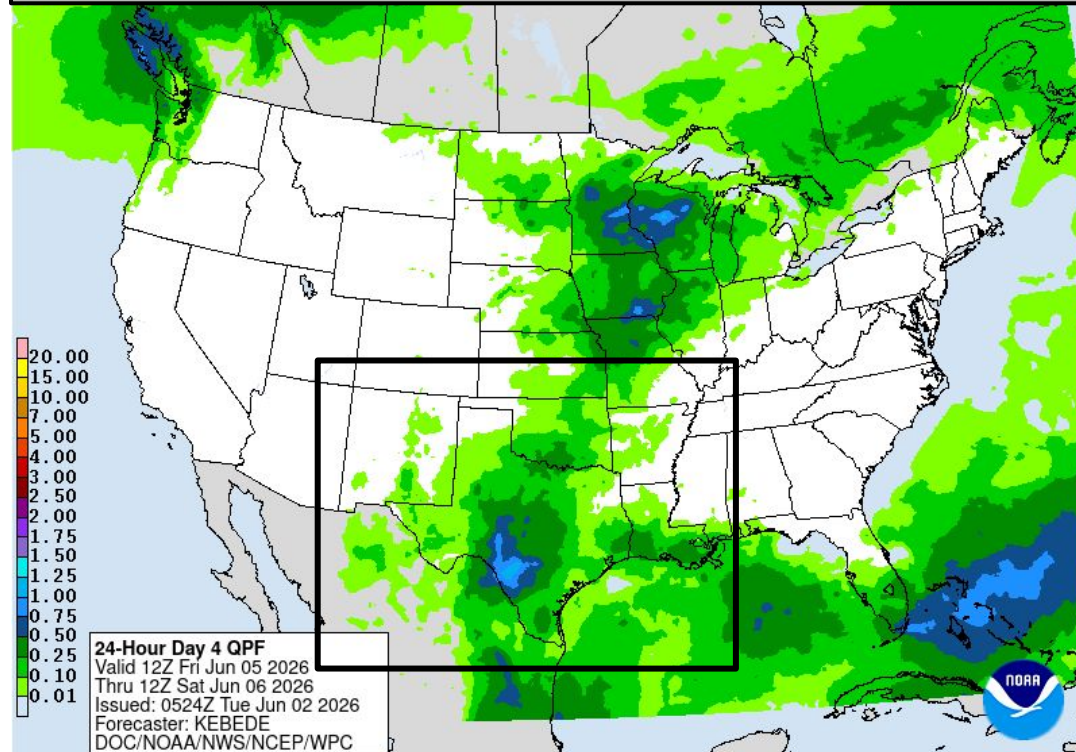

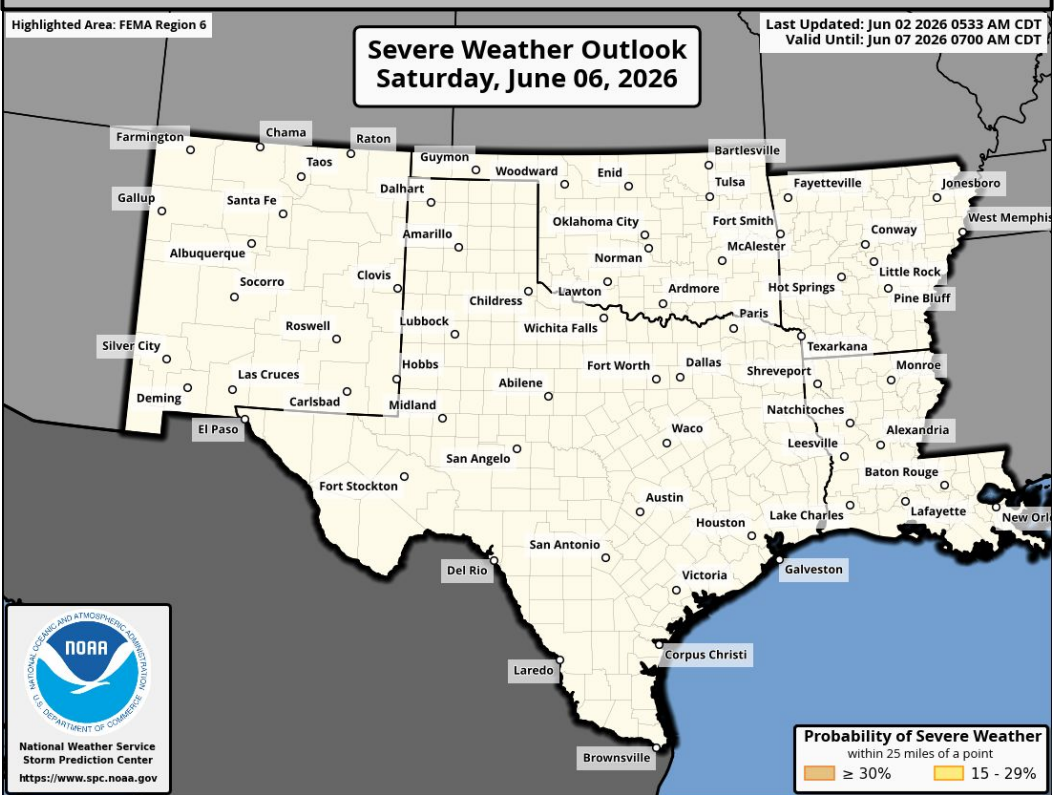
