# Summary

- **Flash Flooding:**

- Slight risk (level 2 of 4) today over S OK, TX; Saturday over OK, W AR, N-NW TX; Sunday over E OK, N/W AR; and Monday over NE AR.

- **Severe Storms:**

- Marginal risk (level 1 of 5) Saturday over S OK, N-SW TX.

- **Burn Scar Flooding:**

- High risk today and a Moderate risk Saturday over the Sacramento Complex.

- **Fire Weather:**

- Elevated (level 1 of 3) in NW NM Saturday through Tuesday.

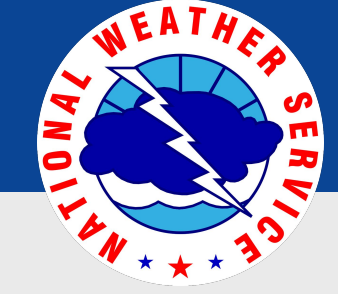
# 5-Day Precipitation Forecast & River Flood Status

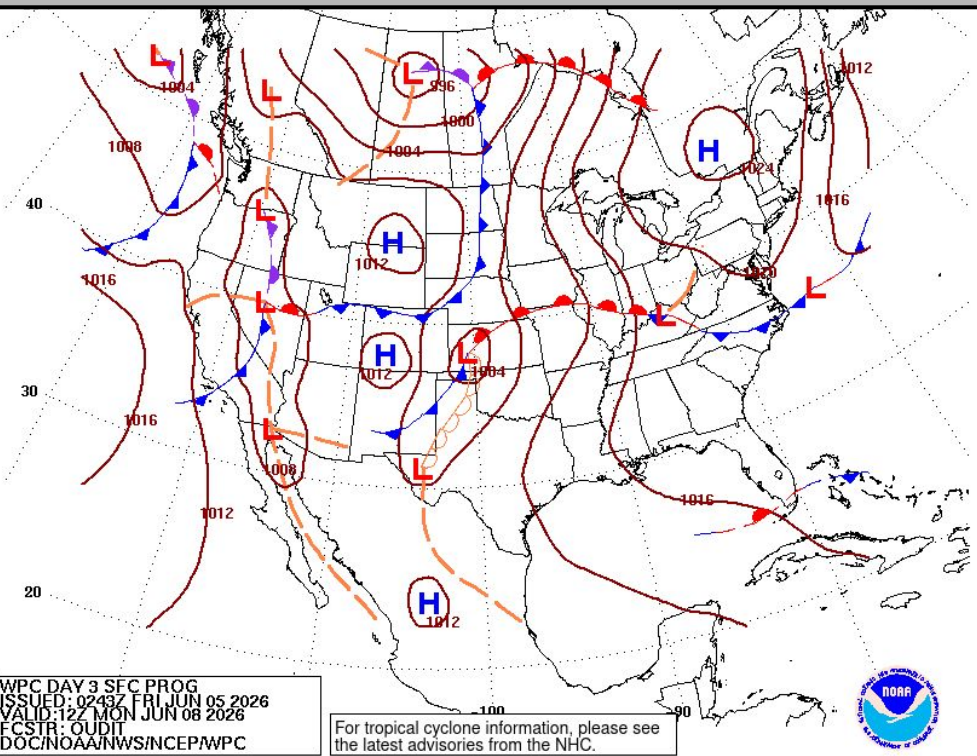
# Sunday's Severe Weather Probabilities/CIIG Level



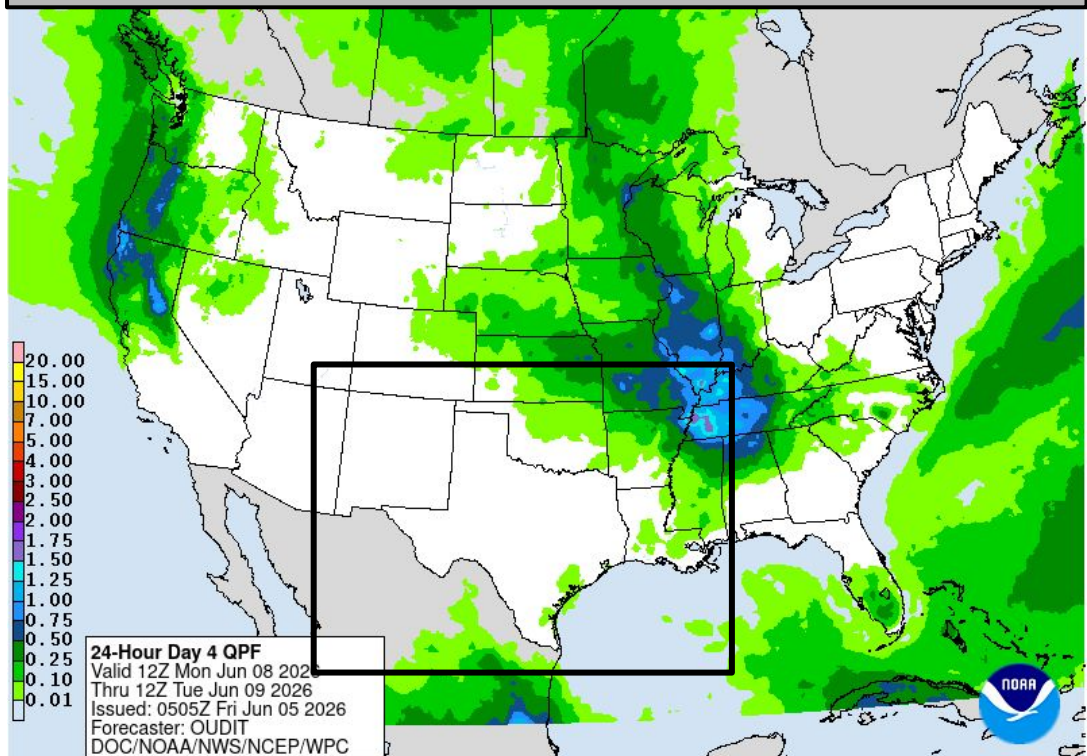
