STATEWIDE CURRENT SITUATION: The Texas Animal Health Commission (TAHC) continues to support New World Screwworm (NWS) response efforts through livestock movement inspections, compliance monitoring, roadside checkpoint operations, and stakeholder outreach to ensure guideline compliance, maintain continuity of business, and support producer awareness.

The Texas Parks and Wildlife Department (TPWD) continues to support NWS response efforts through stakeholder outreach, surveillance, wildlife monitoring, trapping operations, and coordination with response partners to promote early detection and awareness in affected and at-risk areas across Texas.

Texas A&M AgriLife continues to support NWS preparedness through livestock inspection training and statewide outreach efforts, increasing awareness of identification, surveillance, and response procedures among stakeholders in affected and at-risk areas.

Texas Department of State Health Services continues coordinated NWS response efforts through regional outreach, interagency coordination, and ongoing support for case investigation and public health partners. Communication efforts include updates to local officials and widespread distribution of bilingual guidance materials. Training and preparedness activities are also underway to support a consistent response across jurisdictions.

On June 19, Governor Greg Abbott announced the launch of an enhanced website that offers comprehensive information for Texans related to the New World Screwworm (NWS). Located in TDEM's Disaster Portal, Texans can visit screwworm.texas.gov to access a “one-stop shop” of information and resources from state agency partners engaged in NWS response.

State agencies are working closely with local, state, and federal partners in the field and at the State Emergency Operations Center. State partners have contacted thousands of landowners and stakeholders and remain engaged and prepared to support response operations as efforts continue to prevent further spread of NWS.

On June 8, Governor Abbott directed TDEM to activate the Texas State Emergency Operations Center to Level II (Escalated Response) to support the state's New World Screwworm response operations.

Resources from multiple state agency partners and the U.S. Department of Agriculture (USDA) are being leveraged in response to this parasite detection.

On June 5, following confirmation of NWS detection in Texas, Gov. Abbott received a briefing and provided an update to Texans on the state's response at the Texas State Emergency Operations Center. The Governor also issued an updated state disaster declaration to address NWS and prioritize operations in Uvalde and Zavala counties.

On January 26, Gov. Abbott issued a statewide disaster declaration certifying that the spread of NWS threatened Texas's livestock industry and economy and posed an imminent threat of widespread and severe property damage for all Texas counties. The declaration also authorized the use of all available resources of the state government to cope with this disaster and allowed for the allocation of state resources to address the spread of the parasite to the Texas NWS response team.

On June 25, 2025, Gov. Abbott directed the Texas Animal Health Commission and Texas Parks and Wildlife Department to establish a joint Texas New World Screwworm Response Team to lead the state's prevention and response efforts.

For more than 18 months since being informed of a positive case of NWS in Mexico, the USDA has been working to combat the impacts in coordination with state and local partners. Such measures by the USDA include importing and dispersing sterile flies in South Texas, outreach with local producers, and building a facility to assist with sterile

fly operations.

The Texas Emergency Management Council continues to monitor developments.

OPERATIONAL PRIORITIES:

- Protect life and property.
- Support rapid & effective response.
- Collect and disseminate accurate incident information to improve decision-making.
- Accurately track incident costs associated with assigned resources for cost recovery.

Region 6 (Includes DDs 17, 18, and 24)

Region 6 has contacted every County Judge in the region regarding the outbreak, status, and anticipated future briefings.

Region 6 is coordinating and communicating with local officials and state and federal partners. Currently, personnel are assisting with the needs of the unified command post located in Eagle Pass.

DD 18 – New Braunfels (Includes Atascosa, Bandera, Bexar, Comal, Frio, Gillespie, Guadalupe, Karnes, Kendall, Kerr, McMullen, Medina, and Wilson Counties): Disaster District Emergency Operations Center (DDEOC) 18 is activated to Level III (Increased Readiness Conditions).

DD 24 – Del Rio (Includes Dimmit, Edwards, La Salle, Kinney, Maverick, Real, Uvalde, Val Verde, and Zavala Counties): DDEOC 24 is activated to Level III (Increased Readiness Conditions).

RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS

Texas Division of Emergency Management (TDEM):

On June 8, the State Operations Center (SOC) activated to Level II (Escalated Response) in support of the New World Screwworm incident. The SOC continues

directing interagency coordination to maintain unified communication, deploy necessary resources, and support response operations in affected regions across Texas.

Mission Information and Details

June 24

- To date, TAHC has inspected 8,022 animals in the infested zones, and 154 certificates have been issued for movement out of the infested zones.
- Five (5) groups of TAHC inspectors have been mobilized to conduct animal inspection/movement/outreach within the identified infested and adjacent zones. These groups will support movement inspections and issue movement certificates as quickly as possible for continuity of business, as they are requested and scheduled by the ICP.
 - On June 23, a total of 13 inspections were completed for movement out of the infested zones.
- Nine (9) compliance and checkpoint strike teams are operating roadside checkpoints. Roadside checkpoints have been established within the infested and adjacent zones to ensure NWS guideline compliance.
 - On June 23, a total of 47 stops were completed; 23 stops provided for education/outreach, and 24 verified NWS guideline compliance.
- TAHC Regional Staff are working with local producers in the region to answer questions and assist with the coordination of local jurisdictions and assets.
- NWS Identification Specialists, located at the NVSL Mobile Lab and USDA Agricultural Research Service (ARS) Lab, are screening suspect larval and fly submissions from the infested and adjacent zones for rapid identification. One (1) TAHC entomologist has been assigned to the mobile laboratory to assist.
- Providing information, outreach, and education to industry, animal owners, stakeholders, and the public about NWS to encourage surveillance and proper reporting.
- The TAHC New World screwworms webpage is updated regularly to provide information and resources, as it becomes available.

The situation is evolving, and new information will be provided as investigations continue.

Executive Director Orders identifying Infested Zones remain in effect, pursuant to Texas Agriculture Code, Chapters 161 – 168, and applicable regulations found in Title 4 of the Texas Administrative Code, Part 2, Chapters 31-60. This order remains in effect until the quarantine is released by the Commission.

Texas Parks and Wildlife Department (TPWD):

To protect the State's natural resources, including fish and wildlife, through land-based and marine patrol, TPWD will serve as a force multiplier responding to requests for

support from our federal, state, and local partners to prevent, detect, control, or eradicate parasitic disease outbreaks. TPWD will deploy coordinated resources to prevent, detect, control, and eradicate parasitic disease within the Texas-Mexico Border region.

TPWD staff will continue to coordinate native wildlife surveillance efforts, which will include:

- Working with landowners to organize active wildlife surveillance on their properties
- Inspection of hunter-harvested carcasses when necessary, including animals harvested in State Parks and Wildlife Management Areas.
- Inspection of recently road-killed wildlife.
- Inspection of animals is handled as part of routine wildlife handling, whether that is by agencies, researchers, or other entities that encounter wildlife on a regular basis.
- Reporting from wildlife rehabbers, private practice vets, law enforcement, taxidermists, game processors, and the public.

June 24

- TPWD Staff have contacted 4,983 TPWD cooperators and permit holders by phone to notify them of the NWS infestations and promote surveillance.
- In addition to cooperators located in a zone, TPWD staff are also contacting all available TPWD cooperators that are currently not in a zone in South Texas and the Edwards Plateau by phone to notify them of the NWS situation and promote surveillance. As of this report, 3,150 TPWD cooperators on that list have been contacted.
- TPWD staff continue contacting the remaining cooperators in the newly established Crockett 01 and Terrell 01 infested and surveillance zones today. There were no Deer Breeders or Wildlife Rehabilitators identified within the new zones. Crockett 01 covers portions of Crockett, Schleicher, Sutton, and Val Verde counties.
- Staff will begin contacting TPWD cooperators that are currently not in a zone for Region 1 in Terrell, Pecos, and Brewster Counties after primary Infestation Zone and Surveillance Zone contacts have been made.
- TPWD staff have secured an additional 7 NWS trap locations at the request of TAHC and USDA, with an accumulated total of 73 NWS traps and 22 GRC secured by TPWD staff.
- TPWD staff have investigated 2,414 animals statewide and investigated 34 suspect cases.

- TPWD staff are monitoring 327 game cameras in 31 Wildlife Management Areas. TPWD's Kerr Wildlife Management Area is located within the Gillespie County Surveillance Zone and is monitoring 9 game cameras, and the Chaparral Wildlife Management Area is monitoring 7 game cameras for signs of NWS infestations on the property.
- Since NWS was detected in Texas, TPWD staff have presented on NWS at 12 workshops, totaling approximately 2,015 attendees.

As of June 23

- Staff will begin contacting cooperating landowners within the newly established Terrell 01 zone today. There are 15 cooperators in the infested zone and 42 in the surveillance zone. There were no Deer Breeders or Wildlife Rehabilitators identified within the new zone.

As of June 22

- TPWD staff are monitoring 51 game cameras in 4 state parks. San Angelo State Park is monitoring 5 game cameras, and an additional 46 cameras at Hueco Tanks, Kickapoo, and Franklin Mountains.

As of June 19

- TPWD staff have actively secured 61 NWS traps and 22 Ground Release Chambers locations by contacting TPWD, cooperating with landowners at the request of TAHC and USDA.
- TPWD Wildlife veterinarians and Wildlife Health Specialists have provided NWS presentations, refresher courses, sample collection training, and SOP overview to 351 TPWD Wildlife staff, 386 TPWD LE, and 76 State Park attendees.

Texas A&M AgriLife Extension Service (AgriLife):

Currently, the AgriLife Extension SOC liaison, Public Information Officer (PIO), Disaster Assessment and Recovery (DAR) Team Members, DAR Administration, Extension Administration, and County Extension Agents are monitoring NWS movement and conditions, SOC response activity, and participating in weekly communication calls with Extension Administration, Entomologists, and Livestock Specialists. Disaster Assessment and Recovery Specialists are on standby to support County Extension Agents and ESF-11 partners with public education, animal response, and recovery efforts as requested. PIO continues to develop educational and outreach materials for publication and continues to participate in daily Joint Information Center activities.

Since June 2025, leading up to the first confirmed NWS case in Texas, AgriLife has:

- Conducted educational programs on NWS reaching over 21,200 participants.

- Established an 18-member working group of Extension Specialists across livestock, wildlife, and human disciplines focused on the development of educational information, outreach techniques, and resources for use by County Extension Agents and other appropriate Extension personnel across Texas.
- Two internal staff NWS webinar trainings completed by 500 AgriLife Extension and AgriLife Research personnel, were conducted with training support from the TAHC and TPWD.
- Hosted a hands-on professional development NWS workshop hosted at the San Antonio Livestock Show Ground for 126 AgriLife Extension and AgriLife Research personnel. In addition to others in attendance at this workshop, County Extension Agents (CEAs) from 48 of the southern and western Texas Counties were in attendance.
- Developed a County Extension NWS Educational Tool kit, complete with videos and PowerPoint Slide Decks for use in local producer and community educational outreach efforts.
- Through a grant from USDA-APHIS, Texas A&M AgriLife Extension has distributed 1,000 NWS larva collection kits among the Southern and Western County Extension offices for use in NWS detection and identification.
- AgriLife Extension is wrapping up the development of a course that will train people on what to do and expect related to the occurrence of NWS. AgriLife Extension will provide maintenance and management of this course.
- Provided expertise with local and state government representatives to better inform their preparation should an incident occur.
- Texas A&M AgriLife Extension livestock entomology specialist conducted an NWS awareness training during the monthly meeting of the Extension Disaster Education Network (EDEN) Agricultural Committee, as well as more in-depth training during the May 2026 EDEN webinar hosted by the EDEN professional development committee.

June 24

- The NWS Preparedness and Response Education Course for Livestock Inspection is available on the AgriLife Learn educational platform. As of 8 AM today, 3,476 individuals are enrolled in the course, with 1,183 having completed the modules and earning completion certificates.
- AgriLife Extension personnel continued New World Screwworm outreach efforts through county meetings, informational events, and multi-county trainings across Medina, Stephens, Comanche, Runnels, Brown, Coleman, Callahan, and Shackelford Counties. These efforts continue to increase awareness of New World Screwworm identification, monitoring, and response procedures.

As of June 23

- SOC Liaison coordinated with AgriLife Extension, TDA, and TDCJ representatives to determine staffing support to conduct livestock inspections for extended NWS response efforts.
- AgriLife has a DAR PIO serving at the Joint Information Center at the SOC.

As of June 19

- The USDA announced the outcome of the NWS Grand Challenge program, where the focus is on developing new tools to aggressively detect, treat, or mitigate the impacts of NWS. Several AgriLife Research scientists were recognized for this challenge.
- 708 new NWS sample kits have been made for distribution.
- AgriLife Leadership testified to the State House Agriculture Committee on efforts associated with AgriLife towards supporting the NWS response, including progress on the inclusion of medicated feed for deer.

Texas A&M Veterinary Medical Diagnostic Laboratory (TVMDL):

The Texas A&M Veterinary Medical Diagnostic Laboratory (TVMDL) has deployed one laboratory professional to the Texas Animal Health Commission's (TAHC) Pleasanton office to join the United States Department of Agriculture mobile detection unit deployed from USDA's National Veterinary Services Laboratory (NVSL). The lab is now operational and accepting samples for identification. A second professional remains stationed in the State Operations Center (SOC) in Austin.

TVMDL is educating clients to contact TAHC for triage of a suspected fly or larvae instead of direct submission to TVMDL. However, TVMDL Client Services staff review every daily submission and flag any cases submitted for fly/larvae ID. Laboratorians who have passed the USDA proficiency test for NWS identification stand ready to review submissions and will immediately contact TAHC and USDA should a suspect case be identified. Suspect samples will be routed as directed by TAHC and USDA.

Staff participate in the TAHC Virtual Joint Information Center daily calls.

Laboratory personnel at all four agency locations are on standby to support ESF-11 partners as needed.

TVMDL veterinarians are assisting the Texas A&M AgriLife Extension Service in producing screwworm collection kits. Talks are ongoing today to secure supplies for more kits.

TVMDL is working to validate high-throughput testing, should the need arise.

June 24

- With support from TVMDL, the NVSL mobile lab reviewed 5 cases on June 23, 2026; TVMDL did not receive any new cases at any lab location on June 23, 2026.

As of June 23

- With support from TVMDL, the NVSL mobile lab reviewed 1 case on June 22, 2026; TVMDL received and reviewed 2 new cases at the College Station location on June 22, 2026.

As of June 20

- TVMDL communications personnel documented multimedia content of TVMDL staff training efforts at the NVSL Mobile Animal Disease Laboratory (MADL).

Texas Department of State Health Services (DSHS):

DSHS State Medical Operations Center (SMOC) is at Increased Readiness in support of this incident. DSHS continues working with state partners and lead agencies to ensure ESF-8's ongoing support.

There are currently no confirmed human cases of NWS in Texas. DSHS is prepared to support, as needed, to assist in protecting the Texas livestock industry and wildlife. DSHS is ready to respond to human cases, should that occur.

June 24

Ongoing Coordination

- DSHS Public Health Region-9/10 (Odessa and El Paso area)
 - NWS was confirmed in 3 additional cattle in Terrell County. Zoonosis Control is working on reaching out to stakeholders in the area.
 - Zoonosis Control provided information via virtual presentation to Local Health Department Lead Epidemiologists on NWS current situation and response as well as sample submission and case investigation guidelines.
- DSHS Public Health Region-8 (San Antonio and Uvalde area)
 - Region will be attending two Commissioner's courts in Calhoun and Dimmitt counties to provide NWS updates and answer questions.
 - Region will also attend NWS briefing with Comal and Guadalupe counties, along with other state agencies to give an update on NWS.

Public Messaging

- DSHS shared New World screwworm flyers, fact sheets, and reporting aids with all Texas regional and local public health entity leaders and local health authorities. These resources are available in both English and Spanish.
- DSHS has uploaded factsheets, flyers, reporting aids, and guidance documents to the agency NWS Websites at www.dshs.texas.gov/newworldscrewworm. Spanish version www.dshs.texas.gov/es/gusano-barrenador.
- DSHS Zoonosis Control Branch will be hosting a webinar, “Operational Response to New World Screwworm” on Thursday, June 25 from 12 pm to 1:30 pm. The webinar will provide a clinical overview and focus on NWS case management in the community, including epidemiological and public health follow-up protocols. The intended audience is local health departments and public health partners. Invitations have been sent to Local Health Departments.

As of June 23

Ongoing Coordination

- DSHS Public Health Region-9/10 (Odessa and El Paso area)
 - Following confirmation of new cases, Region 9/10 Zoonosis Control is working on reaching out to stakeholders in affected areas.
 - Personnel continue to engage with local officials and have conducted multiple webinars for clinicians.

DSHS staff across regional offices continue reaching out to partners to ensure animal control officers, veterinarians, local health departments, county judges, tribal nations, and other regional partners have the latest guidance and resources for identification, sampling, and reporting New World screwworm.

Texas Department of Agriculture (TDA):

The Texas Department of Agriculture continues to conduct surveillance, gather intelligence, collect evidence, and monitor any signs of the New World Screwworm fly in relevant portions of the state. Traps specific for the New World Screwworm have been deployed and are continually monitored, with all suspect samples sent to our state and federal partners for identification of suspect fly species.

Texas Commission on Environmental Quality (TCEQ):

TCEQ continues to closely monitor the New World Screwworm response and will coordinate with state and federal partners to provide technical assistance and guidance on carcass disposal.

Texas Department of Transportation (TxDOT):

TxDOT Emergency Management personnel continue to monitor the situation and support lead state agency partners. TxDOT continues to coordinate with TAHC regarding the increase and extended specialized fly trap locations along state-maintained Right-of-Ways (ROW) in impacted areas. TxDOT continues to coordinate with TAHC regarding compliance checkpoint locations along state-maintained roadways.

Texas Military Department (TMD):

The Texas Military Department (TMD) is supporting state agency partners in response with a SOC support team.

Texas Cyber Command (TXCC):

TXCC is monitoring the situation and stands ready to support the state's response efforts. TXCC is monitoring the situation using cybersecurity tooling and threat intelligence feeds. No cyber threats related to this event have been identified.

Texas Department of Public Safety (DPS):

Texas Department of Public Safety personnel continue to assist the Texas Animal Health Commission by providing a Texas Highway Patrol Trooper to serve as a liaison at the Incident Command Post. Personnel will serve as the region liaison to facilitate coordination efforts. Additionally, area Troopers are conducting patrol operations in and around the affected areas of Zavala, La Salle, Edwards, and Gillespie Counties and remain available to respond to requests for assistance if needed at designated TAHC checkpoints. DPS has assisted TAHC with the transportation of test samples as needed.

Texas A&M Veterinary Emergency Team (VET):

VET has returned from an assigned status in the field to an available status from home stations and remains available on an as-needed basis.

VET's operational area focused on the following counties: Gillespie, Mason, Kimble, Sutton counties, with options for Edwards or Uvalde counties.
